PAKISTANI BRUTALITIES IN 1960S CHT Chakma victims want Indian citizenship

PALLAB BHATTACHARYA, New Delhi A delegation of All India Chakma Social Forum met a key federal Indian minister in New Delhi and sought his intervention for grant of Indian citizenship to Chakma migrants who had escaped from Pakistani brutalities in Chittagong Hill Tracts in 1960s. The delegation met Minister of State (Independent Charge) for Development of North Eastern Region (DoNER) Jitendra Singh, and submitted a memorandum stating that during 1964-68 around 15,000 Chakmas had fled from the Chittagong Hill Tracts of the then East Pakistan. These Chakmas settled in the then Northeastern Front Agency (NEFA), currently Arunachal Pradesh. The delegation members complained that not a single Chakma migrant in Arunachal Pradesh has been granted citizenship rights till date despite specific directions of the Supreme Court of India issued on January 9 in the case of National Human Rights Commission (NHRC) vs State of Arunachal Pradesh and others, an official statement said. Following another writ petition, the Indian Supreme Court in its judgment dated September 17 directed the Indian government and the State of Arunachal Pradesh to process the citizenship applications. The memorandum also alleged that not a single application of any Chakma migrant had been recommended for grant of citizenship in spite of fulfilling the criteria for the citizenship. As a result, according to them, the Chakmas cannot move out of their villages because of lack of identity proof which is necessary and is indispensable in the context of current security scenario. The signatories to the memorandum sought that two special officers be designated in the federal Home Ministry to address the issues raised by them and ensure early redressal. Singh said he would forward their case to the MHA.

CONNECTIVITY, WATER, FOOD, AND ENERGY SECURITY Dhaka's proposal endorsed at Bangkok summit

UNB, Dhaka He called for not only physical connectivity but also connectivity of peoples, cultures and ideas, connectivity of trade, investment, technology, enterprises and labour forces to secure an inclusive growth and sustainable development in Asia, according to a message received yesterday. Bangladesh also offered to host the first ACD Working Group Meeting on Connectivity in Dhaka. Further, in line with the government's focus on a digital Bangladesh, he expressed strong support for the "science, technology and innovation pillar" of the ACD Vision and informed that the country would remain engaged to host Working Group meetings in future. The ACD was attended by heads of states, government and foreign ministers of 34 ACD member countries. Earlier, the state minister held bilateral meetings with his counterparts from Russia and Japan. During their meetings, Deputy Minister of Foreign Affairs of Russia Ig Murglov assured Shahriar that in reaffirmation of the historic friendship between the Russian Federation and Bangladesh since 1971, Russia looks forward to long-lasting cooperation with Bangladesh, particularly on the Ruppur nuclear power plant. The plant is Russia's largest energy project in South Asia. They also discussed a return visit by President Vladimir Putin in Dhaka, meeting between the two prime ministers during the upcoming BIMSTEC-BRICS Summit in India, and strategic as well as security cooperation between the two countries.

They killed the victim after being hurt by his write-ups on Islam, said Mirza Abdullah Hel Baqui, special superintendent of CID. Ananta Bijoy Das was hacked to death at Subidbazar in Sylhet city on May 12, 2015 on the way to his office. Later, banned militant outfit Ansarulaha Bangla Team claimed responsibility of the murder through online post. Ananta's brother Ratneswar Das filed a murder case accusing some unnamed persons with Sylhet Airport Police Station the next day. Later the case was transferred to CID.

Shah Nawaj told journalists that the factory had been closed for a long time and just two months ago he rented it out to one Jakir Hossain. According to Rab they raided Dhaka Mitford Hospital two months ago where they found many fake medicines and during investigation they learned that those medicines were bought from Khulna. Rab filed a case against some 13 persons including Shah Nawaj, Jakir, and the employee, Sharif.

FROM PAGE 3 hearing-impaired woman. "After the elections, Firingi went back to Bogra and later I heard from the hotel owner that she was driven out as she became pregnant," said Shafiqul. Contacted, the hotel-owner Shahidul Islam said over cell phone that Firingi did not work at the hotel, but Sona Mia did. "Firingi lived at Mohasthanagar of Bogra. She often visited Sona Mia's house and stayed over as she was a friend of his wife (her name could not be known). When she became pregnant, Sona Mia objected her staying and told her to go elsewhere," he claimed. Meanwhile, Firingi gave birth to Swapno at an abandoned waiting room of Rajshahi University Railway Station on Sunday and was rescued by three RU students and locals.
