Belgium drama over, EU and Canada to sign trade deal

EU nations approved a landmark free-trade deal with Canada late said. Friday, clearing the way for its signing after a drama that saw Belgian regions threaten to torpedo years of negotiations.

"Mission accomplished!" European Union president Donald Tusk tweeted, announcing that the deal would be signed at a summit in Brussels on Sunday with Canadian Prime Minister Justin Trudeau.

> The trade agreement requires all 28 EU member states to endorse it and in some cases -- as in Belgium -regional governments also have to give their approval, meaning Wallonia and the other holdouts were effectively blocking the deal.

Trudeau had been due to arrive in Brussels on Thursday to sign the deal but that had to be called off, with leaders including Tusk warning that the debacle was further damaging EU credibility following Britain's shock vote to leave the bloc.

Belgian Prime Minister Charles Michel held marathon talks in a bid to win the holdout regions over, finally announcing Thursday that the two sides had reached a deal.

Belgium became a lightning rod for warnings that the EU's international standing, hit by a migration crisis as well as the Brexit vote, would suffer further if seven years of trade negotiations were to go to waste.

After hitting deadlock in talks with Walloon leaders last week, an emotional Freeland dismissed Brussels as "incapable" of achieving an international agreement.

Paul Magnette, head of the southern French-speaking Wallonia, had fought for the region's farming interests and guarantees against international investors forcing governments to change laws against the wishes of the people.

While Michel has said the fraught talks with Wallonia "did not change a comma" in the deal, Magnette says he walked away with assurances from the federal government of strengthened social and environmental protection.

"CETA amended, CETA corrected -- that is fairer than the former CETA and offers more guarantees," Magnette said.

The EU was cleared to sign the pact shortly after Wallonia's parliament voted to approve the deal, along with that of the Brussels-Capital region and the Federation Wallonia-Brussels.

Once signed, the pact will go into effect on a provisional basis, pending full member state ratification -- a process that could take years.

Spain's growth slowed but remained firm in third quarter

Spain's growth slowed but remained firm in the third quarter, official data showed Friday, just as the country emerges from 10 months of political crisis with the conservatives set to head up a minority government.

The Ine statistics agency said that GDP expanded by 0.7 percent compared to the previous three months, which had registered 0.8 percent growth.

Compared to the same period in 2015, the economy rose 3.2 percent from July to September, the same rate as in the second quarter.

This is well above the eurozone average of 1.6 percent in the second quarter -- the latest figures published by statistics agency Eurostat.

The GDP figure for the third quarter is the same as that predicted last month by the central bank, which pointed to a slight fall in exports compared to the previous three months.

But the central bank had said that household and company spending remained strong, as unemployment drops and interest rates remain low.

For 2016, the government predicts growth of 2.9 percent, while the central bank thinks it will be higher, at 3.2 percent.

The growth figure comes a day after the Ine agency said unemployment dropped to its lowest rate in six years at 18.9 percent in the third quarter, thanks in large part to the services sector during a bountiful summer season for tourism.

S&P confirms British rating, warns on Brexit

Standard & Poor's maintained Friday its rating for Britain, having removed its coveted 'AAA' status after the June 23 EU exit referendum, and warned again over the impact of Brexit.

S&P said in a statement that Britain's assessment remained at 'AA' with a negative outlook, meaning that the agency could lower the rating in the medium term.

"In our opinion, Brexit presents a significant risk to the UK's track record of strong economic performance, and to its large financial sector in particular," S&P said. "The Leave result has also led to a less predictable

and stable policy framework for the UK." It added: "The outlook remains negative, reflecting the continued institutional and economic uncertainty surrounding Brexit negotiations, and what arrange-

ments will emerge post-departure." S&P also flagged uncertainty over the future of Britain's membership of the single market.

"The recent decision to exit the European Union -the destination for 44 percent of the UK's goods and services exports -- poses a potential risk to the UK's national income, as well as its fiscal and external balances," it said.
