WB offers \$100m to fortify insurance, pension sectors

The World Bank has offered Bangladesh \$100 million for strengthening the insurance sector and the private pension market so that the financial sector can give better service to the people. The Washington-based multilat-

eral lender has recently sent a draft proposal to the finance ministry in this regard. There has been notable prog-

ress in financial sector development over the years increasing the depth of the financial sector from 12 percent in 1980 to 70.8 percent in June 2013, the draft proposal said.

Progress has been made in many other fronts as well including the strengthening of banking sector regulation and supervision, financial access to households and recent efforts to fortify state-owned banks.

"But this remains an unfinished agenda, especially with regard to the insurance and pension sector."

Subsequently, it suggested \$35 million for strengthening the Insurance Development and Regulatory Authority and Bangladesh Insurance Academy, \$40 million for the modernisation of stateowned insurance companies and \$20 million for developing a private pension market.

A WB mission has already visited Bangladesh with the draft proposal and held meetings with concerned officials of various ministries, a finance ministry official said.

The finance division has suggested the WB take separate projects for the insurance and pension sectors, he said.

Direct support for the IDRA from the WB will involve providing advisory and capacity building services as well as equipment to upgrade IDRA's regulatory and supervisory functions.

To increase its capacity, the IDRA has to formulate rules, regulations and guidelines to set up risk-based solvency rules, improve products for life and non-life insurance and market practice including micro-insurance, the

BTRC plans to allow tech neutrality in spectrum use

The telecom regulator has initiated a move to review the 2G service guideline, in a bid to offer technology neutrality to the mobile phone operators in spectrum use in two bands, which will help them roll out 4G services soon.

Spectrum allocation in the country is service specific as the 900MHz and 1800MHz band spectrum is assigned for only 2G services and the 2100MHz band spectrum is for 3G services.

The 2100MHz, however, is also allowed for

4G services, but it will require a separate service guideline, which is yet to be formulated.

BTRC officials said if technology neutrality is allowed, the operators can then start 4G services with 1800MHz, which will be cost-effective for them.

In this region, operators are allowed to take technological neutrality, and all of them are using the 1800MHz band for 4G services. Some countries are also allowed both the 1800 MHz and 900 MHz bands for 4G services, said another senior official of the regulator.

"Actually, only Bangladesh is yet to offer The meeting presided over by its 4G services in South Asia," said the official.

> The top two mobile phone operators Grameenphone and Robi - have already requested the regulator for a 4G services guideline. However, allowing technology neutrality can affect the prospects of the 700MHz band, currently specified for 4G services, in the short run as operators might not be willing to buy that spectrum.

> BTRC officials said the 2G spectrum price will also be adjusted under the review, as technology neutrality would make the 1800MHz band more lucrative.

> Currently, the 10.60MHz spectrum is available in two blocks for auction in the 1800MHz band or 2G services.

> The base price was set at \$30 million for 1800MHz in 2015 when BTRC was trying to hold an auction for the remaining spectrum of 2G and 3G (2100MHz).

> BTRC, however, could not hold the auction after changing the date three times as the mobile phone operators said they will not participate if the government did not settle a

> Tk 3,000 crore tax dispute with the operators. Later, the base price of 2G spectrum was readjusted to \$25 million and approved by the finance ministry.

Duty-free access to UK to continue

Bangladesh will continue to get duty privilege to the UK under the European Union's Everything But Arms scheme until Brexit formally happens next year in June, said Alison Blake, British high commissioner in Dhaka, yesterday.

"Until we leave the EU, we remain a member of the EU with all the rights and obligations that our membership entails, including our commitments to the existing trade framework," Blake said.

The process of leaving the EU will be invoked no later than the end of March 2017, she said at the monthly luncheon meeting of Foreign Investors' Chamber of Commerce and Industry at the Westin Dhaka hotel.

But Britain will remain open for business for the world.

"There are challenges as well as opportunities but because of the decisions the government has taken our economy is fundamentally strong and there are many reasons to think our economic future outside

the EU will be bright." Until Brexit materialises, Britain will continue to take a leading role in the EU-Bangladesh Business Climate Dialogue, espe-

cially on taxation issues.

Big change in garment sector after Rana Plaza tragedy

An apparel buying consultant from Netherlands speaks on Bangladesh

The future of Bangladesh's garment sector is bright as the number of factories has gone up over the years and almost all of them are accredited and audited now, said a garment buying consultant from the Netherlands.

"This is a big achievement for the country," said Dhyana van der Pols, owner of Nash International, which advises 200 European garment retailers who source \$200 million worth of apparel items from Bangladesh a year. So far, none of the other garment producing

countries have been inspected by a third party agency. No other nation has voluntarily audited their factories, she said. As a result, retailers all over the world now

consider Bangladesh to be one of the compliant nations, said van der Pols, who recently visited Dhaka to attend a seminar on sustainable sourcing of garment items. The Daily Star caught up with her on the sidelines of the seminar.

Previously, the European and American buyers thought of China a one-stop shopping mall. But now, they have started viewing Bangladesh in the same light, as all their sour-

cing demand can be met here, she said. the low-cost T-shirts and that it is a bottom-

feeder. Bangladesh produces a lot of diversified

products."

The retailers are also shifting orders to



Bangladesh from China, which has lost its comparative advantage due to higher costs of production and shortage of skilled workforce.

The experienced garment buyer went on to "It is not true that Bangladesh produces only recommend Bangladesh to work on formalwear, swimwear and outdoor clothing as well as these items have high demand in the international market.

About the transformation of the garment sector following the Rana Plaza collapse in April 2013, van der Pols said: "The changes are a miracle. The industry people have done everything for changing the industry."

Bangladesh has facilitated everything for restructuring of the garment sector, she said, adding that she herself spread the word on the sector's positive transformation.

"I went to different television shows in the Netherlands and spoke a lot on the progresses Bangladesh made after the Rana Plaza building collapse."

The Alliance for Bangladesh Worker Safety, the Bangladesh Accord on Fire and Building Safety, the brands and the Western consumers have also realised the progresses that Bangladesh made is a miracle, according to van der Pols.

Regarding fair wages, fair prices and fair business conduct, she said these are ethical issues that need everybody's cooperation.

In Bangladesh, the manufacturers are in fierce competition for getting more work orders from international retailers. "The internal competition is a problem for not getting fair prices from buyers."

Going forward, one of the big challenges for the sector is scaling up production to meet the higher volumes of work orders that would be diverted from China.
