Land grabbers at it again in Kuakata beach

Illegal structures are springing up along the Kuakata beach ignoring a High Court directive issued five years ago.

The structures, consisting at least 18 sea-front stores, were built hurriedly over the past few days since Friday with corrugated tin sheet and wood in Narikel Bagan (coconut orchard) area near Zero Point of the beach town.

A local youth named Abdul Kuddus has built the structures and leased those out to various businesses at a rate of Tk 20,000 to Tk 50,000 for each store, said locals.

On June 2, 2011, the HC in its directive required the authorities concerned to immediately remove all structures from the Kuakata sea beach. It also asked them to take necessary steps

to stop encroachment, earth filling and construction of structures on the beach.

The HC directive came following a writ petition filed the same day by Human Rights and Peace for Bangladesh (HRPB) on the basis of a report headlined "Realtor faces eviction case in Kuakata", published in The Daily Star on June 1 the same year.

Requesting to remain anonymous, a storeowner who leased a store space from Kuddus said all the storeowners have made oral contracts with Kuddus and made payments to him, ranging from Tk 20,000 to Tk 50,000 for each space.

Kuddus even boasts of having the capability of managing anyone -officials at the land office, journalists and even political leaders, he said.

Making children smile

and "ba". "After the incident [of liquid coming out of her ear], we discovered that she is losing her hearing ability gradually. She also stopped saying the words she used to utter and started communicating with us by using her arms," said her mother Sarower Nimmy, a home-

maker.

The couple left no stone unturned to get their daughter cured. They shuttled from one hospital to another and met a number of doctors, but to no

Then one day they came to know about a surgery -- Cochlear Implant -from a doctor of Samorita Hospital in the capital. Upon further enquiry, they learned about the surgery and its costs, which the electrician father could not

"We're told that the surgery would cost around Tk 15 lakh. We even thought of selling our organs for Elma's treatment," said Sarower.

Finally, their wish came true as Elma has recently undergone the Cochlear Implant surgery at the Bangabandhu Sheikh Mujib Medical University (BSMMU) at a very low cost. Her parents had to pay only Tk 15,000.

The surgery is being done under a special initiative taken by the social welfare ministry which is implementing it as a programme titled "Development of Cochlear Implant Programme" at the BSMMU. The ministry bears the larger portion of the cost while parents need to pay only Tk 15,000 to 50,000, depending on their monthly income.

The programme was launched in 2010 to treat people, mostly from lowand middle-income families, with hearing impairments. Children are the main focus of the programme as the surgery is more effective for children than for adults.

The ministry usually publishes advertisements in newspapers seeking applications from parents whose children suffer from the disability and the people who want to take the treatment. After getting applications, they analyse those and select patients, said the ministry officials.

A total of 48 children and six adults had been operated on in the first phase of the programme that continued until 2013. Most of the treated children can hear and talk, and are now studying in schools and leading a normal life, said doctors.

In the second phase that started in she will begin to hear." 2014, 40 children and an adult were chosen for the treatment after the selection process. Elma and some other children had already been treated as the surgeries began this

So far, the government had spent Tk 20 crore in the programme which is still continuing. This year, the government has decided to allocate Tk 7 crore as yearly budget following a rise in the demand for the treatment, said ABM Shafiqul Haidar, deputy chief within five years of their birth. (planning) of the ministry.

"We want to thank the government for taking such a great initiative, as it helped us cure our daughter. We can't express our happiness that Elma will be able to hear us again," Elma's father Mostakur told this newspaper.

Doctors at BSMMU said Elma would be able to hear and talk within a year of the surgery by following a rehabilitation process.

Abul Hasnat Joarder, director of the Cochlear Implant Programme, said, "We have set a cochlear implant device, known as bionic ear, inside her [Elma's] ear. After three to four weeks, we will set an external device at the outer side of her ear. It will work along with the implanted device, and then Then she will be given an auditory-

verbal therapy, two days a week for a year, which will help her learn language, he said. To start talking within a year, Hasnat said, she would have to practice at home and take the therapy regularly. Hasnat, also a professor at BSMMU, said hearing impairment can be cured,

and children with severe hearing impairment can also be treated if their cochlear implant surgery is done "It is better to do the surgery when patients are 2-3 years of age, as their

language learning ability reduces with age," he said. The doctor said Elma is lucky to

have her surgery done within time.

Every year, around 2,600 children are born with hearing disability in the country, and approximately six percent of children (aged 0-14 years) suffer from mid-range hearing impairment, according to a 2013 survey by the World Health Organisation.

According to the survey, 9.6 percent of the country's population and 15 percent of world population suffer from different types of hearing compli-

Ershad's old case gets a hearing date

Former president claims people want to see JP in power

The High Court yesterday fixed November 15 for hearing a 24-year-old appeal of former president HM Ershad against a lower court verdict that jailed him for three years in a corruption

The bench of Justice Md Ruhul Quddus set the date after the Anti-Corruption Commission's lawyer Khurshid Alam Khan prayed on August 22 for hearing the appeal for its disposal.

Khurshid yesterday told The Daily Star that the then Bureau of Anti-Corruption (Bac), which became defunct after formation of the ACC in 2004, had filed the case against Ershad with Cantonment Police Station on charge of misappropriating Tk 1.91 crore by misusing powers at different times when he was the president of the state from December 11, 1983 to December 6, 1990.

On February 3, 1992, a Dhaka court convicted Ershad, also chairman of the Jatiya Party, and sentenced him to three years' imprisonment for misappropriating the money and ordered the authorities concerned to confiscate the money and his Toyota Land Cruiser car for committing corruption.

Ershad the same year had filed an appeal with the HC, challenging the lower court judgment, he said. Following the appeal, the HC stayed

the lower court verdict, he said, adding that the ACC on February 26 in 2012 became a party of the case under the HC's permission, as the Bac was not functional.

The lawyer said Ershad had obtained bail from the HC in the case.

He, however, could not say how long Ershad had been in jail in the case.

Advocate Khurshid said they had earlier tried to get the appeal of Ershad moved before the HC, but there was no SEE PAGE 10 COL 4

The law ministry is going to send the summaries of all 100 selected candidates in a day or two to the president through the Prime Minister's Office for approval of their appointment. Once approved by the president, the law ministry would give them posting upon advice from the Supreme Court.

The president may not approve the appointment of the 21 candidates, who

face objections, the officials added. A process for recruiting 115 new judges for the lower courts have meanwhile been underway to fill the vacant

posts and ease the massive case backlog.

BJSC Secretary Paresh Chandra Sharma told The Daily Star that the commission has already held the written examinations of 1,225 candidates, who had earlier qualified in the

preliminary test held on May 20. Evaluation of their answer sheets has been going on, he said, adding that only the successful candidates would be called for viva.

Chief Justice Surendra Kumar Sinha on October 31 in a message stressed the need for doubling the number of judges in the lower courts.

The number of approved posts of judges for the lower courts is 1,655, of which 387 are now vacant. It is not possible for 1,268 judges to dispose of more than 27 lakh cases pending with the courts across the country, the chief justice observed.
