A 50-year-old man was caught red-handed while attempting to violate a minor girl at Paikpara village in Sadar upazila of the district on Tuesday. Villagers caught the perpetrator, Abul Kashem, son of late

# in panic for days

Five families including a retired teacher are passing days amid utter sufferings and insecurity due to ostracism by a panchayet (village committee) at Ziapur village of Chhatak upazila in Sunamganj.

Victim families filed a petition with Chhatak Police Station on October 25, stating that panchayet president Nur Islam and its members Shafiq Mia, Anor Uddin, Rafiq Uddin and Ramjan Mia imposed the order, forbidding villagers to engage in any interaction with the five families.

But no action has been taken to rescue the victims so far.

There was a long standing feud between retired teacher Masuk Mia and Panchayet member Shafiq Mia over a land dispute, locals and victims said.

Recently Masuk Mia's son Mahbub Mia posted a Facebook status about the land and Shafiq Mia.

On October 22, Nur Islam and Shafiq called an emergency panchayet meeting

and declared the order against the five families including Masuk Mia and his relatives at the vil-

"We are in serious trouble and insecurity. I wish I could die to end the suffering," said octogenarian Takhlis Mia, one of the victims, breaking down in tears.

Khosru Mia, another victim, said he is suffering with his family as he cannot open his shop at Pargona Bazar for the last several days due to the panchayet order.

Victims Shah Alam and Ashak Mia said they

are passing days in panic due following the panchayet decision. Panchayet chief Nur Islam said Masuk Mia and his relatives ignored the panchayet deci-

sion and so, the five families were ostracised as per panchayet rule. Shafiq attempted to justify what he had done, saying, "Masuk Mia's son brought false

accusations against me." Ashek Suja Mamun, officer-in-charge of Chhatak Police Station, said, "We received a written complaint in this regard. After investi-

gation we will take legal action."

### Cuchia, boon for Jhenidah families

Many families in six upazilas of the district are living solvent lives through catching cuchia (swamp eel), a vulnerable species of fish in Bangladesh.

Cuchia traders said around 5,000 people of Bejpara, Baisha, Khalkula, Badurgacha, Sundarpur, Hardebpur, Harigobindapur under Kaliganj upazila are involved in catching the fish. Some families of Shailakupa, Harinakundo and Moheshpur

upazilas also catch cuchia and sell it to the local traders. Gaya Das of Bejpara village said he has been hunting cuchia

for 15 years, like other poor people. He said they are now free from debt by catching and selling cuchia. Dipok Kumar Das and Kishore Kumar Das said they

catch cuchia in waterlogged areas of Kezuli water body in Kaliganj upazila, Dopila water body in Kotchandpur upazila, Garaganj Kumar river area in Shailakupa upazila, bus terminal area in Jessore and water bodies and haors in Barisal.

The fish is sold at Tk 250 to Tk 300 a kg.

Debendra Nath Das of Mahadebpur village in Kaliganj upazila said he catches three to four kgs of fish every day and earns Tk 600 to Tk 700.

Cuchia trader Gopal Chandra Das Goni told this correspondent that he gets profit of Tk 2 lakh every year by investing Tk 7 lakh to Tk 8 lakh. He sends eight to 10 tonnes of the fish to Dhaka every month.
