Another judge dismissed over anomalies

A lower court judge was dismissed from his service on charges of corruption and misconduct yesterday.

The law ministry issued a gazette notification on the

dismissal of former Comilla women and children repression tribunal judge SM Aminul Islam (district judge), now attached to this ministry, after the president approved the decision of his dismissal. It has dismissed four lower court judges including

Aminul in last one month for their incompetence, misconducts and corruptions on advice of the Supreme Court, the ministry's Deputy Secretary (administration)

Mahbubar Rahman Sarker told The Daily Star. The other three were former Jamalpur additional district judge Md Sirajul Islam, former Thakurgaon district judge Ruhul Amin Khandaker and former Khulna additional district judge Moinul Haque.

According to sources, Aminul was involved in a massive corruption as he granted bail in at least 20 non-bailable cases when he was a judge in Dhaka.

Ruhul Amin was involved in corruptions including taking bribes from people for giving them jobs, while Sirajul was involved in corruptions and anomalies including illegally acquiring a piece of land.

Moinul Haque was sacked for delivering verdict after taking bribes when serving as additional district judge of Khulna following complaints of 68 lawyers.
