

Remittance's slide continues for the third straight month, after the month of October saw receipts decline 8.18 percent year-onyear to \$1.01 billion.

Migrant workers sent home \$4.26 billion in the first four months of the fiscal year, down 17.31 percent year-on-year.

The decline in oil price, which dropped to its historic low in January this year from its historic high in the middle of 2014, affected incomes in the Gulf Cooperation Council economies, weakening the demand for migrant workers.

reached 6.8 lakh in fiscal 2015-16, up 48 percent year-on-year. About 71.3 percent of the migrant workers went to the GCC countries: Bahrain, Kuwait,

The six countries are among the top 11 FY '16 remitters to Bangladesh so far in the current fiscal year. They were also among the top 10 countries in the last fiscal year, according to

> Bangladesh Bank. In fiscal 2015-16, remittance fell 2.54 percent year-on-year to \$14.93 billion, despite a significant rise in migrant outflow in the previous two fiscal years.

Remittance sent by migrant workers plays a crucial role in the country's economy, helping reduce the overall incidence of poverty as well as maintaining a healthy balance of payments.

The portal was developed under a Tk 78.98 crore project financed mainly by the Asian Development Bank and the government. The NBR took the initiative in 2011

Govt creating 'land bank' of 100,000 acres

The government is creating a 'land bank' of 100,000 acres to help domestic and foreign investors set up their factories without any hassle in Bangladesh, said Abul Kalam Azad, principal secretary to the prime minister, yesterday.

The 100,000 acres would include the special economic zones that the government plans to set up.

The land application law will be amended in two to three months to give land owners more compensation than they currently get, he said at a programme organised by the Public Private Partnership Authority at the capital's Sonargaon Hotel.

The PPP Authority signed preliminary agreements with 14 lenders on PPP financing partnership.

As per the agreements, the PPP Authority will send tender documents to the 14 banks and nonbank financial institutions before awarding the contracts so that lenders can analyse whether the projects will be financially viable for them.

GSP appeal to be placed in Ticfa meet in Dec

Bangladesh will once again demand the restoration of the trade privileges to the US market at the third round of Ticfa meetings to be held in Dhaka on December 13.

"We will discuss bilateral trade issues with US representatives at the meeting, including the GSP (generalised system of preferences) issue," said Hedayetullah Al Mamoon, senior secretary to the commerce ministry.

Michael J Delany, assistant US Trade Representative for South Asia, is scheduled to lead the US side at the meeting.

Members of the delegation will be finalised after the US general elections on November 8, Mamoon said.

The Trade and Investment Cooperation Forum

Agreement (Ticfa), a platform to discuss bilateral trade issues between Bangladesh and the US, was signed after the collapse of Rana Plaza building in April 2013, mainly to regain the trade benefit.


Under the agreement, both the countries ment of the GSP. hold an annual meeting to call upon the respective governments to remove trade disputes, if any.
