### 35 human skulls found in Dhaka flat, tenant held

Police recovered at least 35 human skulls and some bones from a flat in capital's Kafrul yesterday evening.

The flat's tenant,

Kamruzzaman Ronny, was arrested in this connection. Ronny had rented the flat a month ago, introduc-

ing himself as the owner of a chemical factory in Old Dhaka and a physician at Mitford Hospital, police said, quoting landlord Elias Saifullah.

Masud Ahmed, deputy commissioner of Dhaka Metropolitan Police (Mirpur division), said Ronny claimed before them to be a final-year student at the National Medical College in the

skeletons stored in several cartons were discovered and Ronny was arrested after a tip-off, he said, adding that two of Ronny's associates escaped arrest.

The parts of human

Ronny told police that he sells human skeletons to medical college students and he collected those from a senior physi-

Police are investigating the matter, said the DC.

A resident of another flat of the building first sensed foul odour from Ronny's flat and knocked on his door.

As Ronny did not respond, the resident notified the landlord. Ronny was forced to open the door after residents of the building gathered in front of his door and demanded an explanation.

Police were informed after the skulls and bones were found inside the flat.

Hasina visited the prison cell where Bangabandhu had been kept confined during the Pakistan rule.

The cell has now been named as Father of the Nation Bangabandhu Sheikh Mujibur Rahman Jail Memorial Museum.

Sheikh Rehana's son Radwan Mujib Siddiq Bobby, Home Minister Asaduzzaman Khan Kamal, Lawmaker Haji Mohammad Selim and Inspector General of Prison Brig Gen Iftekharul Islam were present.

Both Hasina and Rehana who survived the August 15, 1975 carnage turned emotional witnessing the materials Bangabandhu used during his prolonged prison time.

Later, she went to the prison cell where the four national leaders -- Tajuddin Ahmed, Syed Nazrul Islam, Captain Monsur Ali and AHM Qamaruzzaman -- were brutally killed on November 3, 1975.

Earlier, Iftekharul briefed her about various projects taken for the old jail through a physical feature survey and topographic map.

The premier inaugurated the Bangabandhu memorial museum and the four national leaders' memorial museum on May 8, 2010.

## ADR ensures justice along with income: Study

Resolving marriage-related conflicts though alternative dispute resolution services not only ensures justice for women but also, in some cases, engages them in income-generating activities, says a 2014 study of Brac Research and Evaluation Division.

Around 9.3 percent of the over 386 respondents from 19 districts got engaged in economic activities availing the services through Brac's Human Rights and Legal Aid Services Programme on experiencing domestic violence.

Around three percent got jobs while four percent engaged in businesses, said the study, revealed through a roundtable jointly organised by Brac and The Daily Star at the latter's office in the capital yesterday.
