Ten temples attacked elsewhere

Yesterday, unidentified criminals damaged the idols of goddess Kali and Shitola at Fulkocha Kundupara Kali Mondir in

upazila, said police and locals. When Hindu devotees went to the temple early yesterday, they found the idols badly damaged, Adhir Chandra Kundu, president of the temple committee, told our Pabna Correspondent.

Songasa area of Sirajganj Sadar

Basudeb Sinha, officer-in-charge of Sirajganj Police Station, said the criminals would be arrested soon. "They vandalised the idols at the temple in a

planned way." Top government and police officials visited the spot.

In a separate incident, unknown criminals damaged an idol of Kali at a temple at Ponabalia Bazar in Jhalakathi Sadar Upazila on Saturday night.

Materials used for performing prayers were thrown into a pond near the temple, Anil Chandra Das, president of the temple committee, told Our Jhalakathi Correspondent.

The criminals carried out the attack in the dead of night, he added.

The attacks took place despite the police headquarters' instructions on Thursday to all its units to stay alert. It issued a six-point directive, including one for taking prompt steps against whoever instigates violence to harm communal harmony.

Asked about the recent attacks, Home Minister Asaduzzaman Khan Kamal said his ministry has taken all necessary steps to prevent this type of incidents and alerted the police, the BGB and Rab.

"The situation is under control," claimed the Home boss.

On the steps taken to check attacks on the minority community, Kamal Abdul Naser Chowdhury, senior secretary to the public administration ministry, said,

"Directives have already been given in

this regard. The administration is alert." Meanwhile, representatives of the Hindu community alleged that the failure of the administration and the police, and the culture of impunity were the reasons behind repeated attacks on the community.

At a meeting with Inspector General of Police AKM Shahidul Hoque at the police headquarters, they demanded trial of the cases filed over such attacks.

They voiced concern over the prevailing situation and demanded tough action against the culprits.

The minority community representatives also sought investigation into the role of local Awami League leaders and activists as well as police in the Nasirnagar incident.

They called for forming a cell at the police headquarters to look into the attacks on the minority community. The IGP assured them of setting up a

cell, and said that he himself would oversee it, according to a press release.

Shahidul also told them that he had already given directives to form "harmony committees" with representatives of all religious communities in every division, district and upazila to maintain communal harmony.

OTHER ATTACKS

In Netrakona, police arrested a person for allegedly torching Ekota Sangha Kali Mondir in Satpai area on Saturday.

The arrestee was identified as Sumon Islam, 40, son of Nurul Islam of Singrapur village in Narsingdi's Raypur upazila, police said.

Bhajan Das, president of the temple committee, said they caught Sumon redhanded at the temple. The idols there were damaged partially by the time they brought the fire under control.

Yesterday, a Netrakona court placed Sumon on a two-day remand.

In Thakurgaon, criminals set fire to a temple and vandalised a Kali idol at Pokati Paschimpara village in Thakurgaon Sadar upazila on November 4.

Banaripara police in Barisal arrested a person, Babul Howlader, for vandalising idols of goddess Durga and other deities at a temple in Banaripara Bazar on Thursday.

Ziaul Ahsan, officer-in-charge of Banaripara Police Station, said Babul was arrested from his house at the upazila's Narottampur village.

During primary interrogation, Babul confessed to his involvement in the

attack, said the police officer.

In Gopalganj, a temple came under attack in Raghunathpur on October 31. The same day, unknown criminals

vandalised an idol of goddess Durga and looted valuables from a temple in Chittagong's Hathazari upazila. The criminals looted gold jewellery and cash from the temple's vault, said

Hathazari upazila Puja Udjapon Committee. Also on October 31, a group of 50 criminals attacked a Kali temple and a Shree Chaitanya temple in Sunamganj under the pretext that some Hindus set off firecrack-

They, however, could not enter the temples as those were locked.

The mob then hurled brickbats at two Hindu houses.

On October 30, when religious bigots carried out attacks on the Hindus in Brahmanbaria's Nasirnagar upazila, violence spilled over into neighbouring Habiganj district where a Kali temple came under attack in Madhabpur bus stand area.

The attackers vandalised a Kali idol there when Hindu devotees were offering prayers on the occasion of Diwali.

The deputy commissioner's (DC) office acquired the land for then Pakistan Industrial Development Corporation, which established Rangpur (Mahimaganj) Sugar Mills between 1954 and 1957. The original land owners were given only Tk 8.07 lakh for the vast land. Later in 1962, the DC office, on behalf of the land owners, signed an agreement with the corporation.

City

The deal stated that the land was acquired for cultivation of sugarcane by the mill authorities. If the land is used for farming any other crops, the corporation shall surrender the land to the government (the DC office).

However, the agreement was violated as the mill authorities leased out most of the land for cultivation of crops like rice, wheat, mustard, tobacco, and maize. Four months ago, indigenous people

occupied around 100 acres of land and built makeshift sheds on the plea that the land belonged to their forefathers. Several clashes have meanwhile taken

place over eviction of the indigenous people from the land. Contacted, Gaibandha

Superintendent of Police Ashraful Islam said police would launch a massive drive to evict illegal occupants by night to recover the government land. Communist Party of Bangladesh has,

meanwhile, condemned the police attack on indigenous people. In a state-

ment, party chief Mujahidul Islam Selim and Secretary General Syed Abu Zafar Ahmed alleged that a conspiracy to evict indigenous people has been

going on for long in the name of protecting government property. "We have taken possession of our forefathers' property at Shahebganj sugarcane farm, as the mill authorities are

no longer cultivating sugarcane," said Sofen Hasbrone. "We have appealed to the authorities concerned to get back our forefathers' property acquired by the then government on condition that if the mill was shut down, the property would be handed over to the original owners,"

said Sreemon Basthe. Santal people have been peacefully staging demonstrations, including forming human chains and submitting memorandum, to get back their land in vein and were eventually compelled to take possession of their land, said Shahjahan Ali, secretary, Bhumi Uddhar Committee, Shahebganj.

"Several of my men were pierced by arrows and are now undergoing treatment at Gobindaganj Health Complex, said Subrota Kumar Sarker, officer-incharge of Gobindaganj police.

Talking to The Daily Star, Abdul Awal, managing director of Rangpur Sugar Mills, said, "We have made several requests to the indigenous people to vacate the mill's land, but no one paid any heed."

were just parked while others were being repaired. Besides, buses were seen stopping

even on middle lanes to pick up or drop off passengers. Trucks were seen loading and unloading goods like bamboos, motor

parts and scrap metals, occupying part

of the road. The spots where the occupancy was most prevalent include Dania, Shanir Akhra, Matuail, Rayerbagh, Sanarpar,

Signboard and Simrail. "We have no parking lot. That's why we park our buses here because most of the owners live in this locality," said Akash, a helper of a minibus that was parked occupying the road at Dania,

on August 15. Around 30 buses were also seen parked in a row in the area. Some of them were on the road.

Visiting the same spot on October 4, around a dozen buses were seen parked there in a similar way.

At different points along the highway, buses, trucks and pick-up trucks were being repaired and painted, taking up a part of the road.

"Whenever there is a minor problem in our bus, we come here [Rayerbagh] at the roadside garages for a quick fix," said Abdul Halim, a driver of a local bus plying Dhaka-Narayanganj route, at Rayerbagh.

A staff of Abdullah Motors at Sonir Akhra said, "We have been running this garage here for the last couple of years. As there is a shortage of space, vehicles are often parked on parts of the road." In Matuail, some people were seen

unloading steel sheets from a pickuptruck, which was parked on the road. There are around a dozen shops

along the highway that sell bamboos, and most of the time, traders keep their trucks on a lane of the road and then load the vehicles or unload the bamboos on to the soft shoulder.

A good number of local buses were also seen parked on a lane of the highway at Sanarpar and Signboard areas.

"This is our last stop [Sanarpar] ... We keep our buses here for some time until the next trip," a driver told The Daily Star on condition of anonymity.

However, drives to remove illegal structures on both sides of the highway were on and the rubble of the temporary shops and other establishments were seen scattered beside the road. "We had a garage here. But the

"Rasraj Das didn't upload that image

from Dhaka three days after the October 30 attacks. He drew a lot of flak for playing it down by saying the hate attacks were "not

that serious" and that "only one or two incidents of looting took place". Besides, there was allegation that he

used abusive words against Hindus. Mobs, including religious zealots and local goons, vandalised and looted over a hundred houses of Hindus and temples in Nasirnagar upazila headquarters and Haripur union during the three-

hour mayhem. It was over a Facebook image, purportedly in the account of Rasraj, "hurting the religious sentiment" of the Muslims.

Before his arrest, the 27-year-old claimed that he had nothing to do with the upload. He apologised for it anyway while relatives said the account might have

been hacked. The minister at the press conference trashed reports that the local administrabrought the situation under control quickly. He even said only two to three houses

were torched.

But the administration itself in a survey found at least 58 families were affected and 17 temples were either damaged or looted when the mobs went berserk in at least eight Hindudominated areas that day. Hours after the minister's statement

defending the local adminstration and police, the public administration ministry issued a circular transferring Nasirnagar Upazila Nirbahi Officer (UNO) Choudhury Muazzam Ahmed and attaching him to the ministry before further appointment.

Later, UNO Muazzam told this correspondent that the transfer actually came as a blessing for him. He, however, did not say why.

On Thursday, the Police Headquarters withdrew the officer-incharge of Nasirnagar Police Station, Abdul Kadir, following widespread criticism for failing to ensure security of the Hindus.

Local Hindu leaders have been demanding resignation of the UNO and the OC, alleging that both assisted in the organising of two protest rallies from where zealots and local goons carried out the attackts. Besides, the two didn't take proper precautionary measures to

save Hindus. Asked about the officials giving the two Islamist groups permission to hold the rallies, Sayedul said, "They [local administration and police] had tackled the incident very well at the beginning. The OC even suffered
