### Ahle Sunnat Wal Jamaat denies attack allegation

Islamist group Ahle Sunnat Wal Jamaat's central committee yesterday denied the allegation of their involvement in the attacks on the Hindus in Brahmanbaria's Nasirnagar upazila.

Holding a press conference in the capital's Jatiya Press Club, they condemned the attacks.

The group's member secretary Mosaheb Uddin Bakhtiar announced to hold a rally at Suhrawardy Udyan on Saturday to protest the militant and minority attacks.

Replying a query, he, however, said they have not got permission yet from Dhaka Metropolitan Police to hold the rally there, but are hopeful.

The group claimed that they had only held a rally in Nasirnagar after taking the local administrations' permission against "maligning" holy Ka'aba allegedly through a Facebook post by a Hindu youth who later denied posting it.

"Two groups held separate rallies on the same day in Nasirnagar. One was linked with us, but we had no links with the other one," said Bakhtiar.

Additional superintendent of police and upazila at their rally, he claimed, after reading out a written statement at the press conference.

Zealots vandalised at least five Hindu temples and ransacked over a hundred houses of the minority community on October 30 following the Facebook

Terming the attacks "medieval barbarism", Poet Asad Chowdhury said the government will have to ensure speedy trail and the people come forward to resist such "planned" violence against the minorities.

Bangladesh Group Theatre Federation Assistant General Secretary Chandan Reza, Jatiya Kobita Parishad President Prof Muhammad Samad, Acting Editor of the daily Sangbad Khandaker Muniruzzaman and Poet Ashim Saha also spoke.

Shafiul Alam Bhuiyan, chairman of the film and television studies department at Dhaka University (DU), told a human chain that only the laxw

enforcement agencies will not be able to prevent such crimes, but rather a change in the people's psyche is needed to curb these. Dhaka University Teachers' Association formed

the human chain at the base of Aparajeyo Bangla on the campus. Rajshahi University and Jagannath University, too,

formed two human chains on the respective campuses, while commoners formed another human chain and brought out a procession in New Market area of Chittagong city, protesting the attacks.

In Barisal, Communist Party of Bangladesh and Bangladesh Sajtantrik Dal were seen holding a similar protest programme for the same reason.
