The eldest daughter, Sharmin, said a group of people have been spreading rumours to demerit the case although her father did not have any affiliation with any political party or any enmity with anyone over any land dispute.

Sharmin and her mother demanded exemplary punishment to the criminals.

Aminul Islam, officer-incharge of Kaliganj Police Station, said he only heard about a quarrel in the village, but he was not informed of any "eve teas-

He, however, said he already heard that Shahanur has lost his two

He had asked Shahanur's family to file a case with the police station, but they filed the case with Jhenidah court instead, claimed the OC.

On Monday night police arrested two individuals named Azad Hossain and Likhon Mondol on suspicion of their involvement with the crime and they have been trying to apprehend the other criminals, he added.

Forest official, 4 others beaten by grabber's men

A forest beat officer and four others were beaten up allegedly by the men of a local land grabber as they tried to stop construction on a land at a forest at Boiragir Char village in Sreepur upazila of Gazipur district yesterday.

The injured are forest beat officer Rafiqul Islam, 35, forest guard Anwar Hossain, 50, Md Azharul Haque, 45, Md Sajidur Rahman, 35, and Md Jahangir Alam, 35. They were admitted to the upazila health complex.

Forest Range Officer of Sreepur Mozammel Haque alleged that one Jahirul Islam, son of Sukkur Ali of Baoiragichala Uttarpara village, constructed a house occupying the khas land at midnight.

When the four went to stop construction of the house in the morning, a gang allegedly led by Jahirul beat them up mercilessly, he said.

They were later taken to the hospital, said the forest official. Refuting the allegation, Jahirul said he has been living there for about two decades. He paid taxes of the land until Bangla year 1422.

He claimed that while strengthening a pillar of the land, a few bitter words were exchanged with the forests officials.

Preparation to file a case with Sreepur Police Station was going on in this regard as of filing of this report around 6:00pm yesterday.

Attacks on to grab Khasi land

Miscreants cut down 350 betel leaf plants in five days

Betel leaf cultivation is the only source of income of the indigenous Khasi people in the district, but some criminals have started destroying the betel leaf gardens recently.

Criminals cut down 150 betel leaf trees in Muroicherra punjee area under Kulaura upazila of the district on November 4. They felled over 200 betel leaf trees at Islacherra punjee on October 31.

Headman of the Islacherra punjee Akriman Pathmi said criminals cut two hundreds betel plants in his punjee.

The people of Kulaura upazila are added. deeply distressed following an attack by a gang of criminals who targeted the punjee's betel leaf plantations. Indigenous people believe the attack was instigated by Palash Mia and

Babul Mia of Noldori village following an earlier altercation between residents and the duo on September Head of the Amuli punjee Protush

Asakra said environmentalists, civil society and punjee people demand immediate arrest and exemplary punishment of the persons involved in such a heinous act. Flora Bably Talang, general secre-

tary of KUBORAZ (an indigenous human-rights based organisation) said the responsibility of state is to ensure security of the Khasi community. The state should take urgent action against the perpetrators, she

Despite several attempts, this correspondent could not contact the Kulaura forest officer as his cellophane remained switched off.

Officer-in-Charge of Kulaura

Police Station Md Shamsuddoha said the victims should inform the police, who can then investigate the matter and take action against the culprits. President of Bangladesh Adivasi

said Khasi people have not been getting justice in the matter for a long time. The land belongs to them as per ILO Convention-107, he told this correspondent. Joint Secretary of Bangladesh Paribesh Andolon (Bapa) Sharif Jamil

Forum Sylhet chapter Gourango Patro

said innocent Khasis are in jail facing false cases, tea gardens are chopping down trees, and land grabbers together with timber traders are destroying Khasi villages.

Destruction of betel leaf gardens is violation of the Constitution of Bangladesh. There is no alternative but people's movement to protect the Khasis and their villages, he added.

Salt-resistant bamboo brings hope in coastal areas

Prior to the introduction of a new salt hardy strain of bamboo in 2010 the plant, despite its usefulness, held little attraction for coastal dwellers. The new strain developed by the Bangladesh Forest Research Institute and adapted to grow well in salty soils has changed that. Nowadays, bamboo is proving increasingly popular in coastal household

gardens. "We had a lot of unused land," says Md Zakir Howlader, from Baher Char in Patuakhali's Rangabali upazila. "Then an officer from the forest research institute gave me some bamboo trees and now a healthy

stand covers a good area of my land." "I bought bamboo trees for Tk 20 each," says Abdur Rahaman Munshi of

Char Kukri Mukri in Bhola district.

"Now in our household garden there are over one hundred."

According to S.K. Ahiul Islam, divisional officer of the forest research institute's plantation trial division, it's usual for some with the new variety results are promispart of household yards to be devoted to bamboo since many useful household items including baskets, trays and winnowing fans are crafted of bamboo. The variety known as 'bangla bash', locally called 'baijja' can live for up to 45 years.

"In coastal areas," says Islam, "research shows that bamboo clumps are successful at offering protection from natural calamities like storms, a characteristic of particular importance in the context of global warming. The impact of storms and climate change can be reduced if bamboo is planted on a large scale. It would be useful for the forest department or NGO sector to pursue such a project."

"Commercial bamboo farming has been a challenge in coastal areas," says another forest research institute officer, "due to the saline soils. But

The new salt tolerant bamboo has been introduced with a view to commercial farming in a range of areas, resulting in increased bamboo coverage. Abdul Quddus, from the Barisal office of the forest research institute reports that in Patuakhali's Rangabali where in 2010 within 29 households sampled only 198 square metres was covered by bamboo, nowadays within 639 households surveyed bamboo coverage measures 5,104 square metres. Similar increases have been documented on Bhola's Char Kukri Mukri, in Chittagong's Sitakunda upazila and in coastal Noakhali.

FROM PAE 16 This means it is safer from large storms and invisible from the shore. When it starts generating in 2018, Ceto 6 device will represent the country's first wave farm.

The device works using a large float submerged in the sea. As the float is lifted and lowered by the wave motion, this drives a pump and a generator.

Power is delivered back to shore through subsea cables to power desalination plants as well as for export into the grid. Three Ceto units are already in operation in Australia. It will start providing

1MW of electricity in 2018, enough for 400 homes a year, but this will grow to 15MW with another 14 devices by 2020 if the second stage of the project goes ahead.


That will be enough to power 6,000 homes each year by 2020. This would

make it Britain's first wave farm with multiple devices. "The UK offers unique advantages for the commercialisation of Ceto," said Carnegie's Managing
