# Evicted Santals now face acute food crisis

Also, police not letting them out of 3 villages to 'avoid flare-up of violence'

Indigenous people evicted from the land of Rangpur Sugar Mill in Gobindaganj upazila of Gaibandha have been in dire straits as police are not letting them move out of three villages for avoiding any further violence.

As many as 1,200 families took shelter at Sahebganj, Joypurhat and Madarpur villages of Sapmara union in the upazila after their eviction on Sunday night from the land that the Santal community claims to be of their forefathers. Their belongings on the disputed land were demolished that night.

During a visit to the areas yesterday, the correspondent observed panic among the indigenous people.

Policemen were deployed at the entries of the roads that lead to the villages. Law enforcers were seen whistling to a group of indigenous people as they tried to walk out of their village.

Adivasis said police were prohibiting them from going out of their villages.

However, Subrata Sarker, officer-in-charge of Gobindaganj police, said they had set up temporary camps to ensure safety of Adivasis.

# NASIRNAGAR ATTACKS PM angry over AL MP's role

Prime Minister Sheikh Hasina yesterday expressed anger over the role of Brahmanbaria district Awami League President RAM Obaidul Muktedir Chowdhury in the Nasirnagar incident.

"I won't keep him in any committee," sources quoted Hasina as saying. She was speaking at the adjourned joint meeting of the Awami League Central Working Committee and Advisory Council at the Gono Bhaban.

The lawmaker from Brahmanbaria-3 is also a member of the AL central committee.

Mobs, including religious zealots and local goons, vandalised and looted over 100 houses of Hindus and temples in Nasirnagar upazila headquarters and Haripur union during the three-hour mayhem on October 30.

Hasina said BNP-Jamaat

# 42,000 displaced in Mosul assault

Says IOM as Iraqi forces yet to push deep into IS-held city; US-led coalition raid 'kills 20 civilians' near Syria's Raqa

Nearly 42,000 people have fled their homes since last month's start of the operation to recapture Mosul from the Islamic State group, the International Organization for Migration said yesterday.

Aid organisations have warned that more than a million people could be displaced in the battle for Mosul, and while it has not yet reached that scale, the numbers are growing.

The IOM said on its displacement tracking web page that 41,988 people have been "displaced as a result of the ongoing Mosul operations which began on 17 October 2016."

That was an increase of more than 7,000 from the figure the IOM gave the previous day.

The IOM said a significant part of that increase was the result of new counts of people who were already present in camps, though more were also still arriving.

While the worst-case scenario has not materialised so far, Iraqi forces have yet to push deep into the city, and the number of people fleeing could increase dramatically when that occurs.

Both Mosul residents and the United Nations have reported that IS has forcibly gathered civilians for possible use as human shields.

IS militants have displayed the crucified bodies of five people they said gave information to "the enemy", and are back on the city streets policing the length of men's beards, residents say.

The five bodies were put on display at a road junction, a clear message to

# Anti-liberation forces behind B'baria attack

Says 14-party after visiting Nasirnagar

The October 30 attack on the Hindus in Brahmanbaria's Nasirnagar was instigated by "anti-liberation forces and aides of BNP Chairperson Khaleda Zia", top leaders of Awami League-led 14-party alliance said yesterday.

They also vowed to try the attackers and the masterminds behind the incident at the speedy trial tribunal.

"The killers and looters who don't believe in Bangladesh's liberation carried out the attack on the Hindus of Nasirnagar," Health Minister Mohammed Nasim said while talking to some of the victims at Goura Mandir in the upazila.

Nasim led a 14-member 14-party alliance team, which visited the areas that came under the attack that day.

"The attack was aimed at demeaning the Sheikh Hasina-led government and making Bangladesh look like it is not safe for the Hindus," he said. "The attackers will be tried at the speedy trial tribunal."

The AL presidium member also

# MONEY LAUNDERING Top court asks Morshed Khan, wife, son to surrender

The High Court yesterday directed former BNP foreign minister M Morshed Khan, his wife Nasrin Khan and their son Faisal Morshed Khan to surrender before a court in six weeks in a money laundering case.

The HC, however, asked the lower court to grant them bail in the case after their surrender.

Delivering a verdict on a revision petition filed by the Anti-Corruption Commission (ACC), the HC extended till March 31 next year its earlier order of freezing the bank accounts of Morshed, his wife and son with the Standard Chartered Bank in Hong Kong.

The bench of Justice M Enayetur Rahim and Justice JBM Hassan also permitted the ACC to further investigate the money laundering case against them.

# Save Turag

HC asks govt to stop earth filling, encroachment within 48 hours

The High Court yesterday directed the government to stop earth filling, encroachment and construction of structures along the foreshores of the Turag river within 48 hours and submit a report to it by November 27 after complying with the order.

The court also asked the deputy commissioner of Gazipur to submit within the same timeframe a list of names and addresses of those involved in carrying out such activities.

In response to a writ petition, the court issued a rule upon the authorities concerned to explain in four weeks why their inaction to stop such activities should not be declared illegal.

The court also asked the authorities to explain why they should not be ordered to remove the soil already dumped in the river and to demolish the structures along the foreshores of the Turag.

Shipping secretary, chairmen of Bangladesh Inland Water Transport Authority and Rajdhani Unnayan Kartipakkha, directors general of Water Development Board and Department of Environment, deputy commissioner and superintendent of police in Gazipur, and officers-in-charge of Turag and Tongi police stations were made respondents to the rule, petitioner's counsel Manzill Murshid told The Daily Star.

The HC bench of Justice Quazi Reza-Ul Hoque and Justice Mohammad Ullah came up with the order and rule after hearing the writ petition filed by Human Rights and Peace for Bangladesh, seeking necessary orders on the authorities concerned to save the river.
