China producer prices rise for second straight month

Price for goods at the factory gate rose in China for the second straight month in October, officials said Wednesday, in a sign of strengthening demand in the world's second-largest economy.

The producer price index (PPI) rose 1.2 percent yearon-year in the month, according to the National Bureau of Statistics (NBS), adding it "rebounded obviously". In September, the index ended more than four years of falls, rising 0.1 percent on-year and offering some relief

to longstanding concerns about deflation. Chinese firms have for years been battered by falling prices for their goods in the face of chronic overcapacity and weak demand, putting a damper on growth in a key

driver of the world economy. Protracted drops in PPI bode ill for industrial prospects and economic growth, as they put off customers -- who seek to delay purchases in anticipation of cheaper deals in the future -- starving companies of business and funds. October's figure exceeded economist expectations of a 0.9 percent increase in a Bloomberg poll.

"Consumer and producer prices are both rising at a comfortable pace, with deflation fears no longer a pressing concern," Julian Evans-Pritchard of Capital Economics said in a note.

Surging prices for key industrial commodities, particularly coal, appeared to drive the increase, and "the trend will continue for a while

until it heads down next year", Larry Hu of Macquarie Securities in Hong Kong told Bloomberg. "The readings show that China's economy has stabilised." The consumer price index, a key gauge of retail infla-

tion, matched expectations with an increase of 2.1 percent on the back of rising food, housing, and health care costs, data showed. Looking ahead, Evans-Pritchard said the introduction of policies designed to control housing prices and loose

credit will start to rein in consumer inflation. Other data have showed a mixed picture of the Chinese economy, as exports sank for the seventh straight

month and came in below forecasts in October. Overseas shipments fell 7.3 percent year-on-year, while imports also dropped 1.4 percent, Customs said Tuesday.

Moscow stocks higher on Trump win

Moscow stocks ticked up Wednesday on news of Donald Trump's victory in the US presidential election, running counter to falls in global financial markets, amid hope that Trump would mend relations with Moscow.

Russia's dollardenominated RTS index gained 1.2 percent at 0900 GMT, while the rubledenominated Micex went up 1.0 percent.

Some analysts said that Russia's economy is likely to benefit from Trump's victory, as he repeatedly professed his desire to work with Moscow during the presidential campaign, stirring hopes that his term would bring an ease in sanctions over the Ukraine crisis.

Economy Minister Alexei Ulyukayev was quoted by Russian agencies as saying Wednesday that he "would like to rebuild a higher level of trust and cooperation", including economic, but that it was too early to tell if Trump would fulfil those hopes.

"Any assumption for a quick dilution of sanctions or an early summit between Trump and Putin is unrealistic," wrote Chris Weafer, senior partner in Macro-Advisory consultancy.

Britain puts brakes on EU tax haven blacklist push

EU finance ministers on Tuesday painfully agreed on the criteria to draw up a European blacklist of tax havens, but Britain watered down the proposal, eager to protect low tax dependencies such as Bermuda and Guernsey.

Europeans have struggled to agree on the basis of an EU-wide tax haven blacklist, even after revelations in the Panama Papers and LuxLeaks scandals shocked the general public on the strategies used by the rich people and big companies to reduce tax bills.

The European Commission, the EU's executive arm, has taken the lead on cracking down on tax havens and wants to draw up a list of problem jurisdictions by the end of next year. Britain, as well as Malta and the Baltic states, however blocked a push to include zero or near-zero corporate tax rates as one of the criteria to land on the EU's blacklist, diplomats said.

The ministers agreed to delay that decision for now -- presumably at least until after Britain leaves the EU after its Brexit divorce, expected in 2019. But it ordered a task force to explore the idea further. "What was very important for some countries was the near zero corporate tax rate, which is important for us too, but maybe as an indicator not as an cialised in setting up such firms.

actual criteria," said Spanish Economy Minister Luis De Guindos after the talks.

The 28 ministers agreed other criteria however including a demand that third countries automatically exchange tax information and agree to an already existing set

of G20 standards to fight tax evasion. A spokesman for the British government said the new criteria "will encourage those few tax jurisdictions that refuse to follow internationally agreed best practice to do the right thing."

EU Commission Vice President Valdis Dombrovskis said the EU would notify a very broad list of countries by the end of January, from which the far more narrower blacklist would be drawn before 2018.

Activists criticised the watered down proposal, adding that the process still lacked transparency. "If the EU blacklist is to be a useful tool in the fight against tax dodging, and not just a gimmick, politicians can't afford to fudge it," said Esme Berkhout, tax policy advisor for Oxfam.

The EU blacklist in one of many ideas given in reaction to the leak of thousands of documents last Spring on anonymouslyowned shell companies from Mossack Fonseca, a Panamanian law firm that spe-
