The smiling faces of the recipient kids showed how small gifts can mean a big thing and initiate a real change for the better.



Police rescued a schoolgirl, allegedly abducted from Dimla upazila of Nilphamari, from Savar upazila in Dhaka on Friday, 23 days into her abduction.

The law enforcers also arrested Jahangir Alam, 22, and his father Abdul Mazid, 55, for their alleged involvement in the abduction.

Police said Jahangir and his associates picked up the girl, a Class IX student of Dimla Chapani Girls' High School, while she was returning home from the school on October 19.

Failing to know her whereabouts, victim's grandfather lodged a case with Nilphamari Women and Children Repression Prevention Tribunal the following day.

Officer-in-Charge Moazzem Hossain of Dimla Police Station said police rescued the girl from a house at Nabinagar village. They also detained Jahangir and Mazid from there.

Sub-inspector Shahabuddin Ahmed, also the investigation officer of the case, said the victim, however, claimed that none had abducted her and she left her house willingly and married Jahangir the same day.

Police produced the arrestees and the victim before the court yesterday that sent Jahangir and Mazid to jail and handed the victim under her grandfather's custody.

Property-greedy family members beat dead an elderly man in Bhangura upazila of the district on Friday. The victim is Md Torab Sardar, 70, son of

late Fayez Sardar of Boalmari village of Mondotosh union in Bhangura upazila. Police arrested Torab's son Saddam

Hossain, 24, and daughter Sabina Khatun, 20, on charge of the murder while two other accused -- Torab's wife Sohagi Begum and son-in-law Monirul Islam managed to

"Torab's wife and their son and daughter often created pressure on him to hand over 10 bighas of inherited land so that they can sell it. But he did not want to part with the paternal land before his death," said Md Amir Hossain, nephew of the victim.

On Friday afternoon, Torab's wife Sohagi, son Saddam, daughter Sabina and son-in-law Monirul beat him mercilessly as he again refused to hand over the property, said Amir, who filed a murder case accusing the four yesterday. In a critical condition, locals took Torab

In gross violation of government rules, several tobacco companies have continued advertisement of their products at different public places in the district, much to the worry of health conscious people.

During a recent visit, this correspondent saw four or five workers of Dhaka Tobacco Industries sitting under an umbrella beside a betel shop at Nekmarad Haat in Ranishankoil upazila of the district.

They were seen describing the 'merits' of smoking Briton brand of cigarette and offering it to people, especially younger ones, take the taste.

Those who showed interest to buy a packet after smoking it were given an extra packet as incentive.

"I don't know about any prohibition on advertisement for promotion of cigarettes. As per instructions of our high officials, we are doing it as part of job," said Michael Islam, a worker of the company.

"We only offer cigarettes to the smokers. Other tobacco companies do

various ways," said Md Sharif, another
