Two killed, 30 injured in road crashes

A seven-year-old girl was killed and 20 people were injured as a bus fell into a ditch beside Goshaibari-Dhunat road in Bakshapara area of Dhunat upazila in Bogra yesterday.

The deceased was Amena Begum, daughter of : Aminul Islam of Mollikpur Char in the upazila. She died on the spot, said police.

Mizanur Rahman, officer-in-charge of Dhunat Police Station, said the bus was seized and the injured were sent to hospitals.

In Natore, a man was killed on the spot and 10 others were injured as a bus turned turtle and fell into a ditch beside Baraigram-Lalpur road in Kalikapur area of Baraigram upazila.

The deceased was Bachchu Mian, 35, of Bamnia village in Nilphamari.

Tk 70 lakh robbed, recovered after 7hrs

Muggers looted Tk 70 lakh from two accounts officers of Unilever Ltd's Sylhet depot after wrecking their car at Kaher Miah Goli in Sylhet city yesterday.

Police recovered the money after over seven hours from North Baluchar in the city and arrested two muggers from the spot.

Police said some muggers stopped the car while the accounts officers were taking the money to EXIM Bank in Zindabazar from their depot located at Amberkhana Barabazar.

The criminals snatched away the money from them after wrecking the vehicle and fled on four motorcycles and a CNG-run auto-rickshaw.

On information, police conducted a drive in North Baluchar and recovered the money around 7:30pm. Some local weapons were also recovered from the spot, said Rahmat Ullah, additional deputy commissioner of Police.

Sohel Ahmed, officer-in-charge of Kotwali Police Station, said they have a special security service to help carry large amount of money, but the accounts officers did not ask for it.

Earlier, four people were detained in this connection, he added.

Meanwhile in another incident in Zindabazar area, muggers on four motorcycles waylaid a businessman who was carrying Tk 4 lakh. However, the criminals could not snatch the money as the businessman started screaming and the place was crowded.

The muggers left two of their motorcycles on the spot while fleeing. Police seized the motorbikes, said the OC.

Accelerate case disposal unitedly: President

Hamid went on saying, "As a lawyer I want to make you a request. And the request is each lawyer will take a case of at least one insolvent and helpless person every year. You'll see the society getting changed through the activities and general people will be more respectful to law."

Meanwhile, mentioning that Bangladesh is a country of communal harmony, President Abdul Hamid, at another programme the same day, called upon the young generation to move forward upholding this image. Hamid was addressing the second convocation of

Some 1,486 students received degrees at the convocation while 43 were awarded for their outstanding performance.

ARSON CASE 22 BNP men face arrest warrants

A Dhaka court yesterday issued arrest warrants against 22 BNP leaders and activists, including Barkatullah Bulu and Shamsur Rahman Shimul Biswas, in a case filed over an arson attack on a pickup van in the capital's Shantinagar on February 13 last year.

Former BNP lawmaker Syeda Ashifa Ashrafi Papia, BNP leaders Maruf Kamal Khan, Khairul Kabir Khokon, former BNP ward councillor Md Qayum are among the other accused in the case.

After accepting the charges against 30 including the 22 accused, the court passed the order showing them fugitives.

The court directed officer-in-charge of Paltan Police Station to submit by January 22, 2017 reports on execution of arrest warrants against the fugitives.

The government on November 2 last year suspended Moniruzzaman for being charged in a criminal case.

The HC on June 7 stayed the suspension order following a writ petition. Then the government filed the petition with the SC.



EXPLOSIVE CASE Suspended mayor Ariful gets bail

The High Court yesterday granted bail to suspended Sylhet City Corporation mayor and BNP leader Ariful Haque Chowdhury in an explosive case, paving the way for him to walk out of jail.

Ariful secured bail in the case filed under the Explosive Substances Act-1908 over the killing of former finance minister Shah AMS Kibria.

HC passed the order after hearing a bail petition filed by him, Deputy Attorney General Md Bashirullah told The Daily Star, adding that the government will move a petition before the Appellate Division of the Supreme Court seeking stay on the HC order. If the HC order reaches the jail authorities before the apex court passes any order on the government's stay petition, Ariful will get released from jail, the DAG said.

Kibria and four others were killed in a grenade attack on a rally in Habiganj on January 27, 2005. Two cases -- one for killing and the other for blasting bombs -- were filed in connection with the incident. Earlier on September 6, Ariful got bail from the HC in the murder case.
