Deadly clash kills 4 in Narsingdi

Two rival groups backed by former, current UP chairmen fight over supremacy; 50 hurt; houses torched, vandalised

STAR REPORT

At least four people were killed and 50 others injured yesterday in a string of fierce clashes between the supporters of current and former union parishad chairmen over establishing supremacy in a remote char of Narsingdi's Raipura upazila.

Armed with crude bombs, spears and other lethal weapons, the feuding groups clashed several times since morning at Amirabad and Sonakandi villages in Nilokkha Union.

At least 10 houses were vandalised and six more torched in the two villages.

Law enforcers brought the situation under control last night.

The dead were identified as Manik Mia, 40, and Shahjahan, 40 of Amirabad village, and Khokon, 35, and Rakib, 16, of

Sonakandi village.

All four were known as supporters of former UP chairman Abdul Haque, according to locals.

However, it was still unclear how they were killed.

Of the injured villagers, three were brought to Dhaka Medical College Hospital with pellet wounds.

When police tried to disperse the supporters of the two groups, a tripartite clash

Some supporters of the two groups exploded crude bombs, leaving five policemen, including the OC of Raipur Police Station, wounded, according to police.

Azharul Islam Sarkar, 48, officer-incharge of the police station, was whisked off to a local hospital. He was later shifted to SEE PAGE 2 COL 1

Police yesterday took off the handcuffs of three injured Santal men who were arrested in a case over the November 6 clash in · Gaibandha's Gobindaganj, : hours after the High Court directed the police to imme diately free them from handcuffs.

Choron Soren, Bimal Kisku and Dijen Tudu are now undergoing treatment · at two hospitals in Rangpur and Dhaka.

Choron, 52, and Bimal, · 38, were hit by bullets in their legs and were admit-: ted to Rangpur Medical College College Hospital · (RMCH) on November 6, while 36-year-old Dijen was referred to National Institute of Ophthalmology · in Dhaka with eye injuries.

The HC yesterday also asked the Dhaka Metropolitan Police (DMP) commissioner, deputy inspector general (DIG Rangpur) of police and Gaibandha superintendent of police (SP) to submit a report to it by November 16 after complying with the order.

Quick action Tk one lakh bounty on B'baria arsonists

Brahmanbaria police yesterday announced Tk 1 lakh bounty for information that would help them arrest the criminals responsible for the recent arson attacks on houses and properties of the Hindus.

Daily Star ran a report on the matter on November 7.

The declaration came after unidentified criminals set fire to at least eight Hindu houses in four separate incidents in Nasirnagar Sadar union since November 3.

The office of superintendent of Brahmanbaria police made the announcement at different parts of Nasirnagar upazila through loudspeakers, SP Mizanur Rahman told The Daily Star.

On October 30, religious bigots in a synchronised attack vandalised and looted over 100 houses and at least 17 temples in Nasirnagar centering a Facebook post allegedly by Rasraj Das hurting religious RELATED STORY ON PAGE 2 SEE PAGE 2 COL 3
