Bamboo ladders set to make bridge usable!

Believe it or not, villagers use bamboo-made ladders to get on a bridge on the Kharia river in Phulpur upazila of the district, as it has remained without approach road for a year. A large number of people of Rambhadrapur, Singimari,

Rehai Tarapur, Char Bahadurpur, Char Neamot, Boithamari, Mohishmari, Senerchar, Debuarchar, Sikderpara and Char Bosonti villages regularly use the bridge at Rambhadrapur. "The bridge is too small compared to the river's width

and so, it becomes useless in the rainy season. During the dry season when the river gets narrow, thousands of people including students somehow use the bridge with the help of ladders," said Md Rokunuzzaman Rukon, chairman of Rambhadrapur union parishad.

"We have sent proposal for extension of the bridge to cover the whole breadth of the river," he said.

"Due to lack of bridge that hampers communication with upazila and district headquarters, we cannot get reasonable prices of our agricultural produces," said Adam Ali, a farmer of Rambhadrapur.

Asked why the 40-foot-bridge was constructed over some 200-foot-wide river, Md Zakir Hossain, project implementation officer of Phulpur, said there was a proposal for a 60foot-bridge but the 40-foot-long bridge was approved and constructed due to fund constraints. Work of the approach road could not be completed due

to the same reason, he said, adding that they would start the work yesterday [Tuesday] to complete the bridge's approach road soon.

93 passports seized

Detective Branch (DB) of Police arrested an alleged passport broker along with 93 passports and huge copies of official documents from Rajbari district town on Monday. The arrestee, Nitai

Kundu, 56, son of Orbinda Kundu, is a resident of Khankhanapur area in Rajbari Sadar upazila.

Sub-inspector Kamal Hossain of Rajbari DB police said a team of detectives, acting on a tip-off, conducted a drive at Nitai's house around 4:30pm and arrested him.

During the drive, the law enforcers also seized 93 passports, several passport forms, birth certificates, national identity cards (NID) and other necessary documents from the possession of the arrestee, SI Kamal said.

Quoting the arrestee, police said Nitai is a member of a broker gang, which illegally prepares passports for the passport seekers with the help of some corrupt employees and officials of Rajbari Regional Passport Office in exchange of money.

Fraud swindles job seekers

Thakurgaon NGO aids in trapping 245 unemployed youths

A fake job provider of Dinajpur has gone into hiding after cheating at least 245 jobseekers of Tk 25-30-lakh through a local NGO in Ranishankoil upazila of Thakurgaon. Selina Islam alias Dr Selina of

Dinajpur took Tk 25-30-lakh from the jobseekers through NGO Uttaran Samaj Seba Sangha of Katihar village in Ranishankoil upazila, in the name of providing job in a project under the Ministry of Social Welfare, said cheated jobseekers and NGO officials. "In last March, the woman came

to my office and impersonated herself as Dr Selina, executive director of Bangladesh Karigori Proshikkhan O Jubo Maan Unnayan Kendra of the Ministry of Social Welfare," said Subrata Bihary, director of Uttaran Samaj Seba Sangha at Katihar village in Ranishankoil.

"Selina told me that she would implement a Tk 1,500 crore project in Ranishankoil upazila and a good number of employees would be recruited for the purpose."

"When I asked her to show the project papers, she said those were kept with the deputy commissioner of Dinajpur as her organisation was jointly implementing the project with the district administration," he said.

Afterwards the matter of huge ager' with a high salary, said, "As per

employment opportunity was circulated in the village and its adjacent areas and Dr Selina gave appointment letters to 245 jobseekers from the NGO office within a month. The appointment letters signed

by 'Dr Selina, executive director of Social Welfare Ministry, Golapbag, Dinajpur' asked the applicants to join social welfare offices in different unions of the district but there are no such offices at the union level. Each of the applicants who got

the appointment letter had to give Tk 5,000 to Tk 20,000 as security deposit but they were not given any receipts against it, said the cheated jobseekers who are yet to start work, let alone receive any salary. Md Shahin Hossain, a youth of

Bolidara village in Ranishankoil upazila, got appointment as a field worker and his monthly salary was mentioned as Tk 16,000. "I deposited Tk 15,000 to get the

job. But they have not started the project's activities yet. I was asked to join the upazila unit office of social welfare ministry at Baliadangi. But there is no such office here," he said.

Many others, who got appointment under the so-called project, are in the same boat now.

Subrata Bihary, who himself also got appointment as 'regional man-

Selina's instruction we supplied manpower to her. But the project's work has not started after seven months of giving appointment."

As the jobseekers put pressure on us to return the deposit money we contacted with Selina and she gave us a cheque worth Tk 40-lakh of Janata Bank in Dinajpur branch on October 27. We went to the bank on November 1 but the cheque was bounced as the account had a small amount of money.

Deputy Director of Social Welfare Directorate, Dinajpur, Stiffen Murmu said following a number of allegations of cheating in the name of giving jobs in Dinajpur and Rangpur areas, we initiated action against Dr Selina and she went into hiding.

Deputy Director of Thakurgaon Social Welfare Directorate Sardar Tariqul Islam said they will take action against the local NGO as the fraud woman cheated people through it.

Contacted, Ranishankoil Upazila Nirbahi Officer Khandakar Md Nahid Hasan told this correspondent over cell phone, "I am yet to get any complaint. The upazila administration will take action against the frauds if complaints are failed."

The fraud woman could not be contacted despite making repeated calls to her cell phone.

Stalked schoolgirl ın trauma

Fails to attend JSC exam

A Junior School Certificate (JSC) examinee could not sit for the mathematics examination due to abuse by a stalker on way to her examination centre in Sarishabari municipality of the district on Sunday.

The girl, 14, daughter of a poor farmer in the area, went out of her house to sit for the mathematics examination at Reaz Uddin Talukdar High School centre in the morning that day. On the way, Golam Mostafa, 32, son of Ayen Uddin

Mondal of Bolardiar village under the municipality, waylaid her and gave an illicit proposal around 9:30am As the girl boldly protested, Mostafa turned crazy and

started pulling her to his house, a few yards from the spot, said locals. Hearing her screams, locals rushed to the spot and rescued the girl while the culprit fled away, said Nurul Islam

Sheikh, a resident of Bolardiar village and councillor of the municipality. Humiliated and traumatised, the girl returned to her house instead of attending the examination, said the coun-

Mostafa, a married man, had been stalking the girl on way to and from her school in the area for about two months, said the victim's family members.

"We have already come to know the matter and are investigating it. If complaint is lodged with the police station in this regard, we will take stern action against the culprit," said Rezaul Islam Khan, officer-in-charge of Sarishabari Police Station.

The victim's family is preparing to file a case against the stalker with Women and Children Repression Prevention Court in Jamalpur, said the victim's father.

Cattle trader shot dead by BSF

of Panchraki village in the upazila. Moslem's father-in-law Babar Ali said Indian border guards at Khalisha camp opened fire on a group of


cattle traders when Moslem along with 4/5 others were returning home through the border. Moslem died on the spot

FARM LABOUR IN LALMONIRHAT

Women denied fair wage

Women farm labourers in the district are being deprived of their right to get the same wages as male labourers.

Women farm labourers said they get Tk 120-130 per day whereas a male labourer gets Tk 300-350 per day. They do the same work as male labourers, sometimes even more, but they are not given fair wage, they added.

"We work like male labourers, but we are paid less than 50 percent of what male labourers get," said Anjoli Rani, 36, of Chaklarhat village under Kaliganj upazila. "We are forced to work for low wages as there is no opportunity to get job in the village," she added.

"We start working in the crop field at 8:00am and end at 5:00pm everyday, with only half-an- hour break for lunch," said Hamida Begum, 42, of Chandrapur village.

Farmer Delwar Hossain said he hires women labourers as they are paid low wage and do not avoid their duty.

Khet Majur Mahila Samity President Noor Jahan Begum said many women farm labourers earn their livelihood working in the crop fields everyday, but they are afraid to demand wages equal to a male labourer's. "Our organisation is trying to unite women farm labourers against wage discrimination," she added. Women farm labourers urged the authorities concerned to fix daily wage for them.

Rumi Begum groans in pain at hospital

Victim of inhuman torture by husband and his family members, a woman is groaning in pain at Jaldhaka Upazila Health Complex in the district. She is Rumi Begum, 25, daughter of Mokbul Hossain of

Gopaljhar village in the upazila. Several injury marks caused by beating were found on her arms, legs and back and there was blood clotted in some parts of her body, said Dr Rupayan Das of the

hospital. Rumi's mother Morsheda Begum said her daughter married Moidul Islam, 28, son of Abdus Sattar of Sholmari Kamar para village in 2009.

After the marriage, Moidul and his family members often tortured Rumi for Tk 5 lakh as dowry, she alleged.

"On Sunday, my father-in-law and uncle-in-law held my hands and legs tightly and Moidul, his mother and sister beat me mercilessly the whole day as I refused to bring money from my father," said Rumi at the hospital bed yesterday.
