Dhaka to act for positive change

With Bhutan parliament's upper house rejecting the BBIN motor vehicle agreement last week, Bangladesh is set to hold negotiations and take up diplomatic efforts as it expects the country to hold internal consultations to change its decision.

Additional Secretary to the road transport and bridges ministry Belayet Hossain informed of Dhaka's plans talking to The Daily Star.

"Of course the process...will be delayed...but we are hopeful for operationalisation of the agreement soon," high government officials said yesterday. India's external affairs ministry also stated that they were also hopeful.

A senior foreign ministry official said Dhaka was yet to receive any formal letter from Bhutan regarding its decision.

Transport ministers signed the Bangladesh-Bhutan-India-Nepal (BBIN) agreement in Thimphu in June 2015 for the seamless movement of passengers and cargo vehicles across the territories.

A joint statement said 30 transport corridors would become economic ones, potentially increasing intraregional trade by almost 60 percent and with the world by over 30 percent. The countries mapped out a six-month action plan

scheduled to begin in July 2015. But the process was delayed due to internal procedures.

The infrastructures would require an estimated \$8 billion, with each government catering to their own territory with donor agencies' support.

Fakhrul urges govt STAFF CORRESPONDENT

yesterday called upon the government to hold talks on forming an "acceptable" Election Commission (EC) on the basis of the party chief Khaleda Zia's proposal.

"The government should take our chairperson's proposal positively. It has paved the way for holding talks," said Fakhrul.

He was addressing a discussion marking BNP Senior Vice Chairman Tarique Rahman's 51st birth anniversary, at the Institution of Engineers,

Bangladesh in the capital. On Friday, Khaleda proposed a set of recommendations to the formation of a new EC in consensus with all the political parties involved, with the current commission's ten-

ure nearing its end. Her proposals included bringing a change to the Representation of the People's Order (RPO) to strengthen the EC and constitute a "search committee" to select the next election commissioners.

The ruling Awami League (AL), however, rejected Khaleda's proposals.

The ruling party rejected the BNP chief's call for forging unity after the Gulshan attack, and it did the same in connection with the proposals to form the new EC, said Fakhrul, adding that Khaleda put forward the proposals to

Development experts have suggested engaging and empowering local government institutions and communities to achieve the Sustainable Development Goals (SDGs) set by the UN late last year for the period of 15 years. SDGs aim to maximise

the economic benefits for all and making them environmentally sound and socially just, said Dr Atiq Rahman, executive director of Bangladesh Centre for Advanced Studies (BCAS), addressing the inaugural session of a national consultation.

NHRC CHAIRMAN FOR TWO TERMS HC questions legality Bodi's bail of appointment

The High Court yesterday questioned the legality of Kazi Reazul Hoque's appointment as chairman of the National Human Rights Commission (NHRC) for two terms.

The court also issued a rule asking Reazul to explain in four weeks under what authority he has been holding the office of NHRC chairman. The HC bench of Justice Quazi Reza-Ul Hoque and

Justice Mohammad Ullah came up with the rule following a writ petition filed by Supreme Court lawyer Eunus Ali Akond. He submitted the petition on November 9 saying

Reazul's appointment is a violation of relevant provision of the National Human Rights Commission Act, 2007. According to section 6 (3) of the law, a person cannot be appointed as member of the commission for more than two terms. Reazul was earlier appointed as a NHRC member for

two terms, he said in the petition. A chairman of the commission is also its member, he

Produce four prisoners serving without trial: HC

The High Court yesterday issued a rule asking the government to explain why four prisoners, who have been serving in jail without trial for years, should not be granted bail in murder cases.

Issuing a suomoto rule, the court ordered the jail authorities to produce the four under trial prisoners -- Chan Miah, Makbul Hossain, Sentu Kamal and Billal Hossain, who are in Kashimpur jail, before it on December 4 for hearing their statements. Of them, Chan Mia has reportedly been

serving in prison for 18 years, Billal for 17 years and Mokbul and Sentu for 16 years in connection with separate murder cases. The HC bench of Justice M Enayetur Rahim

and Justice JBM Hassan also called for the records of the cases from the lower courts concerned as they were not settled for a long time. The judges came up with the rule and

order following a November 16 report of a private television channel about sufferings of the four in jail and state of the cases.

Supreme Court lawyers Aynun Nahar

Siddiqua and Cumar Debul Dey placed the

TV report before the HC judges seeking necessary orders.

According to the report, Chan Miah has been in Kashimpur jail since 1999 in a case, which is pending with Paribesh Appeal Adalot (Environment Appellate Court) in Dhaka. Makbul Hossain from Madaripur was arrested in 2000 in a murder case, which

is pending with a Dhaka court. Sentu Kamal from Motijheel AGB Colony was arrested in 2001 and was produced before the Special Judge's Court-3 of Dhaka last month. Billal Hossain from Comilla has been suffering in jail since 2002 in another case, which is now pending with another Dhaka court.

The same HC bench on November 8 this year had granted bail to one Shipon, who was imprisoned for about 17 years in a murder case without any trial.

The Supreme Court Legal Aid Committee on November 16 sent letters to the jail authorities across the country asking them to provide information about the under trial prisoners for providing legal assistance to poor prisoners.

7 lakh Yaba pills seized

Border Guard Bangladesh seized nearly 7 lakh Yaba pills, worth over Tk 20 crore, from a boat in Teknaf of Cox's Bazar early yester-No one was arrested

during the drive as the Yaba traffickers had fled the scene before the BGB personnel arrived, said Lt Col Md Abu Zafar Zahid, commander, 2 BGB Battalion in Teknaf.

The boat was carrying 6,91,104 Yaba pills at Alugula project area in Teknaf through Naf River. "The traffickers jumped

to the shore from the boat sensing our presence and fled to Kewra forest," the commander said, adding that a case was filed.
