Rid Pharma case verdict

Nov 28 COURT CORRESPONDENT

Judgment in the case filed against five officials of Rid Pharmaceuticals Ltd over manufacturing toxic Paracetamol syrup that claimed at least 28 children's lives will be delivered on November 28.

The accused in the case are Rid Pharma Managing Director Mizanur Rahman, directors Sheuli Rahman, who is Mizanur's wife, Abdul Gani and Rid's pharmacists Mahbubul Islam and Enamul Haque.

Of the accused, Mizanur Rahman and his wife Sheuli Rahman are now on bail while the rest three are at large.

The children died of renal failures, caused by intake of Rid's Paracetamol syrup and suspension, across the country from June to August of 2009.

After completion of

arguments from both the

prosecution and the defense, Judge M Atoar Rahman of the Dhaka Drug Court yesterday set the date for delivery of the case. Earlier the court

recorded statements of five prosecution witnesses including complainant of the case. Earlier on August 10,

2009, the then drug superintendent Shafigul Islam filed the case with the Dhaka Drug Court against them.


Four more cases were filed against them in Brahmanbaria, Comilla, Narayanganj and Sylhet.

In his complaint, Shafiqul Islam said several children died at Shishu Hospital of Sher-e-Bangla Nagar in the city due to renal failure after intake of the paracetamol drugs of Rid Pharma.

He said the government realised the seriousness in the matter and published advertisements in national dailies asking all not to take any drug manufac-

tured by the company. On July 22 of 2009, the Drug Administration sealed

Huge workers die at work for Why CrPC provision lax compliance with laws

Says report mentioning that 3,400 killed in last 5yrs

More than 3,400 workers have died in workplace accidents since 2011 for various reasons, including lack of compliance of laws by owners and proper monitoring by the government agencies at factories, according to a report unveiled yesterday.

Of them, 341 workers died between January

and October this year, while fire incidents claimed lives of 62 workers, said the report released by two rights NGOs--Safety and Rights Society (SRS) and BLAST. The report, based on news published in 26 newspapers, was launched at a press confer-

ence at Dhaka Reporters' Unity, marking the fourth anniversary of the Tazreen Fashions fire that killed at least 112 workers on November 24.

A Dhaka court last year framed charges against 13 people, including the factory's two owners, in a case over the fire.

"We are yet to see exemplary punishment for those responsible for the workers' deaths...We cannot term them accidents. These are planned killings," said Wajed-Ul Islam Khan, general secretary of Bangladesh Trade Union Centre (BTUC), demanding that those who are responsible for such deaths be tried under a speedy tribunal.

The report also said 373 workers died between 2011 and 2015 in fire incidents at garment, plastic, chemical, blanket, tannery, footwear, steel-rerolling and rice factories and in other small as well as medium

industries, and that 45 workers died in the Tampaco Foils factory disaster at Tongi in September this year.

SRS said workers continue to die at an alarming level, and the death toll increased this year compared to that last year. "The government, owners and buyers

have taken steps to ensure workplace safety

at garment industries. But we have not seen any such step to ensure safety and security in other sectors," said SRS Executive Director Md Sekender Ali Mina, who claimed to have found 1,316 workplace accidents during the period. In most cases, the victims' families have

not been given compensation stipulated in the Bangladeash labour law, he mentioned.

"The issue of ensuring workers' safety is not given due importance since the workplace deaths are not regarded as a major offence...," alleged the SRS official.

The report also said 226 workplace accidents took place in the last 10 months, with manufacturing and construction sectors accounting for 37 percent and 31 percent of the accidents respectively. The rest occurred in service and transport sectors.

Electrocution and fire are the main causes of their death, identified the report that suggested ensuring safety and security in all sectors.

It also recommended ensuring accountability of the agencies, including factory inspection offices responsible for monitoring and implementing the law.

HC asks govt authorities

The High Court yesterday issued a rule asking the government authorities concerned to explain in two weeks why they should not be directed to take necessary steps to prevent police from abusing section 160 of the Code of Criminal Procedure (CrPC).

The rule came following a November 17 writ petition of one Ashish Kumar Sharma, managing director of Cactus Packaging, a garment factory in Gazipur.

Ashish challenged the legality of a notice sent to him on November 12 by a sub-inspector (SI) of the detective branch of police in Gazipur, Motafizur Rahman Chowdhury.

asking Ashish to appear at his office on November 19 with relevant papers and evidence concerning a written complaint. The complaint was filed by one Md Oli Ullah, owner of Step International, over Tk 31.90 lakh Ashish owed to him

In it, SI Motafizur stated that, as per the CrPC section, he was

centring supply of garment accessories, says the letter. Ashish stated that SI Motafizur abused power given to police under the CrPC section by summoning him

although no case or general diary (GD) had been filed. Talking to The Daily Star, his lawyer Uzzal Hossain explained that police, for the sake of investigations, can call a witness if either a case has been filed under the CrPC section

or permission has been taken from a magistrate following filing of a GD. Moreover, Ashish is an accused, not a witness, and so the letter was sent with malafide intent and is a form of abuse of

power and unlawful, he said. The HC also summoned SI Motafizur on December 4 to explain the letter.

In the rule, the bench of Justice Quazi Reza-Ul Hoque and Justice Mohammad Ullah also asked the authorities to explain why the letter should not be declared illegal.

The home secretary, inspector general of police, superintendent of police of Gazipur, officer-in-charge of the detective branch of police in Gazipur and SI Mostafizur have been made respondents.

Quoting locals, police said Jewel took Yasin to a secluded place beside the slum and tried to sexually abuse him. As the boy tried to resist,

Jewel hit his head against a wall, killing him instantly, said police. Bedenunnesa found the blood-stained body
