# DSCC demolishes 100 makeshift structures

Dhaka South City Corporation (DSCC) yesterday demolished around 100 illegal makeshift structures on footpaths in the Hatirpool kitchen market and its adjoining areas, and in Paribagh yester-

DSCC executive magistrates Abu Sayied and Mamun Sarder led the drive.

Sayed said they conducted the drive to clear the footpaths and will continue to do

Meanwhile, the DSCC purchased a cold recycling asphalt mixing plant and a cold milling machine to modernise road construction, reduce reconstruction

costs and maintain proper level of height of a road.

The modern plant will reduce the costs of road repairing work by around 40 percent, said Anisur Rahman, project director of the "road development work using cold recycling system."

The plant is also environmentally conducive and will reduce carbon emissions by 98 percent, he mentioned, adding that it will not produce any dust and smoke when running.

Repeated development work causes a steady increase in the height of roads, which in turn contributes to waterlogging. But the plant would help maintain the roads' proper height, Anisur observed.

## Tribunal records testimonies of 22nd witness

The International Crimes Tribunal-1 yesterday recorded testimonies of the 22nd prosecution witness in a case filed against two Kishoreganj men, who are facing six charges of crimes committed during the 1971 Liberation War.

Anisur Rahman, a librarian of the tribunal's investigation agency, revealed some documents that were seized by the investigation officer of the case and were in Anisur's custody.

The accused are: Syed Muhammad Hussain alias Hossain and Muhammad Moslem Pradhan.

Moslem is now in jail and pleads not guilty, while Hussain is on the run.

The three-member tribunal led by Justice Anwarul Haque adjourned the case proceeding until December 6 after the defence counsel had completed cross-examining Anisur.

The investigation officer and also the last prosecution witness in the case will give testimony on December 6, said prosecutor Tapos Kanti Baul.

area of Brahmanbaria district following the death of children who tool the drug.

The government also formed a seven-member probe committee to investigate the matter. On July 29 the same year, the probe committee placed its report that found the presence of poisonous diethylene glycol in the paracetamol syrup of the company. Rid Pharma used diethylene glycol, meant for tannery

and rubber industries, instead of propylene glycol as diethylene glycol costs Tk 200 per litre while propylene glycol costs Tk 1, 100.

Later, the government has banned two drugs of Rid Pharma -- Ridaplex (vitamin B-complex syrup) and Temset (paracetamol suspension) for their sub-standard quality and harmful effects on public health.

Manufacturing, marketing, preservation, use and sale of the two drugs have also been banned in the country.



Indictment hearing in arson case against Khaleda deferred COURT CORRESPONDENT

A Dhaka court yesterday deferred to December 1 the hearing on charge framing against BNP Chairperson Khaleda Zia and 37 others in a case filed over an arson attack on a passenger bus in Dhaka's Jatrabari on January 23, 2015. The attack left one killed

and 30 others injured. The court gave the order

after Khaleda's lawyer submitted a petition seeking adjournment of the hearing. In it, the lawyer said

Khaleda, now on bail,

could not appear before the court yesterday due to illness. BNP leaders Amanullah Aman and six others, now

on bail, were present yesterday. On May 6 last year,

detectives submitted two charge sheets -- one for murder and another for explosions -- against Khaleda and the 37 people.

A day after the attack, Jatrabari police filed two cases against 68 BNP and Jamaat-e-Islami leaders.

Sheikh Hasina, who is also in-charge of the Ministry of Defence, said she is delighted after distributing identity cards among the armed forces gallantry award-winning freedom

Using the identity cards, she said, they can enjoy facilities of free travel on trains, BRTC buses and Bangladesh Inland Transport Corporation ferries. The prime minister said they are also entitled to travel on

international routes of Bangladesh Biman once a year and travel in the same airlines for performing Hajj/Umrah once in a lifetime. They can also use VIP lounges of the airports as well as VIP rooms and cabins of ferries.

Besides, she said, they could enjoy medicare facilities using the identity cards.

At the function, the prime minister presented honorarium cheques, and gifts including "shawls" and mobile tabs to the successors of seven Birshreshthos as well as other gallantry award-recipients.
