Shakhawat Hossain Bhuiyan, a Jubo League leader of Feni, filed the petition as public interest litigation with the HC on June 8, 2014 praying to declare Nizam disqualified for contesting the parliamentary polls and his holding office as a lawmaker for his alleged forgery in getting early release from jail in a criminal case.

Quoting a newspaper report, Shakhawat in his petition said a Chittagong court had sentenced Nizam to 10 years' imprisonment in an arms case on August 16, 2000.

He surrendered to the court on September 14, 2000, and was sent to a Chittagong jail to serve his

But he was in jail for only five years and was released on December 1, 2005, through fraudulence, Shakhawat said.

He said Nizam was supposed to be in jail until September 13, 2010.

Meanwhile, Nizam's lawyers opposed the petition saying that their client had served the entire term of the jail sentence and therefore, the petition was filed for personal interest of the petitioner and it should be rejected.

## 24-hr monitoring necessary

Says Population Council study

Constant monitoring is a must to ensure 24-hour service delivery of the union health and family welfare centres (UHFWC), says a non-government study.

Women must be made aware as the UHFWCs are the primary institutions to provide normal delivery facilities in rural areas, said the study conducted by Population Council at 24 UHFWCs of eight upazilas in Chittagong and Munshiganj.

The study was carried out to evaluate the impact of a project "Strengthening Union Health and Family Welfare Centers for Providing round-the-clock Normal Delivery Services", starting October 2014, funded by UKaid and supported by the Ministry of Health and Family Welfare of Bangladesh.

Population Council organised a dissemination seminar at Spectra Convention Centre in the capital's Gulshan yesterday to make the study public.

"The government has more than 1,500 UHFWCs across the country but those do not have enough capability to provide round-the-clock delivery services. That's why we ran the project to strengthen the service," Noorunnabi Talukder, monitoring and evaluation adviser of Population Council, said while

presenting the research outcomes.

The project helped to create awareness among the rural women about child delivery services which is very important for safe births. Awareness has been increased by around 36 percentage points in Chittagong and by 31 percentage points in Munshiganj.

Speaking as the chief guest, Director General at the Directorate General of Family Planning (DGFP) Mohammad Wahid Hossain said the UHFWCs' services can be improved through increased manpower and infrastructural developments.

A change of social and cultural mindset is also needed to accept child delivery services, that ensure safety of mother and the newborn child, he said.

Dr Jahid Uddin Ahmed, head of midwifery education programme at Brac University, said the government needs to recruit more midwives at union health centres to widen its services.

Dr Mohammad Sharif, director (maternal and child health) at the DGFP; Dr Ubaidur Rob, country director, and AKM Zafar Ullah Khan, senior policy adviser of Population Council, and Dr Fahmida Sultana, a deputy director at DGFP, also spoke.

Two to die

A Dhaka court yesterday sentenced to death two youths for killing a 68-year-old widow and her 12-year-old domestic help at her north Jatrabari's Kalapatti flat in March 24, 2015.

Sayeed Howlader confessed that he and his friend Riaz Nagarali killed the domestic help, who is his sister Kalpana Akhter, after she saw him killing Raushan Ara, wife of former additional police superintendent Abdul Kuddus.

Judge Abdur Rahman Sardar of the Speedy Trial Tribunal-4 of Dhaka passed the verdict.

Raushan's brother filed a case alleging that several persons whom Kalpana knew might be involved. On March 26, Jatrabari police arrested

Sayeed at Shahjahanpur and seized a cellphone and Tk 1,400. Reaz was arrested based on Sayeed's confession. Kalpana and her mother Lucky Akhter

worked at Raushan's flat.

Sayeed said he and Riaz demanded Tk 10,000 from Raushan on the day of the murder. An argument ensued and they slit her throat after she denied to give it, he added.
