The government yesterday honoured top taxpayers at the national level for depositing the highest amount of taxes to the state coffers in fiscal 2015-16 -- a practice expected to spur others to be just as compliant.

Some 141 taxpayers, including 76 individuals, were given tax cards and crests as recognition for their exemplary compliance.

Separately, the NBR awarded 370 highest taxpayers at the district level and 147 long-time

National Board of Revenue at its new headquarters at Agargaon in Dhaka. The ceremony also marked the beginning of Income Tax Week (November 24-November

30), introduced by the NBR for the first time this year to provide better services to individual taxpayers and assist them to file tax returns ahead of the November 30 deadline.

"I'm very happy that our efforts and achievements are being duly recognised, not only for banking services but also for our contributions to the national exchequer," said Abrar A Anwar, CEO of Standard Chartered Bangladesh, one of the top taxpayers. Standard Chartered is the oldest bank with a history of 111 years and is the largest foreign bank in Bangladesh.

"It's really a good feeling to be honoured by the government," said Sultan Mahmud after receiving an award as a new taxpayer. Mahmud, owner of Shaha Enterprise, a clearing and forwarding agent, said the recognition increases his responsibility.

card for paying the second highest amount of tax in his profession.

"I cannot only demand from the state -- I have responsibilities too. I have to pay taxes from my honestly earned money so that the state can work for all," Nandi said.

This is the first time Nandi has got recognition as one of the highest taxpayers under the NBR's newly expanded tax card policy.

Since fiscal 2010-11, tax cards were given in only two categories -- individuals and companies -- with 10 tax cards for each to encourage compliance in the country where less than 1 percent of the population file returns and tax avoidance is believed to be high.

As the total number of tax cards was restricted Mahmud along with other top taxpayers to 20, many taxpayers were left out of the hon-

Every solvent citizen should pay income tax, which is needed to boost economic growth, said BSRM Group Director Tehseen Zohair Taherali, who was awarded as the highest female taxpayer under the Chittagong City Corporation.

In Chittagong division, the second biggest engine of the economy after Dhaka, the NBR honoured 41 top taxpayers in four categories.

"Income tax payment is a matter of heroism," said Muhith at the programme in Dhaka, adding that the person who pays tax plays a role in national development.

Given the increased participation in tax fairs and bigger collections, taxpayers no longer consider compliance with tax rules to be a hassle, except for a few cases, he said.

Robi profit nosedives 98pc in Q3

Mobile operator Robi's net profit slumped 98.41 percent to Tk 1.76 crore in the third quarter of the year as its drawn-out merger with Airtel continues to weigh heavy on its earnings.

The merger finally took effect last week although the announcement came in September last year. The company paid Tk 318 crore to the regulator last week as partial merger fees and charges. In the third quarter, Robi's revenue rose 11.5 percent from a year earlier to Tk 1,390 crore.

"We experienced solid mobile revenue growth during the third quarter of 2016," Mahtab Uddin Ahmed, chief executive officer of Robi.

But the decline in customer base following biometric registration and network modernisation also impacted Robi's third-quarter profits, said officials.

Robi invested Tk 290 crore in the third quarter for network expansion mainly focusing on the Chittagong-Comilla region, which is known as the stronghold of the company. It lost around 30 lakh active mobile subscribers in the July-September because of biometric registration.

The deactivation of non-compliant SIMs after May 31 has negatively impacted the growth momentum of business, according to the Robi CEO.

Robi witnessed a loss of Tk 3.42 crore in the second quarter of 2016 after thirteen consecutive quarters of net profit; it bounce back again in the third quarter.

Worker leaders demand punishment for Tazreen Fashions owner

Trade union leaders yesterday again demanded exemplary punishment for the owner of Tazreen Fashions as 113 workers of the factory were killed in a fire mainly due to his negligence.

The fire that burned down the factory in Ashulia four years ago also injured more than 200 workers.

The Tazreen Fashions fire was not an accident but a killing incident due to the negligence of its owner Delwar Hossain, the union leaders said in a statement. The leaders addressed the surviving

victims and dependants at a token sitin programme in front of the National Press Club.

Hossain is now out of jail as the High Court granted him bail last year. However, in September last year, charges were framed against 13 people, including two owners of Tazreen Fashions, in a case over the devastating fire.

immediately, as many workers were killed only for his negligence," said Nazma Akter, executive member of the IndustriALL Global Union.

Many victims are yet to be compensated properly, said Nazma.

Tazreen Claims Administration Trust (TCA) paid around Tk 17 crore (about \$2.17 million), to 582 beneficiaries of Tazreen Fashion fire, said Mojtaba Kazazi, chief commissioner of the TCA, in response to an email from The Daily Star.

Payments were made directly to the individual bank accounts that were opened for each beneficiary with Dutch-Bangla Bank's Motijheel branch. The amount does not include salaries and other assistance provided by financing from C&A Foundation and others through CARITAS Bangladesh, Kazazi said.

The payment of compensation from TCA is over. It was formally closed down on June 30, 2015, he added.

Bangladesh team to meet Philippines

BB to cut currency printing costs

Bangladesh Bank is devising ways to reduce currency printing costs as the country has to spend a whopping Tk 500 crore a year on new notes and coins, central bank

officials said. The expenses that include costs of printing materials, paper, ink, colour, security thread and printing doubled in the last five years to keep up with the demand and the economic growth.

"We are encouraging electronic payment gateways so that the dependence on cash goes down," an official said.

Three such payment gateways have been given licences as payment service operators and they are already in operation. They are shurjoPay, SSL Commerce (easy.bd.com) and IT Consultants Ltd (ITCL).

Some other applications are awaiting approval, according to the BB.

With these e-commerce channels, people can buy goods and services and top up their mobile phones. People will also be able to exchange money and make

payments for purchases, utilities and other services. "If we can reduce the currency printing cost by 20 percent, it will save us Tk 100 crore," said the BB official.

At present, the central bank has to spend Tk 0.95 on a one taka coin and Tk 1.2 on a two taka coin. A 5 taka coin

Teletalk gives false info to parliament: regulator

State-owned operator Teletalk has provided to parliament manipulative information on illegal call termination, provided by Teletalk. according to a report by the telecom regulator.

Teletalk has tried to hide real information and reduced the number of SIMs that were seized by law enforcing agencies, Bangladesh Telecommunication Regulatory Commission said in the report sent to the parliamentary standing committee on the telecom and ICT ministry.

The committee sought clarification from Teletalk a few months back, when the allegation arose that the state-owned

operator was directly engaged in illegal international call termination. In a report, Teletalk said 21,874 of their Ahmed, managing director of Teletalk, SIMs were seized in 37 raids by the regula-

tor with the help of law enforcing agencies

from January 2013 to August 2016.

Upon receiving this information, the parliamentary standing committee asked the regulator to confirm the information

They found that there was a discrepancy between the real statistics and the information provided by Teletalk.

BTRC said there were actually 46 raids, and 25,903 SIMs of Teletalk were seized. Teletalk also mentioned inflated figures

for other operators. Imran Ahmad, chairman of the standing committee, said he has seen both the reports. "Actually I was quite surprised to

see the huge gap in the two reports." The matter will be discussed further in the next committee meeting, he said.

Officials at the finance ministry and the BB also confirmed that the team has got appointment for meeting the Philippine president.

The Bangladesh team will also meet with Senate President Aquilino "Koko" Pimentel, Finance

So far, Bangladesh has managed to bring back \$15.25 million of the \$81 million stolen from the central bank's account with the Federal Reserve Bank of New York by cyber thieves in February.

The team is going to ensure that the top level leaders of the Philippines provide support for

repatriating the remaining amount. The team will also include Abdur Razzak, chairman of the parliamentary standing committee on finance ministry; Attorney General

Mahbubey Alam; and Banking Secretary Eunusur Rahman. The law minister, while replying

to journalists' query about his ensuing Philippines visit yesterday, said he will speak about the success or failure of his visit upon his return on November 30.

On November 12, Bangladesh received \$15.25 million in cash from the Anti-Money Laundering Council of the Philippines after a Filipino court in September adjudged that the BB is the rightful owner of the money surrendered by casino boss Kim Wong and his Eastern Hawaii Leisure Company.

The money has already been deposited in the BB account with NY Fed.

In February, hackers flooded the NY Fed with requests for transfers totalling almost \$1 billion from an

cessfully withdrawn before suspicions were raised. Of the amount, \$20 million was wired to Sri Lanka and recovered by the BB soon after. The rest was transferred to Rizal

Commercial Banking Corp of the Philippines and from there \$46 million found its way into the lightly regulated Filipino casino industry and disappeared.

At least \$54 million of the \$81 million that ended up in the Philippines could be recovered, according to the probe carried out by a three-member team led by former BB governor Mohammed Farashuddin.

So far, the anti-money laundering regulator of the Philippines has accounted for \$60 million of the stolen money.
