Santals worried after filing FIR

The Santals are worried about their future after filing an FIR on Saturday accusing the people, including the ruling party lawmaker, allegedly involved in the eviction of Santal families from Shahebganj sugarcane farm.

Thomas Hembrom lodged the FIR (first information report) with Gobindaganj Police Station on behalf of Shahebganj-Bagda Bhumi Uddhar Sangram Committee against 33 named people and 600 unnamed others. Santal leader Philimon Baske said, "We could not file case

earlier for fear of arrest. Although we are somewhat pleased after filing of the case, we are still worried about our future." "We might be attacked by the ruling party leaders as the

FIR has been lodged against them in connection with eviction of Santals from the cane farm," said Rafayel Hasda, another leader of Bhumi Uddhar committee. "We are worried that the case might not run smoothly,

since the accused are very influential," said Subol Hembrom of Joypurpara. Seeking anonymity, a Santal man at Joypurpara said they

cannot say what would happen in the future as they have stood up against the lawmaker and the chairmen of the unions. The case statement said Gaibandha-4 lawmaker Abul Kalam Azad arranged erecting houses for 2,500 ethnic and

Bangalee people on the government acquired land of the farm house. Sapmara union Chairman Sakil Ahmed Bulbul started a movement in favour of this, the statement continued. A clash over cane harvesting ensued on November 6 between the mills' labourers, Santals and outsiders, in

which over 500 people took part at the direction of the lawmaker and in presence of the managing director of the sugar mills and the upazila nirbahi officer of Gobindaganj, Thomas mentioned in the statement.

Tale of a trafficked Gaibandha girl

Indian border guards returned a trafficked Bangladeshi teenage girl to immigration police through Benapole check post under Benapole Police Station on Saturday.

The 18-year old victim is a resident of Lalchamar village in Sundarganj upazila of Gaibandha.

Jessore police handed over the girl to Sundarganj police who later handed her over to her parents.

Gaibandha Superintendent of Police Ashraful Islam said he received a phone call from Delhi police few days ago saying that they rescued a Bangladeshi girl from the Indian capital.

Later, Gaibandha police traced her parents' address and requested Delhi police to send her back through Benapole border, the SP added.

Father of the victim said his daughter left their home on October 29 in 2015 and took a job at a yarn factory in Dhaka where she developed a friendship with one Hasan who lured the girl of a better job in India.

On their way to India, Hasan doped the girl and sold her to Tarun, an Indian national, for Tk 35 thousand.

AGITATION FOR NATIONALISATION OF MYMENSINGH COLLEGE

Teacher, another killed, over 100 injured during cop action

Two persons, including a college teacher, were killed and over 100 others injured, 10 of them seriously, as police swooped on an agitation programme of teachers, students and locals in Fulbaria upazila of the district yesterday.

The two deceased were Abul Kalam Azad, assistant professor of botany department of Fulbaria Degree College, and Safor Ali, 65, a resident of Kushmile Koroitola village in Phulbaria. The teachers, students and

employees of Phulbaria Degree College brought out a protest procession on the college campus around 1:00pm yesterday. Earlier, they announced a programme to block Mymensingh-Fulbaria road as part of the day's programme.

They have continued agitation including human chain, road blockade and hartal, also joined by local people, demanding nationalisation of the college for last 44 days, college teachers said.

procession, a large police team led by Rifat Khan Razib, officer-incharge (OC) of Fulbaria Police Station, entered the college campus and started beating up the rally participants without any provocation, injuring over 100 people including some 25 teachers," said college teacher SM Abul Hashem, also convener of Fulbaria Degree College Nationalisation Committee.

Later police engaged in a series of chases and counter chases with the protesters outside the college and charged baton in which Safor Ali sustained serious injuries and died on the spot, he said. Police also fired some 100

rounds of blank shots during the action, alleged Abul Hashem.

Safor was brought dead at the hospital, informed Dr Ahsan Habib, emergency medical officer of Fulbaria Upazila Health Complex.

"When we were holding a protest in Mymensingh where he succumbed to his injuries around 4:00pm, said Azad's colleague Arup Kumar Basak. "Police beat up the top leaders of

Quoting Nazma, police said a gang of four led by Shahin forcibly picked up the girl on a CNG-run three-wheeler while she was going to her private tutor's house around 4:00pm on October 28.

Failing to know his daughter's whereabouts, Monir Hossain, father of the girl, filed a case with Patuakhali Women and Children Repression Prevention Tribunal on November 14.

35 hurt as villagers clash in Habiganj

At least 35 people were injured in a clash over land dispute between two groups of villagers at Baghasura village in Madhabpur upazila of Habiganj on Saturday night.

Of the injured, five were admitted to Sylhet MAG Osmani Medical College Hospital, 10 at Habiganj Sadar Hospital and seven at different private clinics while the rest took treatment locally.

Quoting locals, police said supporters of one Kajal Mia, 36, and Nasir Uddin, 41, equipped with wooden sticks attacked each other over the ownership of a disputed land that left 35 people from both sides injured.


