It's not responsibility

"It is now time to make the Rohingya crisis an international issue, and seek support from all to resolve it permanently. Bangladesh is the worst sufferer of this Rohingya situation. The international community must come forward to shoulder the responsibility and ensure the rights of Rohingyas," said international affairs expert Maj Gen (Retd) Abdur Rashid.

The former ambassador said the government appears hesitant to take a firm stance on the issue and convey the message that it would no longer tolerate such an uncalled-for situation created by Myanmar.

"We shouldn't think that Myanmar may be unhappy or BCIM [Bangladesh-China-India-Myanmar economic forum] or BIMSTEC [the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation] may be affected if we take a firm stance on the Rohingya crisis that is adversely affecting Bangladesh. We must uphold our national interest and security first," he

He observed that Myanmar would continue to create such crisis, and one day, it would push all its Rohingya citizens into Bangladesh territory if Dhaka continues to maintain its soft

"Of course, we should continue our efforts to solve the problem bilaterally. But we can definitely engage the international community and regional players so that Myanmar refrains from creating such humanitarian crisis that also has global implications," said the former diplomat, who served as ambassador to the USA and Australia.

Last week, Dhaka decided to launch an all-out diplomatic effort to drum up global support for mounting pressure on Myanmar to resolve the Rohingya crisis.

Foreign ministry officials said the ministry has directed the Bangladeshi envoys in more than 60 countries and the UN bodies to brief the officials concerned in their countries of stay on the influx of Myanmar Rohingyas to Bangladesh in the face of persecution.

At a diplomatic briefing on Thursday, foreign envoys in Dhaka expressed their strong support in resolving the longstanding crisis in a peaceful manner and through dialogue between Bangladesh and Myanmar.

Seeking anonymity, a senior official at the foreign ministry told this correspondent that the government now strongly feels that mounting global pressure on Myanmar is essential as the country is not responsive to Dhaka's steps to establish and maintain friendly relations. Several officials of the ministry said

Bangladeshi envoys abroad have been asked to brief the foreign policymakers and high-ups in the light of the "Strategy Paper on Addressing the Issue of Myanmar Refugees and Undocumented Myanmar Nationals in Bangladesh". The strategy paper clarifies the

government's position on some vital issues regarding the Rohingyas. It unequivocally identifies them as "Myanmar nationals."

The Bangladeshi envoys are advised to highlight that the country has been hosting nearly half a million documented and undocumented Rohingyas since 1991 and has not deported any

Rohingya refugee.

The foreign ministry officials were critical of the UN refugee agency, the UNHCR. They alleged that the UNHCR

always puts undue pressure on Dhaka, and in the name of safety and dignity of the refugees, it delayed repatriation of Rohingyas for decades, which apparently encouraged more Rohingyas to enter Bangladesh. A high official of the foreign minis-

try said, "The UNHCR is requesting us to allow refugees to enter Bangladesh but it is not saying anything to Myanmar... Are we responsible for violence in Myanmar?"

Responding to a query on UNHCR's call for letting Rohingyas in, Foreign Minister AH Mahmood Ali told journalists on Thursday, "It has become the only duty of the organisation to ask Bangladesh to open its border whenever a crisis is created in Myanmar."

Now, around 32,000 registered Rohingyas are living in two refugee camps in Ukhia and Teknaf. The government has introduced free education up to class VI, vocational skill training, computer training, and primary and secondary healthcare to prepare the Rohingyas for a better life when they voluntarily return to their homeland.

Besides, three to five lakh undocumented Rohingyas are staying in different parts of Bangladesh.

The officials said that since Bangladesh is already hosting a huge number of Rohingyas from Myanmar, it cannot take in any more refugees.

for holding a mobile court under the Mobile Court Ain, 2009 must take cognizance of the alleged offence instantly at the spot provided the same has been committed or unfolded in his presence and the said magistrate is also empowered to convict the accused and award the prescribed sentence to him if he pleads guilty," said an HC bench of Justice M Enayetur Rahim and Justice Ashish Ranjan Das. "It is true that Mobile Court Ain, 2009

provides for appeal against the judgment and order of conviction before the district magistrate. But if mala fide is found on the face of the record in a mobile court proceeding and the conviction is 'no-est' in the eye of law, then this court [HC] has every jurisdiction to interfere with the matter exercising power under Article 102 of the constitution." Delivering the verdict on a suomoto

rule, the HC judges on October 18 declared illegal a mobile court verdict that sentenced Sabbir Shikder, a ninthgrader of Protima Bonki Public High School in Sakhipur, to two years in prison allegedly for threatening a local ruling party lawmaker via Facebook. The court also directed the secretar-

"It wouldn't merely eliminate inequality in access to water resources, but would also help bring peace, stability and security to the society as water has been the roots of many tension and conflicts across the world. "To achieve this [water security], we

must work together and act now. Bangladesh is committed to playing its role," she added. About the seven-point agenda,

Hasina said the Agenda 2030 sufficiently articulated the inter-linkages and interfaces between water and wider sustainable development architecture. Hence, water should be the integral part of any development endeavour at national, regional and global level. She said millions of people around

Being one of the most climatically vulnerable countries, the government has been carrying out series of measures to address climate change adversities," she added.

The PM told her audience that Bangladesh faces unique challenges -abundance in water during monsoon and scarcity during dry season. The country's vulnerability is further increased by the fact that 92 percent of its surface waters originate from

outside the border, she noted. "Sharing of trans-boundary river water is a complex issue. Two decades back, Bangladesh succeeded to enter into a long-term water sharing arrangement with India on the Ganges waters. Subregional cooperation on waters between Bangladesh, Bhutan, India and Nepal is

SC upholds HC bail for Manna

FROM PAGE 1 Surendra Kumar Sinha passed the order after disposing of two separate leave-to-

appeal petitions filed by the govern-

ment challenging the HC bail orders.

Shahdeen Malik, a lawyer for Manna, told reporters that Manna had been kept detained for about two years, but the police had not submitted any investigation report and that there was no progress in this regard.

The chief justice expressed discomfort, as the government's investigation was not satisfactory, the lawyer said, adding that it would be good if officials having good knowledge in law are

appointed to investigate the cases. There is no legal bar for Manna to walk out of jail following the apex court order, he added.

Additional Attorney General Murad Reza told The Daily Star that the SC had not gone into the merit of the cases against Manna, but upheld the HC orders on the grounds that he had been in jail for about two years and police were yet to submit any investigation report to the lower court. He also said there was serious

allegation against Manna of instigating the army to topple the government. Shaikh Nazmul Alam, deputy

commissioner of Detective Branch (North) of Dhaka Metropolitan Police, told The Daily Star that the investigation was on, and "we are collecting information and evidence". "He is an accused in a sedition case.

Investigation into a sedition case usually takes a long time. We need more time to complete the investigation," he added. Contacted around 4:00pm,

Proshanto Kumar Banik, senior jail superintendent of Kashimpur Central Jail-2, said that they did not release Manna as they were yet to receive the

court's documents on his bail. Necessary measures would be taken after receiving the documents, he added.

More than 20 hours after "plainclothes men had picked up" Manna from his niece's house in Banani around 3:00am on February 24 last year, officials said he was arrested by Rab members who handed him over to the Detective Branch of police.

Rab officials had then said Manna was arrested in a case filed with Gulshan Police Station for "trying to instigate revolt by the armed forces". The arrest came days after his two telephone conversations were leaked. In one conversation, Manna, also

former organising secretary of the ruling Awami League, was heard talking to BNP leader Sadeque Hossain Khoka about strengthening the anti-government movement, among other issues. The other call was made to an

unknown person. During the conversation, the man asked Manna if he would like to sit with top army officers. A Dhaka court on February 25 last

year allowed the police to take Manna

on a 10-day remand in the case. Arguing against the remand petition, Manna had told the court, "Everything I said during my two conversa-

tions is already public. What additional information will you [police] collect from me when I have nothing new to say about this? There is no need for you to take me on remand." On the allegation of instigating the

armed forces to revolt, Manna told the court he never said anything like that in the conversations.

The former vice-president of Dhaka University Central Students' Union also protested that during the conversations he talked about the need for dead bodies to intensify the antigovernment movement.

But prosecutors said they needed to quiz Manna to know the names and addresses of those, including a Bangladeshi living in Australia, "involved in a conspiracy" against the government.

On the third day of the 10-day remand, Manna fell sick. He then filed a petition with the HC challenging the legality of the remand order of the lower court. Following his petition, the HC on

December 10 last year scrapped the

lower court order that had placed him

on remand. On March 31 last year, following his another petition, the HC directed the prison authorities to admit the Nagorik Oikya convener to Ibrahim Cardiac Hospital in Dhaka immediately for treatment, as he had been suffering

from different diseases, including cardiac problem and diabetes. Following two separate bail petitions filed by Manna, the HC, on August 30 and November 10 this year, granted him

permanent bail in the cases. The government later on moved separate leave-to-appeal petitions before the Appellate Division challenging the HC orders.

The Appellate Division recently held hearing on the petitions and fixed yesterday for passing order on them.
