COUNCILLOR ASPIRANTS IN NCC POLLS

Two-thirds did not pass school

The educational qualification of most of the councillor candidates in the upcoming Narayanganj City Corporation (NCC) polls is poor.

Two-thirds of the councillor aspirants did not complete their Secondary School Certificate (SSC) examinations.

The gloomy picture of the candidates was found analysing their affidavits they submitted to the returning nomination papers.

A total of 156 aspirants are vying for 27 general councillor posts. The Daily Star has analysed all of their affidavits.

Of the candidates, 65 claimed either self-educated or literate, 37 studied up to tenth grade, 16 completed SSC education, 19 passed Higher Secondary Certificate (HSC), while the rest are graduates and above. For example, the voters of the five

wards have no choice except electing their councillors who could not complete their school education. In the wards 1, 6, 20, 25, and 26, there are no SSC passed candidates.

records. At least 37 aspirants are accused in criminal cases and 41 had previous

cases, while many had past criminal

criminal records, said the affidavits.

Maksudul Alam Khandaker Khorshed, a councillor candidate of ward-13, is currently an accused in 24 cases. In past, he was accused in three other cases. The number of contesting candi-

dates also varied from ward to ward. In ward-9, highest 12 candidates are contesting while only two in ward-26. Qualified and educated people are

reluctant to contest in councillor Many candidates are also facing posts because a city corporation is officer of the election along with criminal charges including murder mostly controlled by the mayor, and councillors can exercise very limited power, said local government and election expert Dr Tofail Ahmed.

The High Court yesterday directed the government to immediately stop gambling including cards, dice and housie at 13 renowned clubs, including Dhaka club. The 12 other clubs are -- Uttara Club Ltd, Gulshan Club

Ltd, Dhanmondi Club Ltd, Banani Club Ltd, Officers' Club Dhaka, Ladies' Club Dhaka, Cadet College Club Dhaka, Chittagong Club Ltd, Chittagong Seniors' Club Ltd, Narayanganj Club Ltd, Sylhet Club Ltd and Khulna Club Ltd. The HC also issued a rule asking the authorities concerned

to explain in four weeks as to why they should not be directed to take actions against the unlawful business and indoor games of cards, dice and housie in exchange for money. The HC bench of Justice Quamrul Islam Siddique and

Justice Sheikh Hassan Arif came up with the order and rule following a writ petition filed by two Supreme Court lawyers Samiul Huq and Rokonuddin Md Faruq.

According to an ISPR release, BAF Base Bangabandhu is the main base of Bangladesh Air Force, known as "Home of Fighters".

'Human factor' behind emergency landing of PM's flight: Menon

Civil Aviation Minister Rashed Khan Menon yesterday informed the House that "human factor" was behind a technical fault for which a flight of Biman carrying Prime Minister Sheikh Hasina to Budapest, was forced to make an emergency land.

"In a preliminary investigation..., it was found that the emergency landing was due to human factor error. However, intelligence agency members are working on the matter to ascertain whether it was any negligence or sabotage," Menon said in a statement.

Six Biman officials were suspended for "their negligence" in duty in this connection, he added.

On November 27, the VVIP flight heading for Hungary landed at Ashgabat of Turkmenistan due to the technical glitch, which was later resolved by on-duty engineers.

Kidnapped Bangladeshi worker rescued in Malaysia

3 accused held in Malaysia, three others in Dhaka

Malaysian police rescued a kidnapped Bangladeshi migrant worker and arrested three other Bangladeshis for their alleged involvement in the kidnapping on Thursday, said the Bangladesh high commission in Kula Lumpur yesterday.

MSK Shaheen, first secretary at the high commission's consular wing, told The Daily Star that after receiving allegations, they talked to the Malaysian police and rescued the victim from the kidnappers' den.

Mahbub Alam, 36, son of late Abul Kashem of Bhola, was rescued five days after he had allegedly been kidnapped by the gang for ransom from the country's Pahang district on November 26.

The official, however, did not disclose the arrestees' identities.

Meanwhile, a team of Rapid Action Battalion (Rab)-3 arrested three alleged Bangladeshi agents of the kidnappers in Malibagh of Dhaka between November 28 and December 3.

The team yesterday produced them along with the rescued worker, who was brought back home on Saturday night, before the press at its Kawran Bazar Briefing Centre.
