Five Moulvibazar men charged with war crimes

Decision against 6 Netrakona men Jan 24

International Crimes Tribunal-1 yesterday framed five charges against five Moulvibazar men for allegedly committing genocide and crimes against humanity during the 1971 Liberation War.

The three-member tribunal led by Justice Anwarul Haque with members Justice Md Shahinur Islam and Justice Md Shohrowardi fixed January 15 to begin the trial with the prosecution's opening state-

Of Moulvibazar's Rajnagar upazila, Yunus Ahmed, 71, and Ujer Ahmed Chowdhury, 63, are in jail while the rest, Samsul Hossain Tarafder, 65, Nesar Ali, 75, and Mobarak Mia, 66, are on the run.

Prosecutors pressed the five charges on May 26. They allege Samsul was an Al-Badr commander while the rest Razakar Bahini members.

The charges include the abduction, torture and killing of one Danu Mia; looting and torching of three houses; confinement of three people; abduction, confinement and torture of another three and looting and torching of the houses of one Harendra

Prosecutors pressed seven charges on May 22 against the Razakar suspects of the district's Purbadhala upazila.

BNP plans to hold countrywide talks over EC formation

BNP has planned to hold roundtables, discussions and seminars across the country to drum up peoples' support in favour of Khaleda Zia's proposal on formation of the next election commission on the basis of consensus among the political parties.

The party has already started a division-wise campaign and held discussions in Sylhet few days ago and yesterday in Chittagong. It is now planning to spread the campaign at the district

level to create a "debate" over the issue. The tenure of the existing EC expires in February.

"We have already started holding seminars and roundtables...at divisional level and will spread at district level gradually," Mirza Fakhrul Islam Alamgir, party's secretary general, told The Daily Star.

The party is also planning to hold roundtables and discussions in the capital soon, he said. Pro-BNP platforms have already started talks in this regard; talks will be held soon with the professional bodies and stakeholders, he said.

Fakhrul said they have already sent copies of Khaleda's proposal to all the embassies, high commissions and foreign offices.

On December 18, Khaleda Zia placed a 13-point proposal for the formation of a "strong and non-partisan" election commission on the basis of consensus among the political parties and also urged the president to take an initiative.
