### Young woman murdered for dowry

A woman was killed for dowry allegedly by her husband at Ramnagar village in Sadar upazila of the district on Tuesday.

The deceased was Hashi Begum, 22, wife of Mizanur Rahman of the village, said Mizanur Rahman, officerin-charge of Natore Police Station.

Being informed, police recovered the body of Hashi from her husband's house around 10:00pm and sent it to Natore Sadar Hospital morgue for autopsy.

Ziarul Islam, father of the victim, said Mizanur often tortured Hashi for Tk 1 lakh as dowry.

Mizanur and his family members hanged the body of his daughter from ceiling of the house after killing her, he alleged.

Police arrested Mizanur's mother Momena Begum, the OC said, adding that Mizanur and other family members managed to flee soon after the incident.

Its tactics are sophisticated. On October 9, it launched predawn attacks on three border police bases, including an audacious assault on the headquarters, a key security installation.

The headquarters was overrun in a complex attack involving several hundred assailants that included planting improvised explosive devices and setting an ambush on the approach road, delaying the arrival of army reinforcements, while the attackers looted the armoury.

A further clash on November 12 killed a senior army officer. These actions represent the actions of a determined, well-trained insurgency that will likely launch further attacks. Feeling its dignity affronted and

taking casualties, the military employed disproportionate force and failed to adequately distinguish attackers from civilians. At least 1,500 homes have been

burned down -- almost certainly by the military, according to satellite analysis released by Human Rights Watch on seeing it as counterproductive to December 13.

> Some 30,000 have been internally displaced and 27,000 have so far sought refuge in Bangladesh. The area where the military is focusing its crackdown has been almost entirely sealed off, which has made it difficult to verify multiple allegations of serious humanrights abuses; but as more people arrive in Bangladesh, a clearer picture is starting to emerge.

Aung San Suu Kyi has said little publicly on the situation, has not travelled to the area or criticised the crackdown. The state media she controls have issued blanket denials of abuses, risking reinforcing the impunity of troops on the ground. And tensions with the Muslim world are rising.

secretary of Chowdhury Hat Market Traders' Association, lodged the complaint with Hathazari Police Station. Shariful Islam, inspector (investiga-

tion) of the station, said, "We have got

a written complaint against a youth. We are investigating the matter." Several hundred locals, including Hindus and Muslims, gathered at the market after the news about the post had spread in the locality yesterday

morning. Habib was on the run and his mobile phone was found switched

However, he offered apology through another Facebook post from the account around 1:00pm. The account was deactivated around 4:30pm.

Locals in a rally held in the afternoon demanded Habib's arrest and punishment.

betfair.com, unibet.com, betvictor.com, netbet.com, titanbet.com, winer.com and paddypower.com. Although betting is illegal in

Bangladesh, it has grown out of proportion with the success of the Bangladesh cricket team and more importantly since the introduction of the BPL in 2012. Besides, people in this part of the world were also involved in betting during overseas events including the Indian Premier League (IPL). And according to police these websites play the biggest role in syndicated betting with their representatives on the ground.

A mid-ranked DMP official told The Daily Star that they detained at least 60 alleged gamblers including three Indian nationals and four Pakistanis from inside and outside stadiums during BPL matches, suspecting their involvement in illegal betting.

"They were taken to custody but were released later on bond, because anyone convicted of illegal betting are liable to pay only Tk 100 as per the law," the police officer told The Daily Star. Preferring anonymity, he also told

that the three Indian nationals, who also visited Bangladesh during the England series, were deported through the Indian High Commission while the Pakistani nationals were handed over to their embassy.

The police officer said it was easy to identify a gambler from a spectator because the gambler stays busy with his mobile phone rather than watching the

When contacted, Nazmul Islam, additional deputy commissioner of Cyber Security & Crime unit of DMP, confirmed that they wrote to BTRC to block those websites after a thorough investigation.

According to police, illegal betting took a serious turn recently as it involved all sections of the society including the young generation. Besides, the illegal betting syndicates that have been sprouting in every nook and corner of the country are sucking in even a farmer, a day labourer and a rickshawpuller.

The betting menace is growing because of the existing lenient law against it, said a police officer, adding that it should be revisited to bring the culprits to book.

The part of section 4 of Public Gambling Act-1869 reads: "Whoever is found in any such house, tent, room, space, or walled enclosure, playing or gaming with cards, dice, counters, money or other instruments of gaming, or is found there present for the purpose of gaming, whether playing for any money, wager, stake or otherwise, shall be liable, on conviction before any Magistrate, to a

fine not exceeding one hundred taka or to imprisonment of either description, as defined in the 9[ Penal Code], for any term not exceeding one month."

Unfortunately we are living in the 21st century and the definition of gambling and its impact increased manifold instead of just being confined to playing cards or rolling the dice. And like an aggrieved police officer, many strongly feel that the gambling law should be updated to coun ter the betting epidemic, which is seri ously hurting the society.

"The BCB through its anti corruption unit is working with the police to counter betting in cricket. Still, I think the law should be timebefitting for a more concerted effort to fight this evil," said the BCB CEO Nizamuddin Chowdhury while confirming that the board has been sharing its knowledge about betting with police for quite some time.

When contacted, Law Secretary ASSM Zahirul Haque Dulal told The Daily Star that the home ministry is the proper authority to take steps to amend the law for enhancing punishment for gambling.

He also added that the law ministry will assist the home ministry if it takes any initiative to this effect.

It's about time the home ministry takes a step forward from 1869.

In the last five years, the company exported around Tk 650 crore worth of BJMCmanufactured jute goods to Sudan. (E) Although the GFTCL has been

performing spectacularly in the export market, disregarding all our credentials and business reputation, Mr Amin Abdel Latif (Bangladesh's consul general in Sudan) in connivance with the beneficiary of the then BNP regime started conspiring against us to monopolise the market. Nowhere did The Daily Star report say that Mushtaq's GFTCL is not an enlisted exporter with the BJMC. Also, the report did not term him as an "unscrupulous trader". It is BJMC officials who said they are a fully-fledged business organisation and are able to market and sell their goods directly. But influential quarters always

prevented them from doing so.

Moreover, Mushtaq himself admitted how a group of people controlled BJMC-manufactured products and made money for years. He said the then jute minister of the BNP government in 1991 had given a Gazipur-based businessman the sole agency of the BJMC's jute products and if other exporters, including enlisted ones, wanted to buy BJMC goods, they had to go to that businessman, who was dubbed "mini BJMC" at that time.

The landmark deal -- which would mark the end of opposition resistance in Syria's second city after years of fighting -- appeared increasingly precarious as the regime, the rebels, and their foreign allies traded accusations.

The last pocket of rebel-held territory in east Aleppo came under heavy tank fire, said an AFP correspondent in the area, who saw several wounded civilians.

The Syrian Observatory for Human Rights said air strikes had also hit rebel areas and that there were "very intense clashes on every front line" State television said rebel rocket

fire on government-controlled areas had also resumed, with at least seven people reported dead. Rebels and a source close to the

regime told AFP that the evacuation had been suspended after objections from Syria's government. The source said Damascus had
