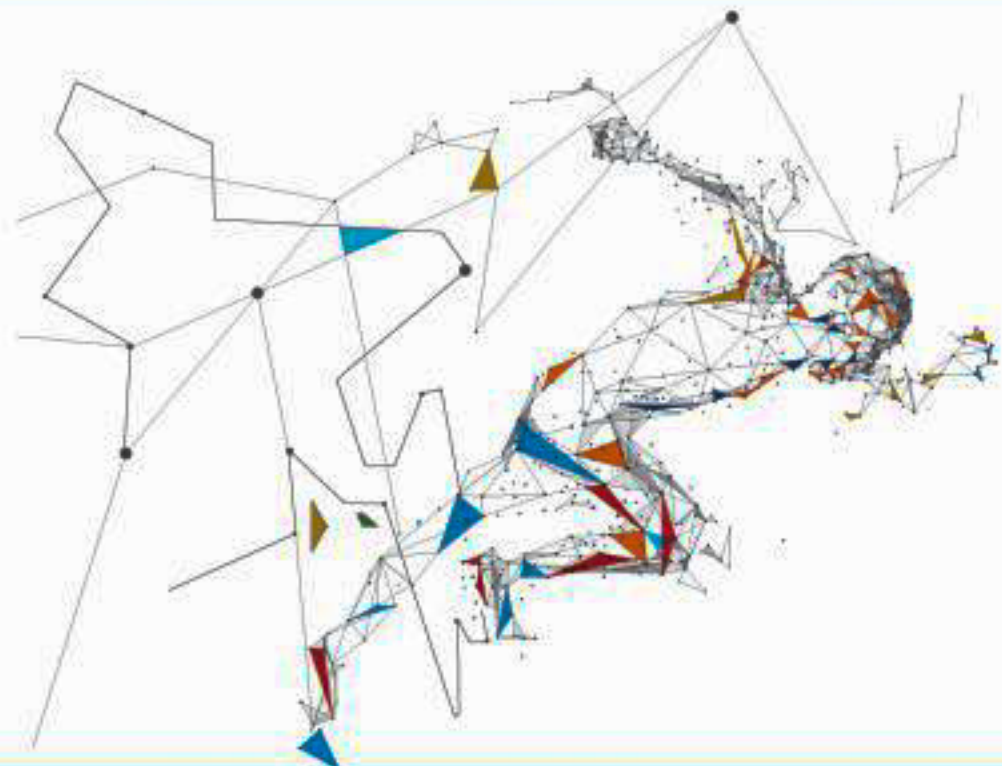

Bangladesh being at the crossroad of economic development and economic globalization, its consistent and positive economic growth indicators, steered by outstanding economic leadership have stunned the world.
