Students in Birganj upazila of the district formed an hour-long human chain at Jharbari area in protest against charging of additional money for HSC registration under Dinajpur Education Board.

They said Dinajpur Education Board fixed Tk 2,275 for each student for filing their HSC registration, but the authorities of Jharbari College allegedly took Tk 3,200 from each student.

The agitating students threatened tougher agitation if their problem was not solved immediately. Earlier, the students brought out a protest procession which paraded different roads in the area.

Chairman of Dinajpur Education Board Ahmed Ali warned of tough action if extra money is realised from the students.

This correspondent tried to reach the principal of the college Md Anwar Hossain for his comments about the allegation, but his phone was switched off.

Parents prefer earning to arranging schooling for children

Sumi Akhter, 10, read up to Class II, but she could not continue going to school as her parents put her to work in a bidi factory at Kalmati village in Sadar upazila of the district.

Like Sumi, her cousin Lavlu Islam, 7, was admitted in Class I, but he was engaged in the same work by his parents instead of going to school.

parents put me to work to earn for the family," said Sumi Akhter. "I can make 2,500 to 3,000 bidi sticks every day, and I get Tk 10 for making 1,000 bidi sticks," she added.

"I was admitted in Class I, but dropped out after six months as my parents engaged me in a bidi factory," said Lavlu Islam. "I can make 2,000 to 2,500 bidi sticks every school, but my parents are not interested," he added.

Sumi's father Fazlu Miah, 42, the school." said, "We are poor, so our children help us to alleviate poverty by "I want to go to school, but my working," adding that many children of the village work in bidi factories.

> "It is not possible for our children to go to school as we have no

ability to pay for their education, so we want them to get training on job," said Sumi's mother Meherbanu Akhter, adding that she also worked in a bidi factory.

Azizul Islam, 48, a bidi factory worker in the village, said many children of 20 villages in five unions -- Harati, Khuniyagachh, Sarpukur, Saptibari and Bhotmari -- under the district are engaged in bidi factories.

Ashraf Ali, manager of a bidi factory in Saptibari village of Aditmari upazila, said they do not hire children, but the guardians send their children to work in the factories.

Fatema Begum, 35, a primary schoolteacher at Sarpukur village, said, "Some children from ultra poor families take admission in the school, but many of them drop out very soon."

District Primary Education Officer Nabez Uddin Sarker said the teachers in the villages are trying their best to convince the guardians to send their children to school.

Cop asked to submit report by Feb 16

Court orders ASP to probe the case

A Mymensingh court yesterday asked the Additional Superintendent of Police (ASP) to investigate the case in connection with the killing of two people during the Phulbaria Degree College agitation for its nationalisation on November 27.

The order was given following filing of a case with the Cognisance Court-2 of Senior Judicial Magistrate on Wednesday against the Phulbaria ruling Awami League lawmaker and six others in this regard, court sources said.

The court also asked the ASP to submit the report by February 16, 2017, they added.

Apart from lawmaker advocate Muslem Uddin, the other accused in the case are his son advocate

Emdadul Haque Selim, information and research affairs secretary of Phulbaria upazila unit of AL, Phulbaria Degree College Principal Nasir Uddin Khan and Viceprincipal Amzad Hossain, Officerin-Charge of Phulbaria Police Station Rifat Khan Rajib, Subinspector Rafiqul Islam and Assistant Sub-inspector Ratan, court sources said.

SM Abul Hashem, a senior teacher of the college, lodged the case with the court against the seven people, including lawmaker Muslem, who is also president of Phulbaria Degree College governing body.

On November 27, a clash between the protesters and police broke out as police swooped on the demonstration by teachers, students and staff of the college.

War hero but not in list

Rabiul Islam, locally known as Borno Mia, who fought against the Pakistani occupation forces and their collaborators during the Liberation War in 1971, is yet to be enlisted as a freedom fighter even after 45 years of the

country's independence. During a visit to his home, this correspondent found the 70-year-old man from Gazipur village under Benapole Police

Station suffering from various old-age complications and lying on his bed without any treatment.

Borno said responding to the call of Bangabandhu Sheik Mujibur Rahman he joined the freedom fighters and took training at Chapabaria Muktifouj Training Camp in North 24

Parganas of West Bengal in India in 1971. After completing his training, Borno along with local youths Irfan, Yusuf, Batul and Sattar joined the other freedom fighters in Jhikargachha upazila and fought against the Pakistan army in different areas of Jessore under the leadership of Sector Commander Major Ziaur Rahman.

After the country was liberated, Borno

failed to submit his certificate issued by the commander bearing serial number 1773 to the proper place and remained unrecognised till today. As a result, the brave fighter

was denied the facilities of a freedom fighter, which pushed him and his family into an absolute despair.

Now he has no work as he cannot even go out of his house. Shah Alam, commander of Bangladesh Muktijoddha Sangsad's Benapole munici-

pal unit, said he had issued a certificate stating Borno's role in 1971 but unfortunately he failed to submit the certificate through proper channel, which led

him to the untold sufferings. Borno said only Prime Minister Sheik Hasina could pull him out of the disaster, adding that he expects the Awami League government to take necessary steps to enlist him as a freedom fighter before his death.

Woman killed by ex-husband

A woman was stabbed to death allegedly by her former husband in Mathbaria upazila of the district yesterday. The deceased was Rabeya Begum, 32, daughter of Abdul

Halim Mridha of Baro Shinga village in the upazila. Police and family sources said Rabeya and Sagar Sardar Mintu of Munshiganj started living in Dhaka since their


marriage seven years ago. As Sagar is a drug addict, the couple often engaged in altercations over the issue. Six months ago, Rabeya returned to Mathbaria from

Dhaka after divorcing Sagar. A month after the incident, Sagar went to Rabeya's house and cut himself with a sharp blade as she refused to go with

him. Around 1:00pm yesterday, Rabeya went out to respond to a natural call. At that time, Sagar, who was waiting outside, stabbed her mercilessly, leaving her dead on the spot. She was rushed to the upazila health complex where onduty doctor declared her dead.

Later, locals caught Sagar red handed and handed him over to police.

A murder case was filed, accusing Sagar in this connection, said Khandakar Mostafizur Rahman, officer-in-charge of Mathbaria Police Station.
