go for water saving tech

Textile companies have started adopting water saving technologies as Bangladesh is one of the highest water consuming countries for washing and dyeing fabrics.

Garment factories use more than 250 litres of water for

washing and dyeing one kilogram of fabrics while the global best practice is 70 litres. Bangladesh's textile mills consume 1,500 billion litres of

groundwater a year for washing and dyeing fabrics, according to a report -- Bangladesh-The Netherlands: 50 years of water cooperation. The report was published recently by Partners for Water Programme of the Netherlands in cooperation with the Bangladesh government. The surface water is also contaminated for inefficient

use of water, the report said, adding that international fashion brands are increasingly aware of their social responsibility concerning the sustainability of their supply chain to achieve a cleaner textile production process. "We were able to save more than 70 percent of water by

adopting the water saving technologies," said Bakhtiar Uddin Ahmed, general manager at Fakir Apparels, a garment maker based in Narayanganj. Previously, his company used 24.96 crore litres of water for washing and dyeing 1,200 tonnes of fabrics in a

month, but the amount of water has now declined to 6.96 crore litres. "We are also saving electricity by adopting similar kind of technologies," Ahmed said.

The International Finance Corporation, a member of the World Bank Group, now provides water saving technologies to Bangladeshi garment factories under its Partnership for Cleaner Textile (PaCT) programme. Along with adopting new technologies, IFC suggests

factories should use industry friendly machinery and change their water use habits. Mondol Fabrics, a concern of Mondol Group, also adopted the water saving technologies of IFC.

"We have already implemented the first phase of adopting the technologies and the second phase is going on. After the implementation of the first phase, we were able to save 27 percent of water in washing and dyeing fabrics," said Momin Mondol, managing director of Mondol Group.

............... Inflation came down to 5.03 percent in December, the lowest in 53 months, helped by a steady decline in non-food prices since June as well as a lack of supply disruption thanks to a stable political environment.

"Political stability played a key role in reducing consumer prices," said Planning Minister AHM Mustafa Kamal as he disclosed the inflation figures at the Planning Commission in the capital.

Overall, inflation went down 35


cent in December, a decline of 88 basis points from 5.33 percent a month earlier. Food inflation fell slightly to 5.38

percent from 5.41 percent in November. The steady decline in non-food

inflation since June 2016 through December 2016 has to do with the weakening of aggregate demand caused by a large decline in remittances, said Zahid Hussain, lead economist of the World Bank in Dhaka.

The fall in remittance has reduced the purchasing power in both rural and urban areas significantly, he said.

Remittance inflow slumped by about \$2 billion in 2016 from a year earlier despite a 35 percent increase in migrant worker outflow during the period.





In addition, there were no upward adjustments in the administered prices of gas and electricity that could sustain the cost push impact of the earlier increases in these prices, he said.

December inflation number is the stabilisation of food inflation following continuous increase from June onwards.

This hopefully will not change as rice prices stabilise with the harvesting of the aman crop, Hussain said.

There was also a sharp drop in infla-

tion in rural areas, dropping to 4.46 percent in December from 4.75 percent a month ago, which is far below the national average.

Although the inflation in the cities The other good news in the went down by nearly half a percentage point to 6.07 percent in December compared to November, the figure is still much above the national general inflation.

The government has aimed to keep the inflation rate within 5.8 percent in the current fiscal year.

BB once again looks to reward good borrowers

Bangladesh Bank has once again urged commercial banks to reward their first-rate buyers with rebates on interest payment and various charges in an effort to foster a good credit culture.

The directive came at yesterday's Bankers' Committee meeting, which was attended by BB Governor Fazle Kabir and chief executives of all banks.

The banks' chief executives said they have been offering various types of rebates to good borrowers over the last several years. The rebate for 2016 will be paid by March this year, they said.

In response, the BB called for more discussions to explore the scope for increasing the benefits further. The Bankers' Committee, comprising chief executives

of all commercial banks, meets periodically to discuss various problems. At the meeting, the central bank presents the govern-

ment's priorities and the current picture of the economy. Save for remittance, all economic indicators are 'very good', Kabir said yesterday. Economic growth crossed the 7 percent mark last fiscal

year and will most definitely be better in fiscal 2016-17. Inflation is low and the reserve level is satisfactory. But remittance inflow in 2016 was about \$2 billion

less than in 2015, and is on a declining trend. Subsequently, the BB governor told bankers to take initiatives to boost the inflow through the legal channel.

About 70 percent of the ATM machines in the country have been fitted with anti-skimming devices and PIN code shields as of now.

Kabir asked the bankers to complete the installation of the remaining 30 percent ATM machines soon.

At the meeting, Anis A Khan, chief executive officer of Mutual Trust Bank, suggested the central bank governor set up a credit bureau.

If the bureau is established a good credit culture will flourish in Bangladesh. On the basis of the ratings of the credit bureau, borrowers will be able to take various types

of loans at low interest rates. The BB governor welcomed the suggestion and said an initiative in this regard will be taken.

> The zone is situated on 216 acres of land at Gazaria in Munshiganj, very close to the Dhaka-Chittagong highway and Meghna Ghat river port.

However, the final licence was for 142 acres, and another licence will be awarded later for the rest of the land.

The economic zone is suitable for

food processing, plastics and other consumer goods, machinery parts and light engineering, automobile and accessories.

Paban Chowdhury said they are planning to provide five more final licences by this year.

Earlier, Beza awarded the first final licence to Meghna Group's Meghna Economic Zone in July last year.

Beza has so far awarded prequalification licences to 10 other local private companies to set up 11 economic zones: one each to AK Khan and Company, Bay Group, Aman Group, Maisha Group, United Group, Unique Group, Akij Group and two to Bashundhara Group and Meghna Group.

It is also setting up four economic zones in the public sector. It plans to create jobs for one crore people in the 100 economic zones by 2030 and produce goods and services worth \$40 billion.
