- Bangladesh Gas Fields Company Limited (BGFCL), a Company of Bangladesh Oil, Gas and Mineral Corporation (Petrobangla) under Energy Division of Ministry of Power, Energy and Mineral Resources (MPEMR), is the largest national gas production company in Bangladesh. BGFCL intends to install wellhead gas compressors to increase wellhead gas pressure in maintaining the gas transmission pipeline pressure at Location-A of Titas Gas Field.
- The Government of People's Republic of Bangladesh (hereinafter called "GOB") has applied for a loan from Asian Development Bank (ADB) (hereinafter called "loan") towards the cost of wellhead gas compressor installation project (hereinafter called "the Project") under the Proposed Natural Gas Infrastructure and Efficiency Improvement Project and intends to apply part of the proceeds of the loan for the eligible payments under the contract for the engagement of Consulting Services for Implementation of the Project. BGFCL intends to employ a consulting firm which will be internationally reputed for design & engineering, preparation of bid documents for EPC contract, bid evaluation, monitoring and assessment of the Project activities including construction supervision as well as providing advisory services for implementation of the project.
- The Consulting Firm will be selected based on Quality and Cost Based Selection (QCBS at 90:10 ratio) method in accordance with the procedures set out in "Guidelines on The Use of Consultants by Asian Development Bank and its Borrowers (March 2013 or amended from time to time)". The Expression of Interest (EOI) is invited under advance contracting notice. The contract is expected to be jointly financed by ADB and AIIB. No nationality restrictions apply other than any restriction arising from Para 1.13(a) of Guidelines on the Use of Consultants by Asian Development Bank and its Borrower.
- The EOI will be assessed based on management competence (20%), technical competence (70%) and geographical competence (10%). Based on the evaluation of EOI, shortlisted consultants will be invited to submit a full technical proposal and financial proposal through the request for proposal.

Assigning sub-consultant will require prior approval of BGFLC. The consulting firm/JV shall remain responsible for the performance of the sub-consultant(s).
