

# 79 judges appointed

The government has completed the recruitment process of 79 new lower court judges through giving them postings as per the Supreme Court advice.  
The law ministry yesterday issued a gazette notification to this effect, asking them to join their workplaces on January 22. The new judges have to join the district and sessions judges concerned, a law ministry press release said.  
President Abdul Hamid in November last year approved the appointments of 79 judges who were recommended by the Bangladesh Judicial Service Commission (BJSC), law ministry sources said.

other suspended Biman officials -- engineer Rokonzaman and junior technician Siddiqur Rahman -- were also sent to jail after they surrendered before another court seeking bail in the case. Later on December 28, they were placed on a seven-day remand.  
They are now on another seven-day remand in the second phase.  
Nine employees of Biman Bangladesh Airlines were made accused in the case filed under the Special Powers Act with Airport Police Station on December 21.  
Wing Commander (ret'd) MM Asaduzzaman, director of engineering and material management of Biman, filed the case.  
All the nine Biman employees were suspended and seven of them were arrested hours after the case was filed.  
On November 27, a Biman flight carrying the prime minister made an emergency landing at Ashgabat International Airport in Turkmenistan on her way to Budapest in Hungary as engine-1 of the aircraft was losing oil pressure.  
After the landing, engineers identified that a loose nut was causing the loss of oil pressure.  
The Biman authorities formed a technical probe committee the following day to find out the reason behind the incident. Based on the findings of the probe committee, Biman first suspended six employees and later three more and filed the case against them.

# Unplanned construction hampering urbanisation: Experts

Unplanned building construction, violation of related laws, and bureaucratic complications hamper proper urbanisation in the country, experts said at a dialogue yesterday.  
Planners and engineers have been making apartments in the city, but in most cases low income groups of the society could not afford those houses, they observed.  
They made the comments at the dialogue on "Urban Infrastructure and Housing" at a conference hall of the Bangladesh Institute of Planners (BIP).  
It was part of BIP's dialogue series on urban planning and development.  
Housing rules have to aim at making living in a city easier in terms of employment and dwelling, they said.

# Report irregularities in school, college admission by Feb 15

**ACC asks DCs**

The Anti-Corruption Commission yesterday asked all deputy commissioners (DCs) to report it by February 15 about students who failed exam but were promoted to next levels.  
"We have found allegations that many school authorities promote failed students to next classes by imposing extra charges," said an ACC official, wishing anonymity. ACC yesterday sent letters to the 15 institutions in the capital seeking information about their admission process and asked them submit information by January 12.  
The institutions are: Motijheel Govt Boys' High School; Ideal School and College; Viqarunnisa Noon School & College; Willes Little Flower School and College; Udaya School; Govt Laboratory High School; Azimpur Govt Girls School and College; Agrani School and College; Dhanmondi Govt Boys' School and College; Mohammadpur Preparatory High School; Saint Joseph High School; Dhaka Residential Model School and College; Holy Cross High School; Monipur High School and College, and Rajuk Uttara Model School and College.

# She forced my hand into boiling water

that the homemaker started to torture her from the second month on any excuse.  
"I had to do all works of the house except for cooking," she said. "I had to sweep the floor, collect water in pitchers from the nearby tube-well, cut and prepare vegetables, fish and meat."  
"She used to beat me and choke my throat with her leg if I did any mistake in work," said Tanjina. "One day she cut off my hair as I was not quick to cut vegetables." "On Friday morning, she ordered me to cut and prepare a chicken but I refused to do that saying I could not do it," she said. "Then she forced my hand into boiling water."  
Tanjina did not get any treatment till the afternoon. As she was sent to fetch water in the afternoon, neighbours and locals found her injured and rushed her to CMCH. Md Sufian, a local of Salimpur area who took her to CMCH, said, "How could a person torture a girl like this!" Sufian filed a case with Sitakunda Police Station and bore the expenses of the girl's treatment. "I tried to contact her parents but the phone of her mother was switched off," he said.  
Police arrested her employers Naorin Akter, 25, and Nur Mohammad, 36, on Friday night, and a Chittagong court sent them to jail the next day, said Inspector Mahubul Milki of the police station. During interrogation, Naorin "admitted" that she used to slap Tanjina occasionally and cut her hair off but she denied burning her hand in boiling water, said the officer.

who returned home after attending his final examinations, will handle the family. Bablu's marriage was also fixed.  
"I don't know who was so zealous wanted that I lost everything overnight," said Moheswar.  
Their traditional clay home was built around a spacious courtyard. The parents lived in a room on the West while Bablu in an Eastern room near the main gate.  
On that fateful night, the parents went to bed at 9:30pm. Bablu talked to his fiancée for hours, said police examining his cellphone.  
After midnight, Moheswar got up from bed hearing "an unusual scream". He got frightened as he remembered the letters.  
He and two of his neighbours -- Montu Soren and Sunil Majhi -- got similar letters reading that 48 people from 23 villages formed an extortion gang, and if they were not paid their demanded money, they would be killed.  
Sunil and Montu said they filed general diaries with Tanore Police Station, but Moheswar did not do so due to fear.  
According to Moheswar, he went out of house at that night and saw around nine masked people wearing black clothes and of them three were carrying daggers in their hands.  
"What did we tell you about the money? Where is it?" one of the gangsters had asked Moheswar.  
Moheswar sold his two bighas of land at Tk 8 lakh, which he gave them away to save their lives.  
Taking the money, the criminals dragged Moheswar to Bablu's room and went away.  
In the dark, Moheswar discovered Bablu's body in a pool of blood.  
"Every sunset, we leave home and come back in the morning. We had only tears to shed," wept Bablu's mother.
