

**IN MEMORIAM**

Today is seventh death anniversary of Ishtiaque Ahmed Khan, an eminent philatelist, historian, author and a multi-dimensional research scholar. He was the only Fellow of the Royal Asiatic Society from Bangladesh and a member of the Royal Philatelic Society, London. On 25 February, 2010 Bangladesh Post Office issued a special postmark to commemorate his lifetime contribution to philately.

Ishtiaque was a Gregorian. He had contributed to Banglapedia and was author of "The Meter Franking Cancellations of Bangladesh" and translated and edited "The Principles of Scientific Management".

He was also awarded the Vermeil medal by the APS Stampshow, held in 2013, in Milwaukee, Wisconsin, USA for his book "One Taka Inland Envelope of Bangladesh: A Comprehensive Study".

At the time of his demise, he was an M. Phil scholar, Management Department at the University of Dhaka. He was also a member of Dhaka Stock Exchange Ltd. Although not among us anymore, his memories remain as vivid today as it was on the day he died.

NEWS IN brief**Two accused in Ansar camp attack case arrested in Cox's Bazar**

Rapid Action Battalion yesterday arrested two alleged robbers and accused in a case filed over the attack on an Ansar camp in Teknaf of Cox's Bazar on May 13 last year.

Khairul Amin and Abul Kalam Azad were held in Kutupulang in Ukhia upazila, said Lt Col Ashequr Rahman, company commander of Rab Cox's Bazar camp.

On May 13, 2016, Ansar member Ali Hossain, 55, was shot dead and 11 firearms were looted during the attack inside a Rohingya refugee camp in Teknaf.

Criminal killed in 'gunfight' with cops

A wanted criminal was killed in a "gunfight" with the Detective Branch (DB) of police at Noljani in Gazipur early yesterday.

Badu Monir, 30, a resident of Tin-Shed colony area in BARC and an accused in 17 cases, was declared dead at Shahid Tajuddin Ahmed Medical College Hospital, said detectives. Police claimed that sensing presence of detectives, Badu and his men opened fire forcing the law enforcers to fire back in T&T colony area of Segun Bagan. Police arrested Anowar Hossain, 28, with a pistol and bullets. Two police officials received minor injuries.

Man murdered by sons in Rajshahi

A man was killed allegedly by two of his sons following a family feud in Rajshahi city's Baharampur yesterday.

Abdul Sheikh, 70, a retired peon of Rajshahi education board, was declared dead at Rajshahi Medical College Hospital. Police arrested Shariful Islam Sharif after his brother Abu Bakar Siddik Suruj filed a murder case.

Sharif owed Tk 4 lakh to Suruj. Sharif and Abu Taher Sujon, who is absconding, smothered Abdul with a pillow as he supported Suruj in demanding his money back, said Suruj. Their mother said the two threatened to kill her if she revealed this. Sharif told police that Abdul died of a heart attack during the quarrel.
