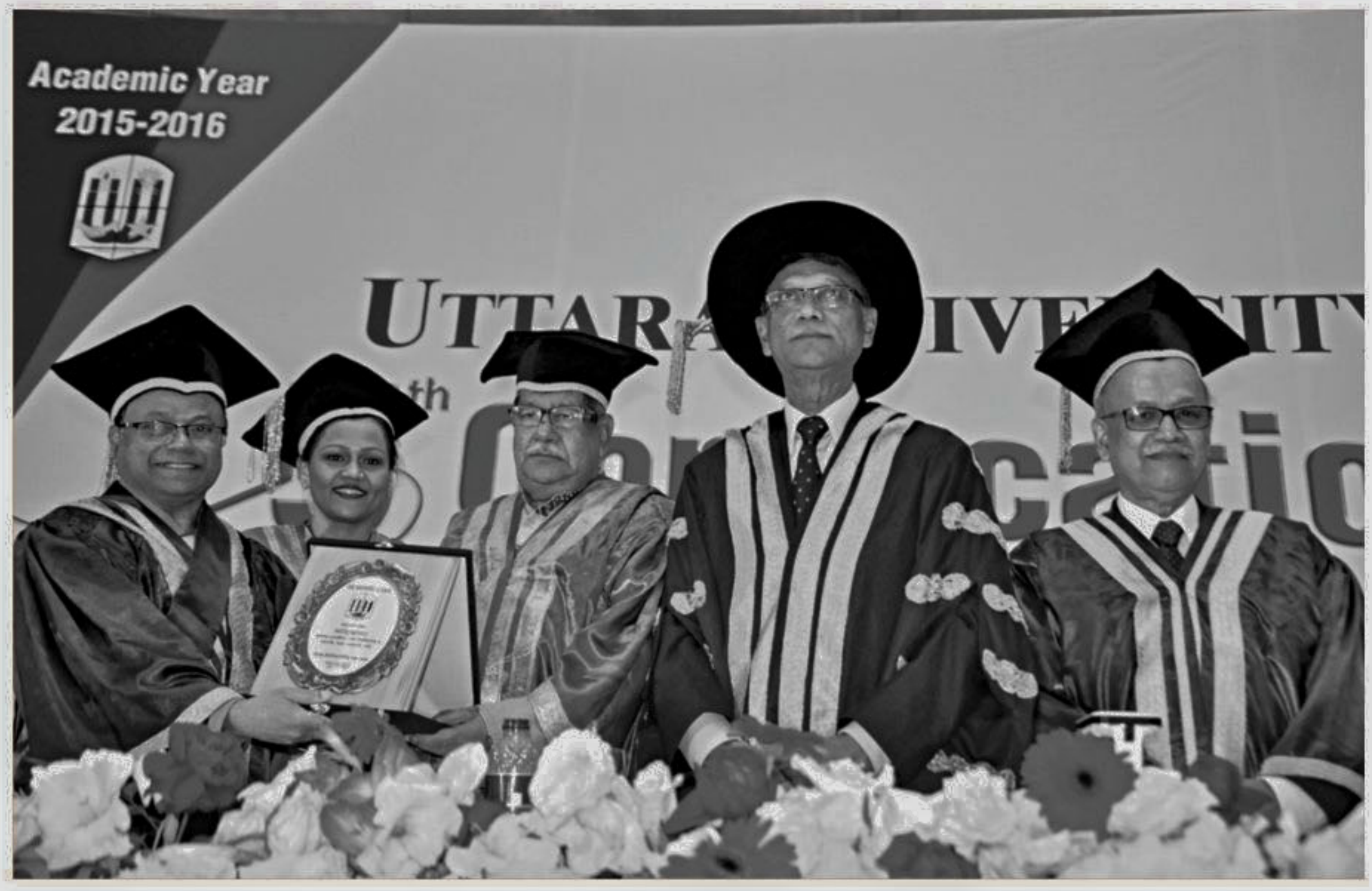

Finance Minister Abul Maal Abdul Muhith yesterday inaugurated 11 development projects in Sylhet city and its nearby areas.

The projects include five-storey Bar Hall-5 of Sylhet District Lawyers Samity, Sylhet Government High School at Lakkatura, the Liberation War sculpture "Uddipon" on Sylhet Circuit House premises, Minar at Shahi Eidgah, four roads in the city, new Sylhet Sangskrit College building, new Power Development Board building, Badaghat Polli Bidyut sub-station, Jalalabad Union Parishad Complex, and two new government primary schools.

 reported incidents of piracy and armed robbery against ships from January 1 to December 31, 2016.

A Liberia-based container "Yadanobon Star" came under attack at Chittagong anchorage on May 5 last year by seven robbers, who came in a small boat. Another Liberia-based container "Sicilia" was attacked by five robbers on June 14 in the same area.

A Marshall Islands-based bulk carrier "Sea Star" came under attack on September 14 last year at Chittagong anchorage while cargo operation was going on.

In its 2016 report, IMB recorded 191 incidents of piracy and armed robbery in the sea around the world. Pirates kidnapped 62 people for ransom in 15 separate incidents last year.

 Bashirullah told The Daily Star that the former prime minister said in her petition that Supreme Court lawyer Mamtaz Uddin Ahmed Mehedi, who is the plaintiff of the case, had no right to file such a case, as he was not a government official.

There is no ingredient of sedition in her comments for which the case was filed, he said, citing the petition.

In the case, complainant Mamtaz Uddin Ahmed Mehedi alleged Khaleda Zia on December 21, 2015 at a programme, organised by Jatiyatabadi Muktijoddha Dal marking the 45th Victory Day, said, "There are controversies over how many were martyred in the Liberation War."

The news was published in different newspapers the following day, which hurt the complainant and it was tantamount to sedition.

She also said, "He (unpronounced name of Bangabandhu Sheikh Mujibur Rahman) did not want independence of Bangladesh, he (Bangabandhu) wanted to be prime minister of Pakistan, liberation war would not take place if Ziaur Rahman did not declare independence."

A Dhaka court on August 10 last year accepted the charges against Khaleda in the case for its trial.

 On November 8, 2015, Khulna Metropolitan Magistrate Court handed down death penalty to Sharif and Mintu to death for killing Rakib.

The convicted accused then filed two separate appeals with the HC challenging their conviction and sentence handed down by the trial court.

 The DGs of Rab and Bangladesh Ansar and Village Defence Party (VDP) Maj Gen Mizanur Rahman along with other senior officials of the two agencies visited the spot and were present at the briefing.

Acting on a tip-off, a team of Rab-7 launched a drive in Kutupalang area on Monday and arrested the three for their alleged involvement in the killing of an Ansar member inside a Rohingya refugee camp in Teknaf upazila.

On May 13 last year, Ansar commander Ali Hossain, 55, was shot dead and 11 firearms along with 670 bullets were looted during an attack on an Ansar camp inside a Rohingya refugee camp in Teknaf upazila of Cox's Bazar.

Alamgir Hossain, an Ansar member in the camp, filed a case against 35 unidentified people with Teknaf Police Station.

5 HELD WITH ARMS IN NATORE
 Rapid Action Battalion in a raid arrested five people with five firearms and ammunition in Mallikhatia area of Natore town yesterday, reports our Natore correspondent.
