BCL leader found dead in Satkhira

A CORRESPONDENT, Satkhira

Police recovered the body of a local leader of Bangladesh Chhatra League (BCL) in Sadar upazila of Satkhira yesterday. The body of Sheikh Hasibul

Hassan Emon, 25, joint general secretary of Satkhira BCL and a final year honours student at Khulna Commerce College, was recovered by police from inside a shrimp farm at Amtola Beel under Dhulihor union

in the upazila, said police. Police speculated that the assailants might have killed the victim -son of Skeikh Iqbal Hassan from Sultanpur in Satkhira town -- by strangulation before dumping the

corpse in the farm area. Firoz Hossain Mollah, officer-incharge of Satkhira Sadar Police Station, said the law enforcers, informed by locals, found the body around 11:00am.

Two individuals named Sheikh Murad Hossain and Sheikh Bakhtiar Rahman from Sultanpur in the town were detained on suspicion of their involvement in the killing, he said, adding that they determined the identity of the victim with the help of a cell

Tanvir Hossain, president of Satkhira BCL, confirmed Emon's affiliation with the party.

phone recovered from his possession.

Emon's relatives said he lived in Khulna city and he came home fifteen days ago.

Sheikh Hamidul Islam Rimon, his younger brother, said the last time he spoke with his brother was around 9:30pm on Monday and he was not aware when his brother went out of the house later the same night.

The family found out about the incident around 11:00am the next day when Emon's body was recovered from the shrimp farm, he added.

The victim's body has been handed over to the family members following an autopsy, police said.

and "took away" his motorbike on January 10 from Naldanga Rail Gate area around 11:00am. His cell phone remained switched

off ever since, Nayan added.

Shapla's father Aminul Islam's version was similar to that of Nayan's as well. He said his son was picked up from Kachari Bazar area of Naldanga at the same time and on the same day.

Officer-in-Charge Farhad Imrul Qayes of Sadullapur Police Station said police were working to trace the four individuals.

Germany's top court rejects bid to ban far-right NPD party

Germany's highest court yesterday threw out a bid to ban the far-right NPD party, arguing that the xenophobic fringe outfit is too insignificant to spell a real threat to the democratic order. "The request has been rejected,"

said Federal Constitutional Court top judge Andreas Vosskuhle about the bid to ban the neo-Nazi party, which has around 6,000 members. He added that "the NPD pursues

currently no concrete evidence... to suggest that it will succeed." The case marks the second failed attempt to outlaw the National Democratic Party of Germany, with the

Helal Uddin, investigation officer of the case, said, "The probe [against Farruk] began on January 4. I am now going through records and will start field level investigation next month." Sources in the agency and the prose-

cution said formal investigation against Farruk, also one of the vicechairpersons of BNP, began after "evidence over his alleged crimes was found" in preliminary investigation.

Chief Prosecutor Ghulam Arieff Tipoo has meanwhile assigned seven prosecutors to assist the investigation officers into the probe of seven separate cases. One of the prosecutors, who was assigned to probe Farruk's alleged crimes, also confirmed the launch of investigation.

After former lawmakers Salauddin Quader Chowdhury and Abdul Alim, Farruk is the top BNP leader facing investigation for allegedly committing war crimes. Salauddin was convicted and executed in November 2015. Alim died of old-age complications while serving jail until death. BNP has always been critical about

the trial begun in March 2010 after the Awami League-led government came to power with a pledge to try the perpetrators of war crimes. On several occasions, BNP leaders alleged that the ruling party were using the trial as a tool to eliminate political opponents, something the AL always refuted.

Son of Muhammad Osman Ghani, a former vice-chancellor of Dhaka University, Farruk was an assistant professor of the then East Pakistan

Agricultural University (now Bangladesh Agricultural University) in 1971. He was elected lawmaker from Kishoreganj-4 in 2001 and became the education minister of BNP-led fourparty government.

started a preliminary probe into alleged crimes Farruk and 10 other teachers of the university committed in 1971.

"Documents show that Osman Farruk was involved with antiliberation forces," agency's coordinator, Abdul Hannan Khan, told reporters that day.

Sanaul Huq, coordinator of the investigation agency, told The Daily Star that during investigations in a case against Jatiya Party lawmaker MA Hannan of Mymensingh, they had learned that the Pakistani occupation army set up a torture cell turning the university into a cantonment.

He added they had obtained a secret intelligence report prepared in 1972 stating about some teachers' antiliberation activities. On Furruk, the report wrote, "[he]

Had regular meetings with army officers; invited them to his house for tea, dinners, etc; used to speak against the Mukti Bahini and Awami League leadership publicly and support strongly the army actions; used to work as an informer for Pakistan army." An investigator, who was involved

in the preliminary investigation, told The Daily Star yesterday that there was an anti-liberation group centring the university and Osman Farruk was a member of that group. The investigator declined to give details. Replying to a question, IO Helal

Uddin said if they found evidence of involvement of other teachers, they would also be booked. The Daily Star tried to contact

Farruk over phone but could not reach him. Earlier on May 4 last year when agency talked about preliminary investigation against him, he termed the allegations "totally false and baseless."

No long-term solution sans stopping violence

Says Swedish envoy

Swedish Ambassador to Bangladesh Johan Frisell has said it is clear that no long-term solution to the Rohingya crisis can be found unless violence in Rakhine state of Myanmar comes to an end. "The humanitarian situation is

serious for the newly arrived refugees With the impressing efforts by different agencies and organisations, we hope that the needs will be met," he said yesterday. Three Nordic ambassadors to

Bangladesh -- Johan Frisell, Denmark's Mikael Winther and Norway's Sidsel Bleken -- visited Cox's Bazar on January 15-17. The purpose of the visit was to

gain a better understanding of the

humanitarian situation for official

and undocumented Rohingya refugees, and to meet with UN agencies, NGOs and local authorities. The recent influx of Rohingyas from northern Rakhine state of Myanmar was a special focus of the visit. The extensive three-day

programme included visits to Leda makeshift camp and Nayapara Registered Camp as well as the camps in Kutupalong. Frisell said this visit shed light on the complex challenges of the refugee

situation in the Cox's Bazar. "I appreciate the efforts that the government of Bangladesh is undertaking to address the situation. Sweden is contributing through support to UNHCR and IOM. We have recently entered into a cooperation with the NGO "Action contre la Faim" in support of their nutrition programme.' Norway's envoy Bleken said, "I'm

impressed how the government of Bangladesh and humanitarian organisations have handled the current influx of more than 65,000 Rohingyas escaping atrocities and violence in Myanmar." "My impression after our visit to

Nigeria accidental air strike

One local resident, Abba Abiso, told AFP: "At least 25 were killed and many more injured."

The medical charity Doctors Without Borders (MSF) said "at least 120 people were wounded and 52 killed following today's bombing", calling the attack "shocking and unacceptable." The International Committee of the

Red Cross (ICRC) said six Nigerian Red Cross members were among those killed while 13 others were injured. Nigeria's President Muhammadu Buhari said in a statement he "received

with regret" news of the bombing and

said he sympathised with the families of the dead and injured. The bombing comes as Nigeria's military claims further gains against the Islamic State group affiliate, pushing them out of captured territory and

their remote bases in Borno. Last month, the army said the conflict was in its final stages after nearly eight years of violence that has killed at least 20,000 and left more than 2.6 million others homeless.

'FOG OF WAR'

Nigerian Army Major General Lucky Irabor, who heads operations against the militants, said the air force had been given coordinates of "Boko Haram terrorists" in the Kala-Balge area. "Unfortunately the strike was con-

ducted but it turned out that the locals somewhere in Rann were affected," he told reporters at a briefing in the Borno state capital, Maiduguri. Irabor did not give casualty figures

but said local staff from MSF and the ICRC were among those wounded. "These are the result of fog of war," he

added. "It is unfortunate. That is the reason why this war must come to an end." Defence spokesman Rabe Abubakar in Abuja described the incident as "a mistake", adding: "We

are actually in grief. It's unfortunate

and it's really not intended." Rann resident Abba Abiso suggested the error occurred as the military was targeting rebel fighters who had been flushed out of Boko Haram camps in the Sambisa Forest area of Borno.

"In recent weeks Boko Haram has moved base to Kala from Sambisa Forest and obviously a military jet mistook Rann for Kala and bombarded, killing many civilians," he added. MSF and the ICRC said its teams

were trying to provide emergency first aid at its facility in the camp and were stabilising patients to evacuate the wounded from the scene.

But Jean-Clement Cabrol, MSF's director of operations, condemned the error.

"This large-scale attack on vulnerable people who have already fled from extreme violence is shocking and unacceptable. The safety of civilians

said, "I asked my cousin Hridoy to create a Facebook ID [of him] using my mobile phone. But then I didn't use the ID." He kept the phone at home and

went for fishing. "I had been fishing in Balinga Beel for a week. As soon as I came back some people started beating me. They didn't give me any scope to say anything.

"The mob dragged me to the bazaar. Many people gathered there at the time.

They then handed me over to police." Narrating his days filled with trauma, he said he was now happy that
