The High Court yesterday summoned the industries secretary to appear before it on February 7 for placing explanation over collecting compensations from tannery owners at Hazaribagh in Dhaka for damaging the environ-

The HC passed the order following a petition filed by Human Rights and Peace for Bangladesh (HRPB) recently.

Petitioner's counsel Manzill Murshid told reporters that the HC in June last year directed the tanners to compensate Tk 50,000 per day each for damaging the environment until they relocate their industries to Savar.

The Appellate Division of the Supreme Court in July, 2016 ordered each of the tanneries to compensate Tk 10,000 per day after modifying the HC directive, he said.

# HC bans 3-wheelers on highways

Govt asked to submit reports in every six months

The High Court yesterday imposed a ban on plying of improvised motorised three-wheelers, known as Nasimon, Karimon, Bhatboti, on highways across the country to reduce the number of road crashes. The court directed the govern-

ment to take legal action against those who will run such poorly engineered locally made vehicles on the highways defying the ban. The HC also asked the authorities

concerned to submit reports on compliance of the directives before the illegal vehicles on the highways. court in every six months.

Yesterday, the bench of Justice Salma Masud Chowdhury and Justice Kazi Md Ejarul Haque Akondo came up with the verdict after hearing a writ petition filed by the Human Rights and Peace for Bangladesh seeking necessary orders

Following the petition, the HC

earlier on February 10, 2014, had ordered the government to withdraw theses vehicles from highways in 10 districts -- Jessore, Khulna, Jhenaidah, Magura, Meherpur, Satkhira, Bagerhat, Norail, Kustia and Chuadanga. During hearing earlier, peti-

tioner's counsel Manzill Murshid told the court that hundreds of people across the country lose their lives everyday due to plying of unfit and

Earlier on July 27, 2015, Road Transport and Bridges Ministry also issued an order, banning the threewheelers and other slow-moving and unfit vehicles on 22 highways to curb road accidents and loss of lives. The order came into effect on August 1.

A day after enforcing the ban,

to stop plying of these vehicles on transport owners and drivers on August 2, 2015, put barricades on different highways protesting the ban and clashed with law enforcers, leaving at least 20 people injured and 75 vehicles damaged.

Later, Road Transport and Bridges Minister Obaidul Quader and Road Transport and Highways Division Secretary MAN Siddique at several programmes announced that the ban would strictly be enforced.

But these slow-moving vehicles are still plying defying the ban.

Talking to The Daily Star, Kazi Md Shifun Newaz, assistant professor of Accident Research Institute (ARI) of Buet, said operation of such vehicles is one of the major causes of accidents on the highways.

He also underscored the need for constructing separate lanes for such vehicles considering huge public demand for these vehicles.

#### ASSAULT ON PRO-VC BSMMU fails to reach consensus

Bangabandhu Sheikh Mujib Medical University (BSMMU) until yesterday failed to reach a consensus as per the advice of the health minister. On Tuesday, Health

Minister Mohammad Nasim asked the BSMMU authorities, when the latter met him, to follow alternative rules in recruiting the nurses since the allegation of corruption came to the fore over the issue.

He also directed BSMMU Vice Chancellor Prof Kamrul Hassan Khan to apologise to Pro-VC [Academic| Prof ASM Zakaria Swapan for his reported assault on the latter on Thursday over publication of a report in a newspaper on the nurse recruitment.

But the consensus had yet to be reached until yesterday as the pro-VC [academic] quit the meeting hearing the VC's proposal to recruit nurses from those qualified in the written exams, according to the top officials of the country's lone medical university.

The pro-VC told the VC that the minister asked them to follow other rules since previous examination process was shrouded in question, said the sources. As the VC remained stuck to his decision, the pro-VC left the meeting.

Contacted, BSMMU pro-VC [administration] Prof Sharfuddin Ahmed said both the VC and the pro-VC agreed to work together on the routine affairs of the

university and the hospital. "We will talk to the minister again and take his opinion to finalise the nurse recruitment process," he told The Daily Star.

The High Court yesterday fixed January 29 for delivering verdict on a petition seeking its directive on the government to stop telecast of three Indian television channels -- Star Jalsha, Star Plus and Zee Bangla -- in Bangladesh.

Syeda Shahin Ara Laily, a Supreme Court lawyer, submitted the petition to the HC in September 2014, saying programmes broadcast by the three channels left adverse impact on social and cultural life of Bangladeshi people.

Education of the students and regular activities of housewives are being hampered due to watching the channels' programmes, she mentioned in the petition.
