

The High Court has cleared the way for eminent jurist Mahbubey Alam to continue running as attorney general of the state.

The court on Tuesday summarily rejected a writ petition that challenged the legality of holding the office of chief law officer of the republic by Advocate Mahbubey Alam.

The bench of Justice Naima Haider and Justice Abu Taher Md Saifur Rahman passed the rejection order saying that the petition, moved as a public interest litigation, is not acceptable as the post of AG is not a public office, petitioner's lawyer Advocate Eunus Ali Akond told The Daily Star.

He said he will move an appeal before the Appellate Division of the Supreme Court challenging the order after receiving its certified copy.

On November 10 last year, Advocate Eunus filed the petition saying that the president appointed AG Mahbubey Alam under Article 64 (1) of the Constitution. Under this article the president shall appoint a person as AG who is qualified to be a SC judge and the age limit of SC judge is 67 years.

Mahbubey Alam turned 67 on February 17 last year and he cannot hold the office of attorney general any more, Eunus Ali said in the petition.

Cable TV operator evades Tk 10cr tax thru hundi

The Rajshahi-based agency used to send Tk 25 lakh a month to three countries including India

New Uttara Communications, an illegal cable television network operator in Rajshahi city sent at least Tk 25 lakh every month to three countries --India, Thailand and Indonesia, running pay channels through piracy.

The operator incurred the government a loss of at least Tk 10 crore in taxes in last three years operating without any license by setting up a few dozen of dish antennas on the roof and installing downlink and broadcast servers inside of a rented house in the

city's Pathanpara area. A mobile court of Rapid Action Battalion led by executive magistrate Sarwar Alam revealed the facts during the ending hours of a raid at the

Amid desperate efforts to find him, police on November 15 last year collected DNA samples of his parents, which matched with those of an unknown body recovered from the Buriganga river on October 9, 2015, and buried

HC bail lets five out of jail

The High Court yesterday granted bail to five under-trial persons of Kashimpur jail, who have been suffering in custody for 11 to 14 years, in separate cases.

The accused prisoners are: Russel Sheikh, Mohammad Parvez, Masud, Liton and Babu The HC bench of Justice Md

Nuruzzaman and Justice SH Md Nurul Huda Jaigirdar also directed the lower court concerned to complete the trial proceedings against two other prisoners -- Saidur Rahman and Rajib Hossain in the next three months.

They gave the orders after hearing a December 15, 2016 HC rule, asking the government to explain why the seven should not be granted bail.

The bench of Justice M Enayetur Rahim and Justice JBM Hassan issued the rule following a report broadcast by private television Channel 24 on December 9, which said there was little progress in lower court trial proceedings of the criminal cases against the seven.
