2 more public universities in Jamalpur, Netrakona

The government has decided to set up two more public universities in the country to accommodate more students.

Bangamata Sheikh Fazilatunnesa Mujib Science and Technology University would be set up in Jamalpur's Melandah and Sheikh

Hasina University in Netrakona. The decision came at the weekly cabinet meeting yesterday, with Prime Minister Sheikh Hasina in the chair. The meeting approved two laws to this end.

Briefing reporters after the meeting, Cabinet Secretary Mohammad Shafiul Alam said the existing Bangamata Sheikh Fazilatunnesa Mujib Fisheries College in Melandah would be upgraded to a science and

technology university. Sheikh Hasina University would be established as per the demand of Netrakona residents, he said, adding that the initial plan was to set up a science and technology university in

FROM PAGE 1 Contacted, Shahidullah confirmed that the probe report had been submitted to the SC registrar general's office. He, however, refused to disclose the contents of the report.

On December 14 last year, the HC bench of Justice Obaidul Hassan and Justice Krishna Debnath directed the chief judicial magistrate to conduct an enquiry to find out whether police were involved in setting fire to Santal houses during the eviction drive in Gobindaganj upazila of the district.

In response to a writ petition by three rights bodies, the court asked him to track down those involved in the arson and submit report to it within 15 days.

Later, the HC bench gave more time to the chief judicial magistrate to finish the probe and asked him to submit report by January 31 (today).

The December 14 directive came after different national and global media outlets aired a video content in which a policeman in uniform and a man in a half-sleeve shirt are seen apparently joining another in a pink Tshirt in setting fire to a Santal shanty. The video clip went viral in the social media.

Santals have all along alleged that it was police personnel who had torched their houses. But the district police rejected the allegation and claimed miscreants did it and they are yet to be identified.

During the eviction drive on November 6, three Santals were killed in an ensuing clash with Rangpur Sugar Mills staff and police.

At least 25 people, including nine cops, were injured in the incident.

Several Santal homes were burned down. In further violation of human

rights, police handcuffed three injured Santals who were arrested in a case filed for "attacking police with arrows" during the clash. Choron Soren, one of 42 people

named by police in the case, was shot in the legs. His fellow Santals sent him to Rangpur Medical College Hospital on the night of November 6.

The following morning, he found one of his hands handcuffed to the

Two other handcuffed Santals were at the National Institute of Ophthalmology in Dhaka.

Their handcuffs were removed following an HC order on November

THE PETITION

Ain o Salish Kendra, Brotee, and Association for Land Reform and Development (ALRD) filed a writ petition on November 16, seeking HC directives upon the government for ensuring security of lives and property of the Santals.

On December 13, they submitted a supplementary petition to the court, attaching to it copies of media reports on the alleged police involvement in the arson.

In its order, the HC bench on December 14 also directed police to take two Santal men's complaints as first information report and probe

Bithi called her mother back home on January 20 and informed her about the danger she was in.

The following day, the three gang members took Bithi to a trip nearby and later booked a hotel room. She was confined to the room and forced to have sex with Anwar and Opu.

"Brishti filmed all these with a camera," Bithi alleged.

Opu took Brishti to a clinic as she fell sick. Opu wanted to introduce Bithi as her wife at the clinic, but she refused

Eminent educationist Prof Abul Kashem Fazlul Haque said the issue of making a law on the EC was discussed at the meeting.

"We said there is still a chance to enact a law. There is no election in near future. There would be no problem if the posts of commissioner remain vacant for the next one or two months. It would be good if the election commission is constituted after the enactment of the law," he said.

Sujan Secretary Badiul Alam Majumdar said that once the names for the posts of commissioner are finalised, those should be made public to get people's opinion on them.

Briefing journalists, Cabinet Secretary Mohammad Shafiul Alam said the civil society members made

valuable suggestions on the possible criteria for picking the right persons for the next EC. "The majority of them suggested picking non-partisan persons, who are

Schoolboy killed in city

A schoolboy was stabbed to death in the capital's Jatrabari yesterday. The victim, Ridwan, 11, was a seventh-grader of

Narinda High School. The incident happened around 3:30pm when Al Amin, a local youth, stabbed Ridwan outside his house in Golapbagh area, Anisur Rahman, officer-in-charge of Jatrabari Police

Station, told The Daily Star. The victim was rushed to a local hospital and then shifted to Dhaka Medical College Hospital where doctors

declared him dead, the OC said. After the incident, Al Amin went into hiding, the police said, adding that the motive behind the killing could not be

known immediately. Victim's family members alleged that Al Amin demanded money from them when they were constructing a house last year.

As they refused to give him the money, Al Amin killed Ridwan, they suspected.

Police said Al Amin stands accused in several cases.

Female 'Pir' Murder Police clueless about motive

Though a day has passed after the killing of so-called female "pir", police were still clueless about the motive behind the murder.

Police recovered the victim's slitthroat body from her tin-roofed house near the Martyrs' Graveyard in the capital's Mirpur on Sunday.

Masud Ahmed, deputy commissioner (Mirpur division) of Dhaka Metropolitan Police, told The Daily Star yesterday that they came to know that there was a gold ring on the victim's finger. They did not get the ring after the murder.

"We are suspecting that someone killed her for the gold ring," he said. Selimuzzaman, officer-in-charge of
