TEACHERS CONTINUE STRIKE

Ruet students fear session jam

Students of Rajshahi University of Engineering and Technology (Ruet) are in fear of facing a session jam as teachers refrained from taking classes and examinations for the second consecutive day as part of their indefinite strike demanding punishment for students who had confined them during their demonstration for cancellation of "33 Credit System".

Some students of 2012-13 session said their final examination is scheduled to start on February 14. If the strike continues they will face a session jam. All the students should not suffer due to the ongoing situation since only a section of students took part in the demonstration, they added. Earlier on Sunday, Ruet Teachers' Association declared the

indefinite strike demanding punishment for the students who confined teachers including the vice chancellor for nearly 20 hours from Saturday evening during their demonstration demanding cancellation of the credit system. Nirendranath Mustafi, president of Ruet Teachers'

Association, said teachers were shamed and insulted during the confinement. Ruet VC Rafiqul Alam Beg told The Daily Star, "We are planning to have a meeting with the teachers' association on

this issue. Decision can be made after the meeting." Mentionable, on January 28, a section of students of 2014-15 and 2015-16 sessions started demonstrating demanding cancellation of the "33 Credit System" which was introduced in 2013. Later, the Ruet authority cancelled the credit requisite on Sunday.


President's Press Secretary Joynal Abedin briefed reporters after the meeting.

Acute gas crisis cripples Ctg life

An acute shortage of gas supply in many parts of the port city over the past week has been disrupting everyday life of the city residents.

Less than normal supply of gas from the national grid is causing this shortage, said officials at KGDCL (Karnaphuli Gas Distribution Company Limited). The KGDCL is responsible for

distribution of gas to the city after receiving it from the national grid. The situation deteriorated in the

Chittagong region recently as the KGDCL is now facing a shortage of at least 70 million metric standard cubic feet (MMCF) of gas each day, the KGDCL officials explained.

Moreover, the recent resumption of gas supply to Chittagong Urea Fertilizer Limited (CUFL) might have added fuel to the crisis, they said, adding that the supply to both

households and industries have been affected since they started supplying gas to the CUFL on January 20.

Star around 2:30pm yesterday, Nandan Kanan resident Rupa Dutta, a physician by profession, said the pressure of gas in her house has been too low for cooking lately. "I started cooking at 10 in the morning, but I still couldn't finish it. Usually it takes only an hour and a half for me to finish all my cooking."

morning," said Alamgir Hossain, a resident of Bakalia area, "I haven't been able to take lunch from my house for over a week now." He has been feeding restaurant

food to his family members, especially in the mornings, Alamgir said.

"The gas supply resumes around 3:00pm for nearly an hour when my wife starts cooking lunch for all. She has to do most of her cooking after 11:00pm when the supply becomes normal."

Asked about the crisis, Anupam Dutta, manager (load monitoring) at KGDCL, admitted to have received complaints, from consuming gas shortage in the mornings and in the evenings. "In fact we cannot do anything at

present to address the situation

since the volume of gas we are

receiving from the national grid is

less than normal." "Currently we are getting 220 MMCF to 230 MMCF from the national grid," as opposed to "our daily demand of 450 MMCF," he said, adding that they usually

receive around 300 MMCF daily. When asked if they were able to take any measure to ease the situation, Anupam said last week they stopped gas supply to the gas-fired Raozan Thermal Power Plant to make up for the shortage, but it did not improve the situation to a noticeable extent.

In addition, they spoke with Petrobangla officials who had assured them of taking necessary measures to remedy the situation.

LAND PURCHASE SCAM RU replies to UGC letter, comes up with new figures

The Rajshahi University authorities yesterday replied to the letter of the University Grants Commission (UGC) that sought explanation from RU regarding the allegations of corruption and irregularities in the Tk 14-crore procurement of a land with high-rise building for the institute's guesthouse in Dhaka.

RU Registrar Prof Entajul Haque said, "In reply, we sent them (UGC) the same statement we gave the journalists [on Monday]."

Earlier on Sunday, Dr Ferdous Zaman, additional director of public university management department of the UGC, in a letter asked the RU registrar to explain the issue within seven days. The Daily Star obtained a copy of the letter.

The statement -- signed by RU Pro-Vice Chancellor Prof Chowdhury Sarwar Jahan -sent to journalists on Monday, came up with new facts and figures, dissimilar with those approved by the syndicate earlier. ers living in different areas, regard-The statement now claims

the RU authorities did not purchase any land individually, they bought a building along with its land. They gave a break-up of the total expenditure showing a new value of the seven-storey building was Tk 10.88 crore. The rest 2.37 crore was being spent on the building's registration, ownership transfer fees and boundary wall construction.

But the Hatirpool land deed shows it was bought at Tk 3.50 crore on October 20, 2016 and the university's syndicate on November 29, 2016 approved that they bought the land at Tk 11 crore and they were constructing a seven-storey building at Tk 2.25 crore on the land.

Habiganj tea workers again on strike against SEZ

After fourteen months of agitation, tea garden workers in Habiganj's Chunarughat upazila yesterday again started work stoppage from 8:00am to 10:00am demanding cancellation of a special economic zone (SEZ) construction project in the area.

They said they will keep continuing it for an indefinite period. The government in 2015 announced that it will build a SEZ on around 512 acres in Chandpur under its Economic Zones Development Project to attract both foreign and domestic investments.

But the workers started protesting against the decision in December 2015 as the SEZ is planned to be built on the land where they have been cultivating crops for survival for movement if the project is not cancelled.

The protest started again as the assistant commissioner (land) of the upazila forbade the workers on Monday to farm the land, and also sized four tractors with police's help, said demonstrators including workers of Chandpore Tea Estate, Ramgonga Tea Estate, Begumkhan Tea Estate and Jual Bangla Tea Garden. Atit Bakti, only bread earner of a five-

member family, said, "We will starve to death, if the government acquires the land." Nripen Paul, GS of Bangladesh Cha Sramik

Union, said, "We have been living and cultivating here for more than 150 years, but still we do not have the ownership of the land," The protesters threatened to wage tougher

Ali Akbar, however, denied the allegation and claimed that the whole incident was part of a conspiracy against him.

"The ACC officials did not find any money [bribe] from me and I only have Tk 324 on me," he claimed while speaking with reporters.

Meanwhile, our staff correspondent in Dhaka reports that the ACC yesterday arrested Sirajul Islam Mir, director of Mir Enterprise, for misappropriating about Tk 9.34 crore of Janata Bank.

According to case document, Mir Enterprise opened 24 back-to-back Letters of Credit (LC) for Chowdhury Towel Industries Ltd and Chowdhury Knitwear, but the firm did not import or export any goods against the LCs.

Sirajul, in collaboration with officials of the bank's Ramna corporate branch, produced fake documents to embezzle Tk 9,34,84,537 from the bank, said sources at the ACC. Sirajul was arrested from Dhanmondi in connection with the case filed with Paltan Model Police Station on February 6, 2015.
