HarvestPlus, a biofortified food crop development initiative that helped Bangladesh release world's first zinc-enriched rice variety in 2013, has won prestigious "LAUNCH Innovator" recognition for 2017.

It has won the recognition along with 11 other innovators selected from a pool of 280 applicants from 74 countries, a release said yesterday.

The United States Department of Agriculture (USDA), the US Agency for International Development (USAID), National Aeronautics and Space Administration (NASA), and NIKE Inc. jointly founded LAUNCH in 2009 to build a community of

innovators. Since 2013 release of first biofortified zinc rice -- BRRI dhan-62 -- which is also the most early-maturing variety ever released for Aman season, the Washingtonbased HarvestPlus helped scientists in Bangladesh to

Arrested war crimes Over 50 quizzed but suspect sent to jail

Decision on charge framing against five Patuakhali men on March 8

The International Crimes Tribunal-1 yesterday sent a war crimes accused from Mymensingh to jail after police produced him before it.

Rustam Ali, 70, was arrested in Kendua Kalibari area of Jamalpur Sadar upazila on Wednesday hours after the tribunal ordered the arrest of three men who allegedly committed crimes during the Liberation War of 1971.

Police could not arrest the two others, prosecutor Abul Kalam told The Daily Star yesterday.

The three accused are originally from Muktagacha of Mymensingh but two of them including Rustam were living in Jamalpur and another in Panchagarh, sources said, adding, they were involved with the Razakar Bahini, a group of Pakistani collaborators.

The tribunal earlier issued arrest warrant against six other accused of the case. Of the six, Suruj Ali Fakir, Abdur Rahim, Abdus Salam, Joynuddin Faruki and Jalal Uddin -- were SEE PAGE 4 COL 1

Seven months have already passed but the investigators are yet to make any headway in the probe into the murder of Mahmuda Khanam Mitu -- wife of former superintendent of police Babul Akter.

Additional Deputy Commissioner (North) of Detective Branch (DB) of Chittagong Metropolitan Police (CMP) Mohammed Kamruzzaman said, "We have been working. So far, we have quizzed more than 50 persons as part of the investigation and we would interrogate more people."

"Recently many juicy stories are being published in newspapers. I am keeping an eye on those and cross-checking whether there is any clue and relevant issue," said Kamruzzaman, also investigation officer

(IO) of the Mitu murder case. In addition, the IO said he had

recently visited Cox's Bazaar, Rangunia, Bandarban and some other places for the sake of the murder investigation.

It cannot be said for sure when the charge sheet of the murder case will be submitted, he said.

About the recent discussion with Mitu's parents, he said they demanded punishment for their daughter's killers. They also discussed many issues relating to the life of Babul and Mitu before and after marriage, he added.

Asked if the family raised the issue of extramarital affair as a motive behind the murder, the IO denied giving further detail.

Militants recruiting thru social media

Says police chief Shahidul Hoque

Militant groups are using social media to inspire people towards militancy, Inspector General of Police AKM Shahidul Hoque said yesterday.

"Till now, most people arrested for militancy were found to have been motivated through Facebook," he told a freshers' reception programme of Dhaka University's Social Welfare and Research Institute on the campus. Cautioning the social media users, Shahidul Hoque said

police were not only bringing radicals to justice but rather trying to bring them back on the right track from radicalisaiton. Bangladesh is a global role model in preventing militancy, he claimed. The IGP, however, identified militancy and drugs as the two biggest problems of the country and asked students to stay away from these.

If anyone is found involved in any crime in educational institutions, the offender must be punished irrespective of his or her political loyalty, said Hoque, a former student of the institute.

"It's painful for us to take cases against students. However, when they commit serious crimes we end up with no choice." Talking about community policing, he said a distance was created between police and people in the colonial period, but police were now trying to serve the people by closing the gap. Urging people to assist police, he said the success of the justice system was dependent on police investigation. Director of the institute, Prof Tania Rahman, chaired the programme.
