Worker killed in wall collapse at Baridhara

3 injured STAFF CORRESPONDENT

A female labourer was killed and her three co-workers were injured when a wall fell on them at a construction site in the capital's Baridhara Society yesterday.

Bedena, 35, who had joined work only the day before, was declared dead on arrival at United Hospital Ltd. She hailed from Netrakona.

The injured, Mahbub Alam, Azibur and Abdul Khaleque, are being treated at Kurmitola General Hospital.

The four were clearing rubble and dirt from a ditch when the adjoining eight-foot tall wall on plot-7 fell on them around 9:30am, Gulshan Police Station Sub-Inspector Sheikh Shahanur Rahman told The Daily

A coworker who was several yards away said he had heard "a loud thud" and saw the injured pinned down by large sections of the wall and only one hand of the deceased sticking

"All but the woman were crying for help," said Asadaur Rahman, the coworker.

This correspondent found two large piles of stone and sand, which had been apparently resting against the wall, occupying a portion of the adjacent Road 13. Baridhara Society Security-in-

Charge Mojibur Rahman said they had verbally asked the authorities carrying out the construction to remove the piles a week ago but to no

Gulshan police said they would try to identify the owners and construction authorities today. An unnatural death case has been filed.

FROM PAGE 2 Rohingya minority citizenship, failing to protect them and itself perpetrating rampant and systemic violation of their human rights, including restrictions on movement; limitations on access to health care, livelihood, shelter, and education; arbitrary arrests and detention; and forced labour".

The statement said Myanmar's discriminatory citizenship policies also "refuse" to cooperate in the repatriation of Rohingya.

"The Bangladeshi government needs to treat the persecuted Rohingya humanely," Adams said. "Instead of dumping Rohingya on a flooded island, the government should be seeking immediate donour support to improve existing conditions for the refugees".

Between 300,000 and 500,000 Rohingya Muslim refugees, most of them unregistered by the authorities, are in Bangladesh after fleeing persecution in Myanmar dating back to the 1990s, said the statement.

Since October 2016, nearly 69,000 Rohingya from Rakhine State in Myanmar have entered Bangladesh to escape attacks by Myanmar security forces, including killings, sexual violence and "wholesale" destruction of villages, it added.

Md Ibrahim Khalil, additional superintendent of police of Rab-4, told The Daily Star that while investigating some recent complaints of threats, they found a mismatch between customers' information and their addresses. Later, it was found SIM distributors and sales representatives were using false information for selling new SIM cards, he said.

Based on information, Rab raided MR Communication's office and found its staff using false addresses, printing fake national ID cards, and attaching copies of them to SIM card registration forms, in presence of the Banglalink zonal manager, he said.

Khalil said the distribution agency gave targets to its sales agents to sell at least 8,000 SIM cards per month. In a hurry, the sales agents just took finger prints and the national ID numbers to activate the SIM cards and give them to customers but they did not take photos or other informa

Later, they used to fill a fake form and attach copies of fake national ID cards and photos with it, said Khalil. "Because of this, we did not find the customer addresses."

A case was filed with Pallabi Police Station.

Asif Ahmed, head of Corporate Communications of Banglalink, in a statement, said, "We will further investigate when officially informed of this particular case. Banglalink is a compliant organisation guided by a strong code of conduct. Banglalink operates its business as per rules and regulations of the Bangladesh government. If any of the business partners is found to be involved in malpractice, we take immediate action."

The frog bit the bird's head and pulled it under water until its heart stopped beating -- the same technique crocodiles usually apply. After a while, the frog came ashore with the bird's motionless carcass and dragged it

into a bush. I have seen shrikes attacking frogs and snakes many times, but this time the opposite happened. It was an incredible experience that I can hardly put into words. How the ecosystem balances everything so nicely, what

Last week, US ties with staunch ally Australia became strained after the Washington Post published details about an acrimonious phone call between Trump and Prime Minister Malcolm Turnbull. "That is the last thing China

wants," a source familiar with China's thinking on relations with the United States told Reuters. "It would be incredibly embarrassing for President Xi and for Chinese people, who value the concept of face." A senior non-US Western diplomat

said China was unlikely to be in a rush to set up such a call.

"These things need to happen in a very controlled environment for China, and China can't guarantee that with the unpredictable Trump," the diplomat said.

"Trump also seems too distracted with other issues at the moment to give too much attention to China." There are a number of contentious

areas where China fears Trump could go off script, the diplomat said, pointing in particular to the issue of selfruled Taiwan, as well as trade. Trump upset China in December by taking a phone call from Taiwan

President Tsai Ing-wen. China considers Taiwan a wayward province with no right to formal diplomatic relations with any other country. Trump has also threatened to slap tariffs on Chinese imports, accusing Beijing of devaluing its yuan currency

and stealing US jobs. In his Senate confirmation hearing, US Secretary of State Rex Tillerson said China should not be allowed access to islands it has built in the disputed South China Sea. The White House also vowed to defend "international territories" in the strategic waterway.

China has repeatedly said it has smooth contacts with the Trump team. The Foreign Ministry in Beijing said last week the two countries were

According to the draft, a boy below 21 and a girl below 18 should be considered under-aged and so should be ineligible to marry. Such marriages, except for the special cases for girls, should be treated as child marriage. Women and rights bodies have

been demanding cancellation of the "special provision" since the cabinet approved the draft of the proposed law in November last year.

The government had faced a wave of criticism when it, more than two years ago, planned to lower the minimum marriage age for girls to 16. The provision put forward at the time was such that a 16-year-old girl would be allowed to marry with her parents' consent or a court's permission obtained on justified grounds.

Amid protests, the government backtracked on that position but in the final draft left the scope for special

The Jatiya Sangsad committee also recommended replacing the word "parents" with "parents or guardians where necessary" and punishing girls for violation of the law. The original bill had provisions for punishing boys only.

Its report suggests that the time of detention be increased from 15 days to 30 days and fine from Tk 5,000 to Tk 50,000.
