Refreshment betters kids' school performance

Midday meal programme benefits 2 lakh primary children in Noakhali

Admission, attendance and pass rates of government primary school students in nine upazilas under district have seen significant improvement during the last one year, thanks to the introduction of midday meal to provide refreshment to the kids during school hours. The programme, brainchild of

Hazera Khatun, headmistress of Charbata Primary School in Subarnachar upazila, gained tremendous success solely depending on the guardians' cooperation, without any grant from any government or non-government organisa-Hazera initiated the programme

at her school early last year and seeing the success, other primary schools in the district started introducing it in phases. Now 1.99 lakh 120 students of

1,213 primary schools in nine upazilas of the district are getting the benefit of the programme. They attend school from 9:00am 4:00pm daily.

However, 64 schools in the district are yet to introduce the programme.

At the beginning of the programme, mothers' rallies were held at the schools where they were made aware of giving children regular nutritious food and the bad effects of not taking meals on time by the school children. School bags and tiffin boxes for

the school children were bought with the money collected from the



among the students.

The mothers were advised to give rice, bread, eggs, khicuri, chira (beaten rice), muri (puffed rice), vegetables etc in the tiffin boxes of their children.

"After introduction of midday meal, students' attention to classes has improved. They are doing better results," said Hazera Khatun, headmistress of Charbata Primary School in Subarnachar upazila in the district. Nuruzzaman, a small trader at a

local bazaar, said, "When I started giving home-made tiffin to my two kids reading in Class V and Class IV, they became more interregularly.

Class V at Dakkhin Char Jabbar Model Government Primary School, said they enjoy taking midday meal with other classmates during the tiffin period. Md Harun-or-Rashid, upazila

nirbahi officer of Subarnachar, said all the 90 primary schools in the remote upazila have been brought under the midday meal programme. "Now the admission rate of the

children in the upazila is 99 percent and the pass rate has reached 100 percent. The drop out percentage has come down to zero from earlier

"The success could be Hasib and Nayan, students of achieved as the guardians have become aware of the importance of nutrition for attention to study. Sincerity of the local administration, teachers and guardians of the schools concerned is enough for introducing the programme all over the country," he said.

Noakhali District Primary Education Officer Anwar Hossain said introduction of midday meal programme in the primary schools has greatly helped to ensure children's regular attendance at classes and improve their performance.

BCL leader beaten dead by rivals

A local leader of Bangladesh Chhatra League (BCL) was killed allegedly by his rivals at Navaron Bazar in Sharsha upazila of Jessore on Saturday night, reportedly over establishing supremacy in the area.

The deceased, Biplob Hossain, 18, son of Nazrul Islam of Jirengachha village in the upazila, was the vice-president of Ulasi union unit of BCL. Quoting locals, police said there had been a longstanding

rivalry between one Shahanur member and Hossain member of the village over establishing dominance in the area.

As a sequel to the enmity, supporters of Hossain member, equipped with sharp weapons, swooped on Biplob around 10:00pm and beat him mercilessly and fled the scene.

Locals rescued Biplob in a critical condition and took him to Sharsha Upazila Health Complex where he succumbed to his injures the same night, said Officer-in-Charge Moniruzzaman of Sharsha Police Station.

Hearing the death news, Biplob's supporters blocked Jessore-Benapole road for two hours and vandalised several houses in the area.

Biplob's father filed a murder case against 14 people yesterday, the OC added.

Man takes own life after killing wife

Illegal Irrigation Pump in Gaibandha

1 km drain troubles villagers

Sinking of a new irrigation pump at Shyampur village in Sadar upazila has created tension among the farmers and pump owners of the village.

A local influential person, without any prior permission from the authorities concerned, has set up an electrically driven irrigation pump next to Shyampur-Bhagabanpur road and dug a nearly one-kilometre-long drain for supplying irrigation water to distant boro fields, hindering movement of

vehicles and pedestrians. He has been operating the pump by taking illegal power connection from a nearby power supply pole of Power Development Board (PDB),

locals said.

Owner of the pump Ripon Akanda said he has been operating it for the last one month taking power connection as per rules, and PDB provided the power connection. But PDB denied President, also upazila parishad giving any new connection this year.

Other pump owners and local people filed complaints with PDB and Upazila Irrigation Committee.

At present, there are three rural irrigation pumps in the village, each covering 300 square-feet area. The owners, Reza Mia, Shahrul Islam and Abdur Rahman, have been operating the pumps for the last few years.

According to irrigation rules, one 5inch diameter pump can supply water for 300 to 700 square feet area and

there is no scope of setting up any more pumps in the said areas, said Reza Mia, owner of a pump in Maddha Dhanghara village.

Upazila Irrigation Committee Chairman, Rashida Begum said the committee did not approve any new irrigation pump, adding that measures will be taken against the illegal pump owner and he has been asked to stop digging the road.

No power connection is provided to any irrigation pump without approval of the Upazila Irrigation Committee, said Anwarul Islam executive engineer of PDB in Gaibandha, adding that PDB has not given connection to a new irrigation pump this year.
