Victim's wife Hosne Ara Begum, 40, received a call from a Bangladeshi migrant worker in Jeddah on September 11, 2010.

"When we received the news that my husband was injured, we were heartbroken. We had nobody to support us," Hosne Ara told this correspondent. The following day, the Bangladesh

consulate in Jeddah contacted her brother Faruk Ahmed, a schoolteacher, to inform him that Bashir had been killed. The victim's body arrived home from Jeddah 10 days later. After consulting with the

Bangladesh consulate officials, Faruk decided to lodge a case with a Saudi court against the teenager.

"We were frustrated at the slow progress of the trial, but our efforts did not go in vain," he added.

Criminal killed in gunfight with army

A criminal was killed and two minor boys were injured in a gunfight between criminals and an army patrol in Naikkhong Mukh Para in the district's Lama upazila yesterday.

The identity of the dead could not be known as of filing of this report at 2:00am today.

The injured, Mang Preng Mro, 8, and Du Nong Mro, 7, of the same area, were rushed to Lama Upazila Health Complex. Later, the two were moved to Chittagong Medical College Hospital as their condition deteriorated, said locals.

The two boys were injured by stray bullets from criminals, said an official of Inter Services Public Relation Department.

Maj Mustafizur Rahman, acting commander of Alikadom zone, said the dead, a member of Parbatya Chattagram Jana Sanghati Samiti (PCJSS), was in army uniform.

The army patrol cordoned off

Naikkhong Mukh Para area around 4:00pm on information that an armed gang was there, he told The Daily Star.

"Shortly afterwards criminals opened fire on the troops. The army men retaliated, firing shots. The two sides fired at least 50 shots during the gunfight that lasted for around 10-15 minutes," added the acting zone commander.

According to Mustafizur, the army team searched the area and recovered a bandolier from the deceased.

Rezaul Karim Shammi, assistant director of the ISPR Department, confirmed the incident. The army men opened fire after being attacked by criminals, he said.

The PCJSS, however, denied its link with any armed men.

"Certain quarters were trying to tarnish the image of Jana Sanghati Samiti by indicating those people's association with our organisation," said Sajib Chakma, assistant information secretary of PCJSS.

The headmaster sent the names of the committee members to Birganj upazila Primary Education office for approval This angered other teachers of the school and some protested this.

On Wednesday, the headmaster locked in altercation with other teachers which resulted in a scuffle triggering panic among students. "Students fled the school when the

He has shown his date of birth as 01/01/1955, but his real date of birth is 01/01/1959 according to the voter list," Binoy Kumar, commander of Shahzadpur Muktijoddha Sangsad, told The Daily Star.

Asked about the allegation, Deputy Commissioner of Sirajganj Kamrunnahar Siddika declined to comment.
