

Three die in Ctg fire incidents

Three persons died in two fire incidents in Chittagong yesterday.

In Rangunia upazila, two women of a family -- Usha Barua, 85, and Mohua Barua Shanta, 35 -- died as a gas cylinder exploded in the kitchen of a house in Betagi Barua Para yesterday noon, said OC Humayun Kabir of Rangunia Police Station.

Meanwhile, in Bakalia, a shop owner was burnt to death after a fire broke out at a shop, where kerosene and other oils were stored, on Aman Ali Road yesterday night, said fire service sources.

The deceased was Paritosh Pal, 40.

The fire broke out at the shop, situated on the ground floor of a four-storied building, around 8:45pm. Fire fighters doused the blaze around 9:25pm. Three flats on the first and second floors were also damaged.

Fire service officials are yet to find out the reason behind the fire and estimate the loss.

'MALIGNING MPS' JS adopts notice over Observer report

Cricketer Sunny denied bail again

A Dhaka court yesterday again rejected a bail petition of cricketer Arafat Sunny in a case filed under the Information and Communication Technology (ICT) Act.

Judge KM Shamsul Alam of the Cyber Tribunal passed the order after Sunny's lawyer moved the bail petition against the rejection order of the lower court.

On January 22, police arrested Sunny after Nasrin Sultana, a 23-year-old woman who claimed to be Sunny's wife, filed the case with Mohammadpur Police Station.

According to the case statement, Sunny threatened to reveal indecent photos of Nasrin on social media site Facebook. Nasrin, in the case statement, claimed to be in a relationship with Sunny for the last seven years and they got married on December 4, 2014. Sunny was remanded for a day in the case. On January 24, a Dhaka court rejected a bail petition of the cricketer and sent him to jail.

Two more cases, one for demanding Tk 20 lakh as dowry and the other for torturing Nasrin, were filed against Sunny.

In the dowry case, Sunny was summoned to appear before the court on April 5.

The marginalised people are deprived of equal rights due to the absence of an appropriate law, although the constitution has guaranteed equal rights of all citizens, it said.

The commission proposed for setting up an "anti-discrimination court" headed by a district and sessions judge in every district to deal with the case filed under the proposed law.

The court will complete the trial of a case in 60 working days after framing of charges, according to the commission.

It suggested that the court can sentence any person or representatives of an organisation up to two months' imprisonment or fine Tk 5,000 for violating its order and it can order the authorities to take departmental action against any public servant who will violate the court's directives.

The commission recommended incorporating a rule for filing an appeal by a convict with the High Court against the conviction in 60 days after the court delivers the verdict.

In another case, Prosecutor Rezia Sultana submitted a prayer requesting to show Shamsul Haque Bachchu, 70, of Trishal upazila in Mymensingh, arrested in war crimes case for committing crimes in 1971.

Shamsul, who was a Razakar in 1971, is now in Mymensingh jail. He was arrested on January 12 in connection with a murder case, said Rezia.

The tribunal asked the jail authorities to produce him before the court on April 23.

'HOLDING POSTS ILLEGALLY' Ragib Ali, son indicted

A Sylhet court yesterday framed charges against industrialist Ragib Ali and his son Abdul Hye in a case filed for holding editorial posts of a daily while being fugitive.

On September 8 last year, Gias Uddin Talukder, 50 a founding member of Chhatak Upazila Press Club, filed the case as the duo were allegedly holding the positions of editor-in-chief and editor respectively of the Sylhet Dak while they were absconding in two other cases filed over grabbing of lands of Tarapur Tea Estate in Sylhet, said sources.

The government bodies concerned "failed" to conserve the river from pollution and illegal occupation as per the law of the land, the notice mentioned.

Bela requested the authorities to make a list of organisations that were polluting and grabbing the river, and declare the Halda an ecologically critical area.

The notice also warned of taking legal action if they fail to inform Bela on the steps taken within seven days of serving the notice.
