Mayor Miru, five

A court yesterday sent to jail Shahzadpur municipality mayor Halimul Haque Miru and five other accused in the case for killing journalist Abdul Hakim Shimul, after the end of their five days' remand.

Earlier on February 13, the Court of Senior Judicial Magistrate at Shahzadpur put Miru and five others on a five-day remand in connection with a factional clash of local Awami League (AL) on February 2 that left Shimul killed.

The six accused including mayor Miru, his aide and local AL leader Nasir Uddin, Nazmul Khan, Alamgir Hossain, Arshad Ali and Zahir Sheikh were sent to jail through the Senior Judicial Magistrate's Court yesterday, said Md Rezaul Haque, officer in charge of Shahzadpur Police Station.

"During interrogation we got vital information about the incident but we don't want to disclose it for the sake of investigation," he said.

Shimul, Shahzadpur correspondent of Bangla daily Samakal, received a bullet when the mayor and his men opened fire during the February 2 clash. Shimul succumbed to his injuries the next day.

The victim's wife filed a case accusing mayor Miru, his two brothers and 15 others. The police arrested 12 people including

eight named accused in the case.

Journalist Shimul Murder Build bridge over others sent to jail Atrai river'

The people of four northern districts have been suffering a lot due to the lack of a bridge on the Atrai river in Birganj upazila in the district.

The districts are Dinajpur, Thakurgaon, Nilphamari and Panchagarh.

The villagers said boats and temporary bamboo bridges are their only means to cross the river.

"If a bridge is built on the river, people from all walks of life in the districts can travel without any hassle," said ASM Ataur Rahman, chairman of Alogjhari Union Parishad under Birganj upazila.

The incidents of boat capsize are common in the Atrai river and the situation gets worse during the rainy season, Ataur said. Farmers could take their produce to the markets, students could attend their schools on time and patients could go to hospital quickly if there was a bridge over the river, he added.

Cloth trader Jahangir Alam of Baldia village in Birganj upazila of Dinajpur, said he needs to go to Nilphamari and Thakurgaon for his wholesale shopping. "The journey is quite risky and I feel insecure at night," he said.

Rahimul Islam of Boleya Bazar said farmers cannot take their crops

to the markets on time due to the absence of a bridge.

"Haats usually start early in the morning, but we can't reach there before 11:00am due to nonavailability of boats and rickshaw vans," Rahimul said.

Ashraful Islam of Joyganj village in Birganj upazila, who got the lease of the ghat (landing place) on the Atrai river, said more than one lakh people of the four districts cross the river every month, adding that many people travel to tourist spot Nilsagar in Nilphamari as it only 17km away.

LGED Engineer in Birganj upazila Md Musa said they were conducting a survey in the area for building a bridge over the Atrai river. After completing it his office would prepare a project plan for building the bridge, he added.

Body of Bangladeshi national Konika Rani Sarkar, 43, arrived in Bangladesh through Hili immigration in Hakimpur upazila yesterday, nearly six days after being stuck in India due to address problem in her death certificate issued by Malda Medical College Hospital in West Bengal.

Around 5:30pm, his mother's body entered Bangladesh territory, said tearful Khokon Sarkar, elder son of the woman. On December 26, Konika along with her son Tokon Sarkar, 18, went to India through Hili land port for treatment purpose.

Tokon returned home alone leaving his mother at a relative's home in Balurghat of South Dinajpur as they required more money. He again entered India on February 12 through the same port.

As the condition of the woman turned critical on that night, she was admitted to Malda Medical College Hospital with local address. She died there the following day. Accordingly, the hospital authorities issued her death

certificate mentioning local address. Consequently, there was administrative problen to send her body to Bangladesh. Sanjay Basu, district magistrate of South Dinajpur, sent the body on February 15 when Tokon brought the issue into

his knowledge. Meanwhile, the boy obtained a clearance from Bangladesh Embassy in Kolkata, which allowed him to take his mother's body back home.

The body was handed over to the family in the afternoon, said OC Aftab Uddin of Hili immigration.
