**Suranjit's wife**  
**gets AL ticket**

Awami League yesterday picked Dr Joya Sengupta, wife of Suranjit Sengupta, as its candidate in the by-election to Sunamganj-2 constituency, to be held on March 30.  
The constituency fell vacant following the death of the veteran AL leader on February 5.  
The decision was taken at a meeting at Gono Bhaban with AL President and Prime Minister Sheikh Hasina in the chair.  
It also nominated Anjum Sultana Shima as a mayoral candidate for Comilla City Corporation polls and decided to back Abdul Matin Bhuiyan in the by-election to Narsingdi Zila Parishad for the chairman post.

**HC adjourns**  
**hearing on**  
**Khaleda's**  
**revision petition**

The High Court yesterday adjourned till February 26 the hearing on a revision petition filed by BNP Chairperson Khaleda Zia seeking its order on the trial court concerned to transfer the Zia Orphanage Trust corruption case against her to another court.  
The bench of Justice M Enayetur Rahim and Justice Shahidul Karim passed the adjournment order after concluding yesterday's hearing proceedings on the petition.  
Advocate AJ Mohammad Ali appeared for Khaleda Zia, while Advocate Khurshid Alam Khan was present for the Anti-Corruption Commission.  
On February 8, the BNP chief filed the petition also seeking a stay on the trial proceedings against her in the graft case filed by the ACC.  
In the petition, Khaleda said she submitted an application to the Special Judge's Court-3 of Dhaka on February 2 expressing no confidence on the judge of that court on various grounds.  
But Judge Abu Ahmed Jamadar of the Special Judge's Court-3 of Dhaka rejected the no confidence petition.  
In the revision petition, Khaleda also challenged the lower court's rejection order.

**Yaba pills seized, 6 held in Ctg**

Police seized 23,000 pieces of Yaba tablets and arrested six people in this connection conducting drives in Chittagong city since Saturday night to early yesterday.  
In Bayezid area, police seized 3,000 Yaba tablets searching a microbus and arrested Sahabuddin, Rubel of Brahmanbaria, Jashim Uddin, and Debobrata Chakraborty, of Chittagong, said police.  
Later, gleaming information from them, police arrested Arifur Rahman of Comilla with 15,000 more Yaba tablets in Boubazar area.  
Meanwhile, Enam, of Cox's Bazar was arrested in Rongipara area with 5,000 Yaba pills. A case was filed.

**FELLOW KILLED IN ROAD ACCIDENT**  
**Medical students want**  
**arrest of bus driver**

The students of Dhaka National Medical College yesterday issued another 24-hour ultimatum to the authorities concerned to arrest the bus driver whose reckless driving killed their fellow Sadia Hasan.  
The demonstrators freed Ray Saheb Bazar intersection in the old part of Dhaka around 12:40pm after police assured them of arresting the culprit soon. During the half-an-hour blockade, four roads connected in the intersection went completely standstill. To check such incidents, the students demanded that the authorities carefully check the eligibility of bus drivers, and double speed breaker be launched before the college. They demonstrators, including Md Abul Bashar, the college principal, also demanded that Johnson road be renamed as Sadia Sharani.  
Sadia, 23, a fifth-year student of the college, was killed after a bus rammed the CNG-run auto-rickshaw she and her mother were in on Saturday.

**Road crashes kill 4**

Four people were killed and 20 others injured in road accidents in three districts yesterday.  
In Dinajpur, two people were killed as a bus fell into a ditch beside Dinajpur-Bogra road after the driver lost his control over the vehicle and hit one of victims in Mohespur village under Phulbari upazila.  
The deceased were Parashuram Roy, 55, of Mohespur village and Shah Alam, 15, of Bhagabatipur village. Parashuram was a pedestrian while Alam was the helper of the bus, said police.  
Twenty people were also injured in the accident. They were admitted to Phulbari Upazila Health Complex.  
In Naogaon, a van puller was killed as a truck hit his vehicle at Mobarakpur intersection on Patnitola-Sapahar road in Patnitola upazila.  
The deceased was Aminul Islam, 33, of West Mobarakpur village.  
In Satkhira, Bulu Sardar, 30, of Kumiria village was killed as his motorcycle collided head-on with a microbus on Tala-Keshabpur road in Baburpukur area of Tala upazila.
