

## Who's to blame for public suffering?

Top transport leaders deny their role in transport strike, but workers say leaders informally backing them

With the ongoing transport strike intensifying and spreading across the country, a number of transport workers yesterday said they called the shutdown with full backing of some top leaders of their association.

The strike began on Sunday initially in 10 southern districts under Khulna division, protesting a verdict that gave life sentence to a bus driver over the deaths of filmmaker Tareque Masud, media personality Ashfaque Munier Mishuk and three others in an accident in 2011. A court in Manikganj, where the accident happened, gave the verdict on February 22. SEE PAGE 2 COL 5

#### Over 12 hurt as transport workers, cops clash in city

Agitating transport workers last night damaged about a dozen vehicles and set fire to a police box and a wrecker, prompting police to use teargas shells and charge batons to control the situation.

Four policemen and at least eight other people were injured in the ensuing clash.

Eight of the victims, including the four cops, were admitted to Dhaka Medical College Hospital shortly after midnight.

Hundreds of cars, pickups and bikes trying to enter and exit the capital got stranded on the road stretching from Aminbazar to Savar, as several hundred transport workers blocked SEE PAGE 11 COL 6

#### 5 to die for Hoshi killing

The Japanese national was killed by JMB men to tarnish Bangladesh's image, says court

A Rangpur court yesterday awarded death penalties to five JMB militants for the killing of Japanese national Kunio Hoshi in 2015.

Three masked assailants riding motorcycles shot Hoshi several times when he was heading to his farm on a rickshaw at Alutari village of Kaunia upazila in Rangpur on October 3.

The 66 year old died on the spot.

The convicts are: Rangpur region military commander of banned militant outfit

Jama'atul Mujahideen Bangladesh (JMB) Masud Rana Mamun, Ishaque Ali, Liton Mia Rafiq, Shakhawat Hossain, and Ahsanullah Ansari Biplob.

All but Ansari are in police cus-

Masud Rana and Ishaque Ali had confessed to their involvement in the murder.

Noresh Chandra Sarker, the judge of the Special Judge's Court, Rangpur, acquitted one accused.

# CHILD MARRIAGE ACT Rights bodies HC stays 2nd phase of gas price hike

Leftist parties enforce half-day hartal; BNP to stage nationwide sit-in tomorrow

The High Court yesterday stayed for six months a government decision to hike gas prices from June 1 in the second phase.

It also questioned the legality of the move to increase the prices in two phases.

The court issued a ruling asking the authorities concerned of the government to explain why the public notification issued

for raising the gas tariff from March 1 and June 1 should not be declared illegal. The chairman and the secretary of the

Bangladesh Energy Regulatory Commission were made respondents. They were asked to come up with the explanation within four weeks.
