Cooperate or I will resign

NCC mayor Ivy warns govt agencies

Narayanganj City Corporation (NCC) Mayor Selina Hayat Ivy yesterday threatened to resign from her post unless the government agencies cooperated with her in resolving various problems of the city.

The mayor came down heavily on officials of Narayanganj administration at a discussion saying that they were not cooperating with the NCC.

"I will quit if I fail to serve the people of Narayanganj city Before that I will hold a press conference, explain everything and then tender my resignation to the prime minister."

Although the administration of the city is immensely influenced by political pressure, "the DC and SP can do everything. Only their willingness [to cooperate] is necessary," Ivy said.

The mayor told this during a views exchange meeting organised by the NCC at its conference room yesterday to discuss numerous problems of the city including traffic congestion and hawker eviction, reports our Narayanganj correspondent. Officials from the district administration, police, Wasa, BRTA and Public Works department were also present at the meeting, which was chaired by the mayor.

Two prisoners in jail for 13yrs get bail STAFF CORRESPONDENT

The High Court yesterday granted bail to two prisoners who have been languishing in jail for 13 years with their cases pending before trial courts.

The HC bench of Justice Md Rezaul Haque and Justice Muhammad Khurshid Alam Sarkar passed the order after a panel lawyer of Supreme Court Legal Aid Office (SCLAO) drew court's attention on the matters last month.

Imran alias Ismail Musa, 45, is in Dhaka jail while Satyajit Paul, 42, in Chittagong jail.

Meanwhile, the same court directed a trial court concerned to complete trial proceeding of Abu Taher within four months.

QUESTION LEAK IU revokes admission of 100 freshers

The authorities of Islamic University in Kushita yesterday cancelled the admission of around 100 freshers, penalised three teachers and two employees, and expelled a student after an investigation found evidence of their involvement in a leak of the admission test questions. The syndicate suspended Nurul Islam, assistant professor

and chairman of the mathematics department, and Alauddin Alal and Saiful Islam, both class III employees. The syndicate also relieved two teachers from academic activities for two years. They are Mizanur Rahman, associate

professor of mathematics, and Altaf Hossain Rassel, assistant professor and chairman of the statistics department. Monojeet Kumar Das, a master's student of mathematics,

was expelled, while admission of around 100 newly-enrolled students of mathematics and statistics was revoked. Acting registrar SM Abdul Latif said president and general secretary of Bangladesh Chhatra League at IU Saiful Islam

and Amit Kumar informed the administration of the leak of the "F unit" admission test questions in the 2016-2017 sessions, through a written complaint.

The test was held in December last year.

A member of the probe committee said 68 question papers went missing from a lot around two days before the test, and an admission seeker paid as much as Tk 1 lakh to Tk 1.5 lakh

Interns call off strike after penalty lifted

Interns of medical college hospitals in the country yesterday called off their strike after the health minister withdrew the punitive measures against four interns of a Bogra hospital.

The strike caused immense sufferings to patients across the country over the last four

The announcement came at a meeting at Dhanmondi residence of the minister, Mohammed Nasim, yesterday.

"The interns apologised to the health minister and promised they would not repeat such incident," a health ministry official said. The minister then announced withdrawal of the punishment and the interns assured him of calling off the strike, Parikshit Chowdhury, public relations officer of the ministry, told The Daily Star.

Pro-ruling party doctors' forum Swadhinata Chikitsak Parishad (Swachip) President Dr Iqbal Arslan, Bangladesh Chhatra League (BCL) President Saifur Rahman, interns from Dhaka Medical

College, Shaheed Suhrawardy Medical College, and Sir Salimullah Medical College were present at the meeting. The ministry on March 2 suspended four

interns of Shaheed Ziaur Rahman Medical College and Hospital (SZRMCH) in Bogra for six months and transferred them to four different colleges after a probe found their role in beating the son of a patient. The interns are BCL president of SZRMCH

Al Mamun, vice president Ashiquzzaman Asif, former president Kutubuddin, and Noor Jahan Binte Islam Naz. They allegedly beat up Abdur Rouf, son

of cardiac patient Alauddin Sarkar, 65, of Sirajganj Sadar upazila, at the hospital on February 19. As the patient was feeling cold, Rouf asked

an intern to show him the switch of the fan for turning it off by addressing Noor Jahan as "sister" since he thought she was a nurse, said Bina Khanam, 30, daughter of Alauddin.

Suddenly, the intern became angry and started insulting him. Meanwhile, other interns rushed in and started beating SEE PAGE 10 COL 1

The victims -- Saddam Hossain, 32, son of Mobarak Gazi; and Hasan Sheikh, 35, son of

Ishak Ali Sheikh -- lived in Chakundia village

2 Kishoreganj War Crimes Accused Prosecution seeks death penalty

Prosecution yesterday prayed to the International Crimes Tribunal-1 for giving capital punishment to two Kishoreganj men for allegedly committing crimes during the 1971 Liberation War.

Prosecutor Tureen Afroz made the prayer after completing her closing arguments in the case against Syed Mohammad Hussain alias Hossain, younger brother of convicted war criminal Syed Hasan Ali; and Muhammad Moslem Pradhan.

Moslem is in jail and pleaded not guilty while Hussain absconding. "We are praying for their capital punishment because the offences are grievous," Tureen said.

The prosecutor placed her arguments citing the testimonies of prosecution witnesses and documentary evidence to prove all six charges brought against them. After taking brief arguments from defence counsel Abdus

Sattar Palwan, the three-member tribunal led by Justice Anwarul Haque adjourned the case proceeding until today when he will place further submission.

The charges are forcing Hindus in Dampara village of Nikli in Kishoreganj to convert to Islam; abduction, confinement and torture on four people at Nikli Bazar; killing of 26 people in Gurui; killing of 35 Hindus and torturing four others in Dampara; and abduction and murder of freedom fighter Abdul Malek of Purbogram; and the killing of freedom fighters

Khairul Jahan Bir Pratik and Md Selim Bir Pratik in Hossainpur.

Cop wearing earphones fatally run over by train
