Feni man jailed for gold smuggling
2 arrested with 2kg gold at Dhaka airport

A Chittagong court yesterday jailed a man for 12 years for smuggling gold, reports our staff correspondent in the port city.
Jamal Uddin, 35, who hails from Chhagalnaiya in Feni, is on the run, court sources said.
The court also fined him Tk 10,000 in default to suffer three more months in jail, said public prosecutor Fakhruddin Chowdhury.
Chittagong Metropolitan Sessions Judge Md Shahenur pronounced the verdict, he said.
On November 20, 2013, Jamal was arrested with 75 gold bars weighing 8.75kgs worth Tk 3.75 crore at Shah Amanat International Airport, according to the prosecution.
Later, customs official Abdullah Al Mamun filed a case accusing him with Patenga Police Station.
A charge sheet was submitted on March 7, 2014.
Meanwhile, customs officials arrested two men with 20 gold bars, weighing around two kilogrammes, at Hazrat Shahjalal International Airport in the capital early yesterday, reports our staff correspondent.
Rubel Hossain and Raman Chandra Das were carrying the gold bars, worth Tk 88 lakh, inside four charger lights, said Abdul Alim, deputy commissioner of Customs.

As the flimsy fencing was almost invisible and unrecognisable to him, he fell into it.
Visiting the spot, this correspondent found such unsafe fences around a total of three open manholes. There was a cautionary sign near only one manhole, reading, "Be careful. Manhole cover is open. Box culvert cleaning is going on... Dhaka Wasa."
In December 2014, Jihad, a three-year-old boy, died after he fell into a 600-foot deep open shaft at Bangladesh Railway Colony in Shahjahanpur.
On February 26 this year, four people, including three railway engineers, were jailed 10 years each in this connection.

and Nikhil Das, convener of Bangladesh Samajtantrik Dal in the district later placed floral wreaths at Taqi's grave.
Gano Sanghati Andolon Convener Zonayed Saki said, "The trial of Taqi murder has been stopped under the direction of government."
"If the government wishes, the trial could be held as swiftly as that of the seven-murder case," he added.
Tanwir Muhammed Taqi, 17, went missing after he had left home for Sudhijon Pathagar, a local library, around 4:00pm on March 6, 2013.
His A-level results were out the next day and he emerged as the highest scorer in the world in physics getting 297 out of 300. In chemistry, he got 294 out of 300, the highest score in the country in the subject. He was a student of ABC International School.
On the morning of March 8, his body was found floating in the Shitalakkhya river. The murder triggered a huge public outcry. People of Narayanganj formed "Santrash Nirmul Taqi Mancha", vowing to fight for justice and against criminal activities, and also to keep alive the memory of the murdered schoolboy.
Taqi's father Rafiur Rabbi filed a general dairy with Narayanganj Sadar Police Station on March 6. He filed a murder case with the same police station on March 8.
Rabbi also submitted a complaint to the Narayanganj superintendent of police on March 18 that year, accusing seven people, including Shamim Osman and his son Ayon Osman and eight to 10 unnamed others.
