Faruk died around 11:30am. The incident happened in a quarry in Utmachhara area, said Nasrin lahan Fatema, vice-chairman of the upazila.

She said the quarry is controlled by an influential local, Hashim Mia. Abul Hossain, president of Companiganj Press Club, said the

Hashim, however, could not be reached for comments despite repeated attempts.

Contacted, Abul Layes, upazila nirbahi officer, said they raided the spot after the incident. They, however, did not find anyone there. Mostafizur Rahman, assistant

director of the Department of Environment, said, "Action would be taken following investigation". Talking to this correspondent,

several locals said a group of traders has been extracting stones illegally from different quarries in the district for long, leading to accidents and subsequent deaths of workers.

"Indiscriminate stone extraction can trigger landslide any moment," Abdul Karim Kim, general secretary of Bangladesh Poribesh Andolon (Bapa), Sylhet chapter, said.

Nasrin Jahan Fatema said despite being well aware of the risks, workers dug the quarries because they need money to feed themselves and their families.

Rouf. They even forced him to do squats by holding his ears and made him seek an apology by touching their feet, she said.

They later confined him to a room until police arrived on the spot and got him out. Interns again beat him when Rouf went to the director's room to complain and said he knew Health Minister Nasim, who also comes from his

district Sirajganj, she added. The interns accused Rouf of misbehaving with a female intern. After the punishment of the interns was announced on March

2, they started a work stoppage first in SZRMCH, which later spread to other medical college hospitals across the country. There are allegations that the

interns, who were penalised, were able to mobilise support for the strike countrywide because of their involvement with BCL, a reason the health minister backtracked.

The minister had earlier told media that the interns' strike was totally irrational and that it would

not be tolerated. Meanwhile, the family of Rouf said they did not seek justice from

anyone but Allah, reports our correspondent in Bogra. His father, patient Alauddin

Sarkar, 65, died on February 21, two days after the incident.

Meanwhile, Dr Rashid-e-Mahbub, chairman of National Health Rights Movement, said the whole incident was "a power

"The main problem in the hospitals is mismanagement. The

patients, however, assume that the frontline health workers are responsible for all that. But those linked to power want to show it off, leading to confrontations," he said.

"Addressing such problems depends on improving hospital services and management," he added. Meanwhile, the interns interpreted the minister's action as

improper and a misuse of power as the patient comes from his district. Intern Kutubuddin of SZRMCH said they withdrew the strike in the

evening yesterday, but demanded security of all doctors in hospitals. The patients, however, suffered

in different medical college hospitals at divisional levels as the interns had enforced the strike until yesterday afternoon.

In Rajshahi and Bogra, the interns also formed human chains, and Bangladesh Medical Association and Swachip expressed solidarity with them in Bogra.

"Ebarer sangram amader muktir sangram, ebarer sangram swadhinatar sangram [The struggle this time is a struggle for emancipation, the struggle this time is a struggle for independence]," the great leader added. During his deliberations amid

thunderous slogans and applause, he also made a fervent appeal to people from all walks of life to prepare for armed struggle against tyranny, exploitation, subjugation and deprivation with whatever they had and turning every house into a fortress.

People were overwhelmed and imbued with the spirit of Bangabandhu's speech.

The whole nation responded spontaneously with a thunderous slogan "Bir Bangalee ostro dhoro, Bangladesh shadhin koro" [Brave Bangalees take up arms, achieve independence for Bangladesh].

The speech changed the course of the country's history, inspiring people to prepare for the Liberation War, which began after the Pakistani military on March 25 launched an attack on unarmed Bangalees and committed genocide for the next nine months.

As soon as the attack began, Bangabandhu proclaimed independence.

President Abdul Hamid and Prime Minister Sheikh Hasina gave separate messages marking the day. The president said the speech was

a fervent call for freedom.

"I recall with utmost respect the Father of the Nation," he said, adding that the immense courage, strong leadership and right directions of Bangabandhu led the nation into achieving independence.

He said the speech would be an endless source of inspiration for generations.

Sheikh Hasina termed it an unforgettable day in the thousandyear history of Bangalee nation.

Bangabandhu called for the freedom of the country and gave the nation the roadmap for achieving independence, she said, adding that Bangabandhu sensed an inevitable

She said the speech was included in the book "We Shall Fight on the Beaches: The Speeches That Inspired History" of Jacob F Field.

Sheikh Hasina urged people to take up a resolution on the day for forging greater unity once again for the development of Bangladesh and

"US citizens should avoid travel to Afghanistan, as no region in the country is immune from violence," said the US Department of State in a worldwide caution issued yesterday.

"Extremist elements are also active in India, as outlined in a recent emergency message," the message reads.

Tk 134cr illegally imported goods seized in Ctg

Huge quantity of illegally imported goods worth Tk 134 crore was found in the 12 containers seized by the customs intelligence at Chittagong Port.

The seizure includes 16,170 bottles of foreign liquor, 4,074 HD, LED and curved televisions sets, 281 photocopiers and 3.84 crore pieces of cigarettes, said a senior official of Customs Intelligence and Investigation Directorate yesterday. One Khorshed Alam using the names of

two firms -- Henan Anhui Agro LC of Khilkhet, Dhaka and Agro BD & JP of Abdullahpur, Keraniganj -- imported the consignments exported by Jam Raj Industries, China.

The directorate suspects not only the importer, many persons were behind the smuggling and has already started investigation to identify them.

Sources in Chittagong Customs House said the clearing and forwarding agent Rabeya & Sons had completed the value assessment of the first consignment as soon as the vessel reached the outer anchorage on February 27.

Sensing surveillance and enquiry by the

customs intelligence, the importer tried to send the cargo back to Singapore from where the vessel came, said Director General Moinul Khan.

The exporter has meanwhile sent a request letter to the commissioner of Chittagong Customs House saying the

cargoes were mistakenly sent to Bangladesh. Chittagong Customs Commissioner AFM

Abdullah said they had rejected the appeal. After the rejection both the importer and proprietor Jalal Uddin of the C&F firm went

into hiding. The commissioner yesterday said he had already ordered to cancel the licence of the C&F firm and its entire staff.

DG Moinul said they had initiated an investigation into previous records of import

by the same importer and the C&F agent. He blamed the respective bank where the

letter of credits (L/Cs) were opened with an importing firm having no office or factory. Mehedi Hasan, a senior official of the

bank's Nayapaltan branch, said Agro BD & JP opened the account with them in 2015. Bank officials visited the address and found a tin-shed structure before opening the account, he claimed.

The findings said, "Average age at first marriage for men was 24 years and for women it was 16 years."

About the right age for girls to be married, 25 percent female respondents said girls should be married after the age of 20, while only four percent of the male respondents opined so, it mentioned.

"Overall, only 50 percent of the respondents thought that girls should have the right to choose when to marry." The majority of the respondents (66

percent female and 42 percent male) had education up to primary level. Nearly half the respondents mentioned

that the husbands have right to force his

wife to have sex even if she did not consent, the survey claimed. "When asked what a woman could do if she was facing marital rape, 92 percent of the male respondents stated that a woman

could do nothing," it said. The survey found that male respondents, irrespective of their level of education, strongly believed that it was common in their community for a husband to physically assault his wife such as slapping or beating if she went out without telling him, used family planning or questioned him

about spending money. When asked about household decision-making, at least 59 percent females stated that their husband made the decisions about household expenditure and children's education, while 61 percent male said they made these decisions

themselves. While all the male respondents stated that they were involved in economic activities, only 40 percent of the female respondent said they were, it said.

Moreover, when respondents were asked if women should be allowed to work to earn a living, nearly all the respondents said they should. But only 69 percent believed that women should have the right to spend their income.

Speaking at the programme, Canadian High Commissioner in Bangladesh, Benoît-Pierre Laramée said they had observed that there were concerns in the Child Marriage Restraint Act-2017 which had been passed in parliament.

There must be monitoring of the implementation of the law, he added.

Law and Justice Division Secretary Abu

Saleh Sheikh Mohammad Zahirul Haque said there was no scope for enjoying exceptions in the new law and that only court would decide the "exceptional" cases of marrying off girls below 18 years of age.

He asked all to report if there is any child marriage and that they would take stern actions against the offenders.

Oxfam Bangladesh Country Director Snehal V Soneji moderated the programme. Chief Executive Officer and Chief Editor of Ekushey Television Monjurul Ahsan Bulbul and Project Director of the Multi-Sectoral Programme on Violence Against Women Abul Hossain, among others, also spoke.

Rayhan, Sirajul and Jasim are fugitives. Asked about the delay in submitting the charge sheet, Shaikh Nazmul Alam, deputy commissioner of the DB, told The Daily Star it took time as customs filed the case more than a year after the incident, and since there is a foreign accused, information about him needed to be verified.
